Farmers Will Not Enter Political Field.

The United Farmers have decided not to enter politics this year. The intimation seems to be, however, that they may do so in the future. It is probable that just now they can do more by using their influence in other ways than in securing a minority in the legislature.

The farmers doubtless deserve a great deal of consideration, especially in a country where the farms have to be hewn out of a forest. At the same time being a farmer does not mean that everyone will vote for him. There is a farmer premier in the province just now and he has made good. Alto there is a farmer minister of agriculture. Some more farmers in the liouse would be all right.

Apotheosis of The Farmer.

Today the farmer is being more or less deified. He is set up on a pinnacle and all bow down and worship him. In Ontario everyone voted for the farmer candidates in some constituencies. People like something to worship. Some years ago it was labor that was deified by the politicians. While very few labor candidates were elected, the political managers made out their programs especially to catch the labor vote. They were the ones that were set up on a pinnacle and everything political was made subservient to them. Now it has been discovered that laboring made to register Edward H. Mortimer, of and 29. men are just common clay like the rest of you. They have the same interests, are made of very much the same kind of flesh and blood only better kept and purified by sweating. It is no use truckling to labor, for the interests of the workers are the interests of all, except possibly a few idle parasites that may easily be dispensed with.

It is also noticeable today that political tricksters are easily found out. They do not make the appeal that they once did. With an educated working community the political sower is spreading his seed on bare ground.

Board of Commerce

And Price Regulation.

Judge Robson has resigned from the Board of Commerce because he does not believe in regulating prices. He seems to think that if some prices are to be regulated, others should be treated the same. He says that regulating profits lessens proauction and tends to drive people to selling luxuries when they should be selling necessaries.

To some extent it is the correct attitude that Judge Robson takes. As a matter of fact this whole matter of price regulation to the above-mentioned lands, in the name has been a farce. There was really no regulation, or so little of it that it was not noticeable. What we need now is production and nobody will produce unless there is profit in so doing.

Should Labor Have Paid Leaders.

The question whether a man who is not working at his trade should represent labor on her councils, opens up a big question. It is the one whether labor is wise in employing paid representatives who make their living by organizing and urging proposed action on my part. on the workers. The organizers have to earn their money and it is by keeping affairs in a ferment that they are able to do so.

On the other hand the workers claim that they have not time to attend to their own organization and they are feady to jump at the chance of getting a clever, glib tongued man to help them out. The whole question is a big one and difficult to solve.
