A. M. Sinclair, timekeeper, at Anyox, recently underwent an operation in the Vancouver General Hospital. Mr. Sinclair was formerly on the Dolly Varden Railway at Alice Arm.

O. H. Nelson has been appointed to represent the local Brotherhood of Railway Workers at a convention to be held in Edmonton on June 5. The brotherhood comprises the clerks and checkers.

The city council was informed by the Provincial Government at last night's meeting that the government has no more money available for soldiers' housing so the request by the city for a further \$25,000 could not be granted.

The finance committee in its report to the council last night regarding the request for a grant of \$300 towards getting in the Greenview Indian Band for Dominion Day recommended that no action be taken and the council endorsed the stand.

Three raffles held over from two weeks ago in aid of the Ladies Auxiliary of the Prince Rupert General Hospital took place yesterday. The kiewpie doll was won by Thyra Akerberg; tin of desiccated egg, Mrs. Moore; miniature electric range, Jean Bloomfield.

At the meeting of the Trades and Labor Council last night arrangements were made for the formation of a Metal Trades Council to handle the affairs of metal workers in local shops. Delegates for the installation of the new council are now being selected.

Plans for the Morse Creek bridge were reported to be going ahead steadily in the city engineer's office by the mayor at last night's council meeting. During the past few days, however, there has been a slight delay as the staff has been busy in connection with the new school.

At the regular meeting of the Ladies' Auxiliary of the General Hospital held yesterday afternoon the accounts in connection with the hospital vaudeville entertainment were passed and it was found that the entertainment would net the auxiliary very nearly \$400. This was considered very satisfactory.

In the current B. C. Gazette is registered the incorporation of the Ingenica Gold Co., in the extra-provincial class with a capital of \$270,000. The head office for B. C. is in Vancouver and for Alberta, Edmonton. The Ingenica Mines are located near Hazelton and were much talked of in the boom days of 1910 and later.

S. D. Macdonald and B. F. Self, for the football and baseball clubs, have been successful in getting a grant of \$100 from the city council towards the erection of a dressing room at the Aeropolis grounds. It is estimated that the cost of an adequate room will be in the neighborhood of \$300, the athletic clubs having to bear the remainder of the cost.

Mr. and Mrs. F. F. Schellenberg are expecting to leave today for Victoria on the steamer Princess Mary. They will holiday for a few weeks in the B. C. capital and then go to southern Oregon. Miss Beaman is going with them. Many friends will regret the departure of Mr. and Mrs. Schellenberg but they are somewhat consoled by the fact that they expect to return here some day.
