RUSSIAN ARMY AND NAVY HELP THE REVOLUTION

London, March 17.—Telegraphing from Petrograd, Reuter's correspondent says Kronstadt, the fortress and seaport at the head of the Gulf of Finland, twenty miles west of Petrograd, has joined the revolutionary government. Two deputies, Pepetauff and Taskifin, on instructions from the Duma, committee, proceeded to Kronstadt, where the troops placed themselves at the disposal of the Duma. M. Pepetauff was appointed commandant of Kronstadt, which is Russia's great naval station.

Petrograd, March 17.—The garrison at Kharkov has formally joined the revolution, and is supporting the provisional government. Strikes in sympathy with the movement have been called in factories and on the street car lines.

Kharkov is the capital of the province of the same name. It is 480 miles south of Moscow, and has a population of 200,000.

London, March 17.—A despatch to Reuter's Telegram Company, says the British and French Ambassadors established official business relations with the Executive Committee of the Duma. The despatch adds that the Grand Duke Cyril informed the Duma that he would place at its disposal the marines under his orders, and afterwards visited M. Rodzianko in the Duma and told him he was entirely at Rodzianko's orders. The correspondent says that the people of Moscow adhered to the revolutionary movement without bloodshed.
