EMPIRE'S GREATNESS

What is an empire's measure of greatness? Father Bernard Vaughan set himself to answer this question in London recently at His Majesty's Theatre, and the reply he gave was a simple one—it is the measure of the character of its people.

In developing his thesis Father Vaughan used all those powers of humor, pathos and eloquence which always bring him in close touch with his audience. There was, to begin with, the story about a reverent father who was addressing a Sunday afternoon audience in a New York theatre, when the audience began to slip away one at a time. At last a young exquisite walked deliberately down to the door, and this was more than the speaker could stand. "Young man, come right back," he said. Whereupon a mother's voice was heard, "Excuse my Reginald; he walks in his sleep."

An empire's greatness, Father Vaughan went on, was not to be measured by its acreage, its numbers or its wealth; nor upon its organization. Do not let us be over-organized; there had been a tendency in the past to follow slavishly the organization of our enemy. Nor did greatness consist of world dominion. Once that was made a fetish, we would have to cultivate a blend of frightfulness and "kultur," which was a degradation to man.

Our Empire's greatness was not to be measured by things that went by and perished. It was to be measured by the character of its people. Nothing mattered but character, which we could build up out of the raw materials knocking about our homes and our daily lives. Its chief ingredients were heredity, environment, education, faith.

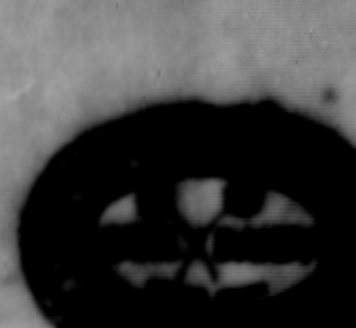
