**DRYDOCKS**

Recently the information came to hand that the Hon. Robert Rogers, Minister of Public Works in the Dominion House, had taken up the question of building Admiralty drydocks at Esquimalt, as well as at Halifax. The matter has apparently been taken up by him with Sir Edward Carson, the First Lord of the Admiralty, and with Mr. Bonar Law, the Chancellor of the Exchequer.

"Canada," Mr. Rogers is reported to have said, "is entitled to this consideration, not only owing to the part she has played in the present war, but because of the effort of the Dominion Government to encourage shipbuilding in Canada."

The principle of having admiralty drydocks built in Canada is all right, but the application of that principle at Esquimalt would be all wrong. A comparison of Esquimalt and Prince Rupert and the suitability of each place for the location of an Admiralty station shows everything to be in favor of this northern city.

To begin with, as harbors, Prince Rupert is possessed of a harbor affording secure anchorage to the largest vessels now afloat, or everyone likely to be launched, over its whole length of fourteen miles. The whole Grand fleet could be accommodated easily. Comparatively Esquimalt is a small place. Besides this, Prince Rupert's harbor is completely landlocked, with splendid facilities for defence. This cannot be said about Esquimalt.

Then take the question of supplies for the fleet. Esquimalt is situated on an island. All material stores and supplies of every kind coming from the East would require to be handled and transhipped at Vancouver, which is costly, while at Prince Rupert, being the terminus of a transcontinental railroad, these goods would be run right into the Admiralty yard, and would only require to be handled once instead of twice.

Then again, there is the geographical positions of the two ports to be considered. Prince Rupert is a day and a half's steaming nearer the Orient

than Esquimalt, which is one natural advantage, which would commend itself to the strategic naval mind.

Lord Dundonald, who at one time was military adviser in the Dominion, several years ago made a report regarding Prince Rupert's harbor as a naval base, and he could find no other place on this coast which offered as many advantages for this purpose. He, too, was an expert in naval matters, while the expertness of the Hon. "Bob" lies in another direction altogether.

In fact, the harbor of Prince Rupert bears a great resemblance to that at the latest naval base at Rosyth on the Firth of Forth in its physical features, with the advantages all in favor of Prince Rupert. Such considerations as these of course, could hardly be expected to be taken into account by the present Government of the Dominion in their recommendations to the British Admiralty, judging by the manner in which the present Prince Rupert facilities have been ignored. It is up to the people of Prince Rupert to see that if, and when the establishment of a naval base is considered upon the Pacific coast, that it comes to the place which is most suitable for it. That place is Prince Rupert.

**NOTES AND COMMENTS**

The elevators of another part of Canada are said to be "bursting with wheat." The great combines must be waiting for the lifting of the duty on grain seeking entrance to the United States. When that is accomplished, we suppose Canadian wheat will "lose its identity," become merged with the inferior grades produced across the line, and the price of flour will take another bound skyward. There appears to be no hope for the unfortunate consumer short of the day when peace shall be proclaimed.

Mr. Bowser has been telling his constituents in Vancouver that the session of the Legislature is proving a source of great joy to him. Well, there is no accounting for dispositions. A mere ordinary man in the position of the leader of the Opposition, with the revelations in connection with the P. G. E. inquiry confronting him,
