TO PROVIDE WORK FOR RETURNED SOLDIERS

Ottawa, May 7.—The following memorandum was issued by Sir Edward Kemp, minister of militia.
"There is apparently some misunderstanding as to the responsibility of the Dominion and the provinces to provide for returned soldiers. This confusion has particularly arisen in regard to provision for employment of returned soldiers."

"On October 18, 1916, a conference was held at Ottawa between the federal authorities, military hospitals' commission and the governments of the provinces on the initiation of Sir Robert Borden. This conference decided to divide and define the work of caring for the returned soldiers in order that there would be co-operation so as to prevent overlapping."

Official Memorandum.
"This conference particularly assigned to the provinces the work of providing employment for soldiers. The official memorandum issued at the time and agreed to by all present stated:

"Each of the provinces of Canada working through its central committee should assume the responsibility of endeavoring to find employment for discharged soldiers, who upon their return to Canada are physically and otherwise fit to assume such employment. All expenditures necessary on undertaking the duty should be borne by the province."
"The Dominion government, on the other hand, assumed the responsibility of caring for and providing for soldiers incapacitated for employment or who require special training or treatment before undertaking employment. This division of the work has been followed since this conference. The provinces have formed committees to undertake the work of re-employment, while the Dominion has provided for all invalided and disabled soldiers, and the vocational training of returned men."

How to go about it

BUY eggs for hatching or day-old chicks; borrow or buy a brooder; hen or an artificial brooder. A slatted pecking-box will house the hen and chicks. Feed the chicks bread crumbs soaked in milk and squeezed dry. Feed five times a day, alternating with prepared chick feed, only as much as they will eat up clean. Remember that a hungry chick is a healthy chick.

CAUTION: Chicks must not be fed until at least 48 hours old, and then only sparingly.

If you can, start now with eggs or chicks; if not, arrange at once with the local poultry association for pullets in the fall.
