## IMPORTANCE OF FOOD SUPPLY IS REALISED

That this convention urges upon the Government of Canada the prompt appointment of a National Food Controller, whose duties shall be among others as follows:

"To fix and control food and fuel prices where desirable.

"To encourage and protect the producer by guaranteeing minimum prices for food products.

"To prescribe regulations governing the production and distribution of those commodities, and if necessary to requisition the producing factories, mines or other establishments.

"To compel holders of necessities to release them in amounts ensuring equitable distribution.

"To require railroads to give preference to the movement of necessities.

"To forbid the export of any food stuffs from Canada except upon license for each exportation, such license to be granted only in case the said foodstuffs are not needed by the Government itself or for its allies.

"To impose limitations or prohibition upon the use of grain and other food stuffs in the manufacture of alcoholic beverages."

The above resolutions with its seven clauses was moved at the great War Convention held at Montreal on May 2nd, by Lindley Crease, K. C., of Victoria, seconded by Nichol Thompson, K. C., of Vancouver, and passed unanimously. In support of its terms in general, Mr. Crease pointed out to the assembly that it was intended more as a precautionary rather than an alarmist measure.

While he did not contemplate a serious shortage of food in the Dominion, he declared that every possible provision should be made in view of any emergency the future held. He dwelt on the several kinds of fuel which were necessary for the feeding of the great army at the front and the great army at home. The sooner a precautionary measure could be introduced the easier the task would be, he said.

It was only by a process of sacrifice and unselfishness that the country could hope to put forth her greatest effort as a telling factor in the problem with which the Empire was faced. To bring the Allies to submission by food shortage was the German plan, and one upon which they had pinned their faith, doomed to disappointment as it was. For that reason the utmost vigilance on the part of this Dominion in the conservation of her food supply was required.

Not only was conservation vital but the process of distribution was equally so, in Mr. Crease's opinion.

## WATER NOTICE

**USE AND STORAGE**
