She departs from jail at the end of that time vowing vengeance upon the judge who sent her there. How she works out her plan, and at the last moment the bitter truths of vengeful conduct is borne upon her and her better nature conquers. The play is a fine one all through. There is also to be shown a gazette and a comedy.

**CRIMINAL ASSIZE  
COURT SITS TODAY**

This morning at eleven o'clock the Criminal Assize Court sat to hear the cases which were upon the calendar. The grand jury was in attendance and the foreman, Mr. H. B. Rochester, intimated that it was their intention to visit the hospital, the schools and the police station, and would later make their report in writing if the court so desired.

The first case to be heard was that of John May, an Indian, accused of assaulting a police officer and with resisting arrest. Mr. L. W. Patmore defended, and the accused pleaded guilty. From the evidence it was shown that in the course of arrest upon the charge of drunkenness, the accused had resisted, while on the reservation. He had elected for a jury trial and had been in jail since August 28.

For the prosecution, it was contended that this was a dangerous character, and severe punishment should be inflicted, the more so, as he had a penknife in his hand. Mr. Patmore said that had it been any other Indian, this charge would never have been laid, but it was brought simply because he was Johnny May. The court will pronounce sentence at the close of the Assizes.

**Seditious Language.**

The next case was that of Eric Bruce, of Massett, Q. C. L., who was accused of uttering seditious language. Mr. Fleishman, of Vancouver, appeared for the defence. Accused pleaded not guilty. The first witness was Mrs. R. O. Davis, of Massett, who testified that when she was working in the hotel at Massett, the accused said in her hearing that he disliked the British and was in favor of Germany winning the war. Crowned heads should be beheaded and that he would get even with the English if they made him sign up. He knew the names of the Lords in England and would like to see them shot.

Mr. Harrison, of Massett, also gave evidence to the same effect.

The jury was sworn in for this case, which consisted of Messrs. Geo. Woodland, foreman; L. M. Fuller, J. C. Knight, H. Berryman, F. W. Chandler, H. Hampton, Wilfrid Kelly, R. Boyd Young, R. E. Benson, J. G. Moody, J. E. Dyer, and H. E. Lipsett.
