### LETTER TO THE EDITOR

Prince Rupert, Dec. 18, 1917.  
Dear Sir:—I wish you to allow me space in your valuable paper. I have been accused so much lately of not being a British subject I will here state to my position. I was born in Rothesay, Scotland, in 1862. I took out my citizen papers in Portland, Ore., in 1882. I served in the United States navy from 1887 till 1890. I was, as all true Scotchmen that takes out papers, a loyal American. To show you I had a good position in Shanghai, China, and came direct to Galveston, Texas, to join up when war was declared against Spain. I might here state I was appointed one of the first master-at-arms in the United States transport service, being master-at-arms on the U. S. S. Dixie, Buford, Kilpatrick, Mead, and Thomas, during the war. I might here state I left New York in 1899, chief master-at-arms on the largest transport, Logan, out of the United States for Manila. I resigned in San Francisco to go up to the Arctic under Lieut. Jarvis. I came to B. C. the same year and adopted Canada in 1901 as a Canadian citizen. I have always been a loyal Canadian on the coast. I here might state I have assisted in rigging up every wireless pole for the Dominion Government in B. C. I have only been out of Canada once, to Mexico, since 1904. It hurt me to be called an alien and challenged everywhere for being an American and not as a Canadian citizen.
