WASHINGTON SCEPTICAL OF GERMANY'S GOOD FAITH

Washington, Dec. 29.—The conditions surrounding Count Czernin's proposals for a basis of peace cause officials here to feel some apprehension for their sincerity. There is a great disposition to feel that the German delegates are simply trying to protract the negotiations as long as possible without any expectations of a peace agreement, with the double purpose of leading the German people to believe that their government really is desirous of making peace and of gaining time for the further strengthening of the German lines in the West.

One condition regarded as impossible, for the present at least, is that the adherence of all belligerents must be secured to the peace the Germans are trying to make with Russia before it can be effected. This is accompanied by a demand for the return of German colonies now in the hands of Russia's Allies.

It can be stated authoritatively that the position of the United States Government has not changed in any respect with regard to its determination to enter into no agreement with a government which does not represent the free will of the governed people. This would dispose of any hope the Germans might have that the Russians could induce America to subscribe to the peace treaty which they are now trying to arrange. As for the German colonies, the American Government has never recorded itself on the subject and Lloyd George recently declared that it was a subject for the peace conference.

APRIL 6TH, 1917.

A medal to commemorate the entrance of the United States into the war and its European allies for the preservation of democracy has been issued by the American Numismatic Society.

It was designed by Eli Harvey, the sculptor, and depicts the white headed eagle of North America, perched on a crag, with wings outstretched and head thrown back, in the attitude of readiness for instant attack upon its foe. The only inscription is the date, "April 6, 1917"—the day that President Wilson proclaimed the existence of a state of war.

The issue is limited to one million copies, 50 in silver and the others in bronze. All have been subscribed for, and it was stipulated that only one medal could be taken by each member.

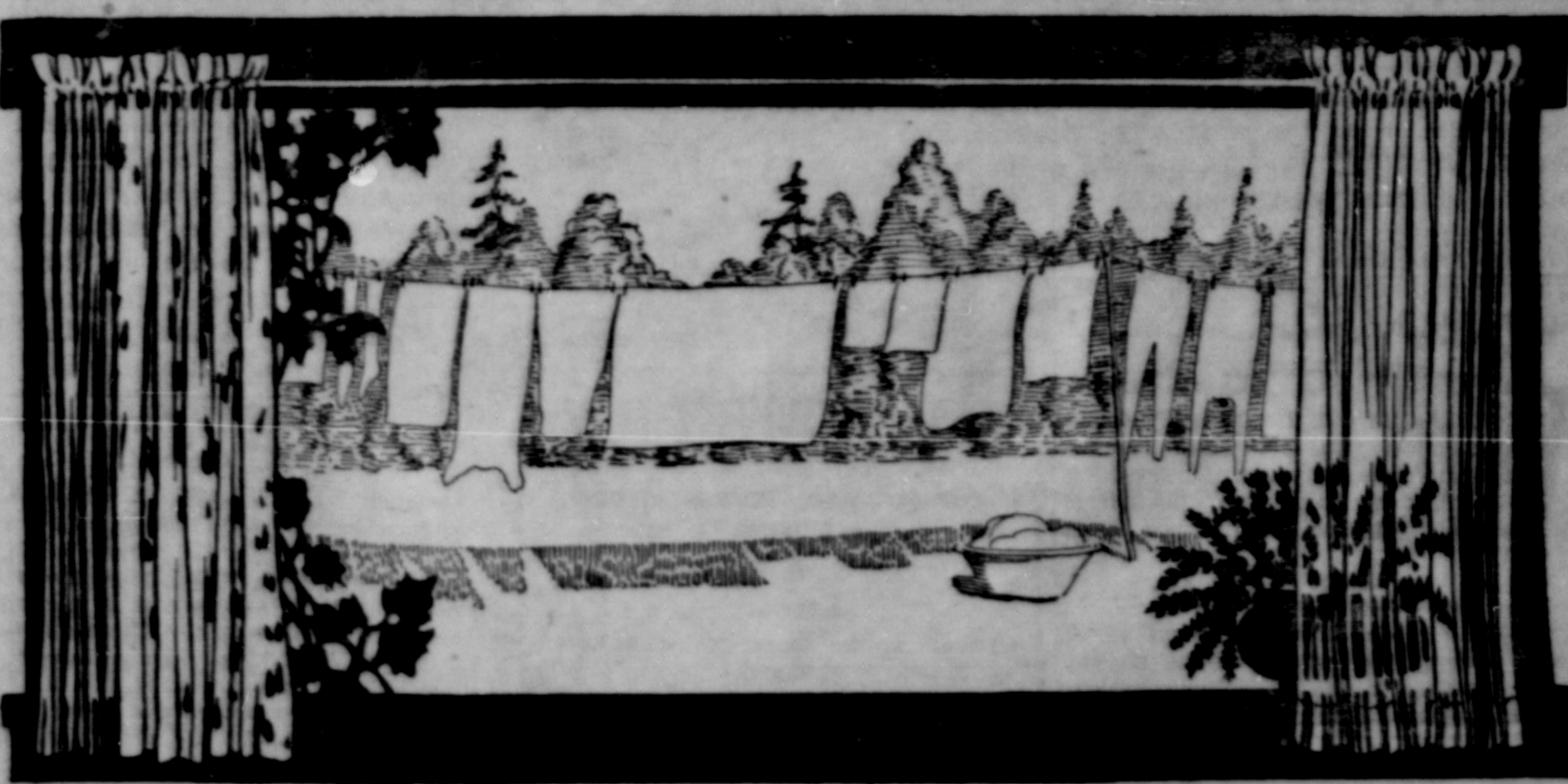
