COAL SHORTAGE KEEPS KIDDIES IN BED

Brantford, Feb. 2.—Returned soldiers, who to the number of thirty are engaged in making a search of local homes to prevent further hoarding of coal, and thereby to allow the limited supply to meet all cases of actual need, report some harrowing stories to the civic fuel office. In one house five children were found wrapped in blankets to keep warm with not a particle of fuel in the home, although the mother had gone three times to the civic office to get a coal order. In another four children were kept in bed all day to keep warm. Many cases of hoarding have been reported, the favorite trick being to cover up the coal with ashes or wood. One woman used potatoes to hide her pile, but she had not enough tubers and the coal showed through when the veteran made the inspection. With a check on all deliveries and on all coal on hand, the city officials expect that all needs will be met.

A LABOR POLITICAL PARTY TO BE FORMED IN B. C.

Vancouver, Feb. 4.—The decision to organize a labor political party and hold a conference immediately after the close of the present session, was reached at session of the B. C. Federation of Labor convention here after a long discussion.

The approval of the formation of a political party was not unanimous, though heavily in favor of the movement. A round dozen delegates did not vote, ten Socialists and Social Democrats voted against it, and eighty-four delegates were for it.

A proposition to enlarge the circulation of the official organ, The Federationist, by imposing an additional tax of seven cents on all affiliated members was unanimously carried, the convention being convinced of the need of an official publication, and that the present paper was doing good work.

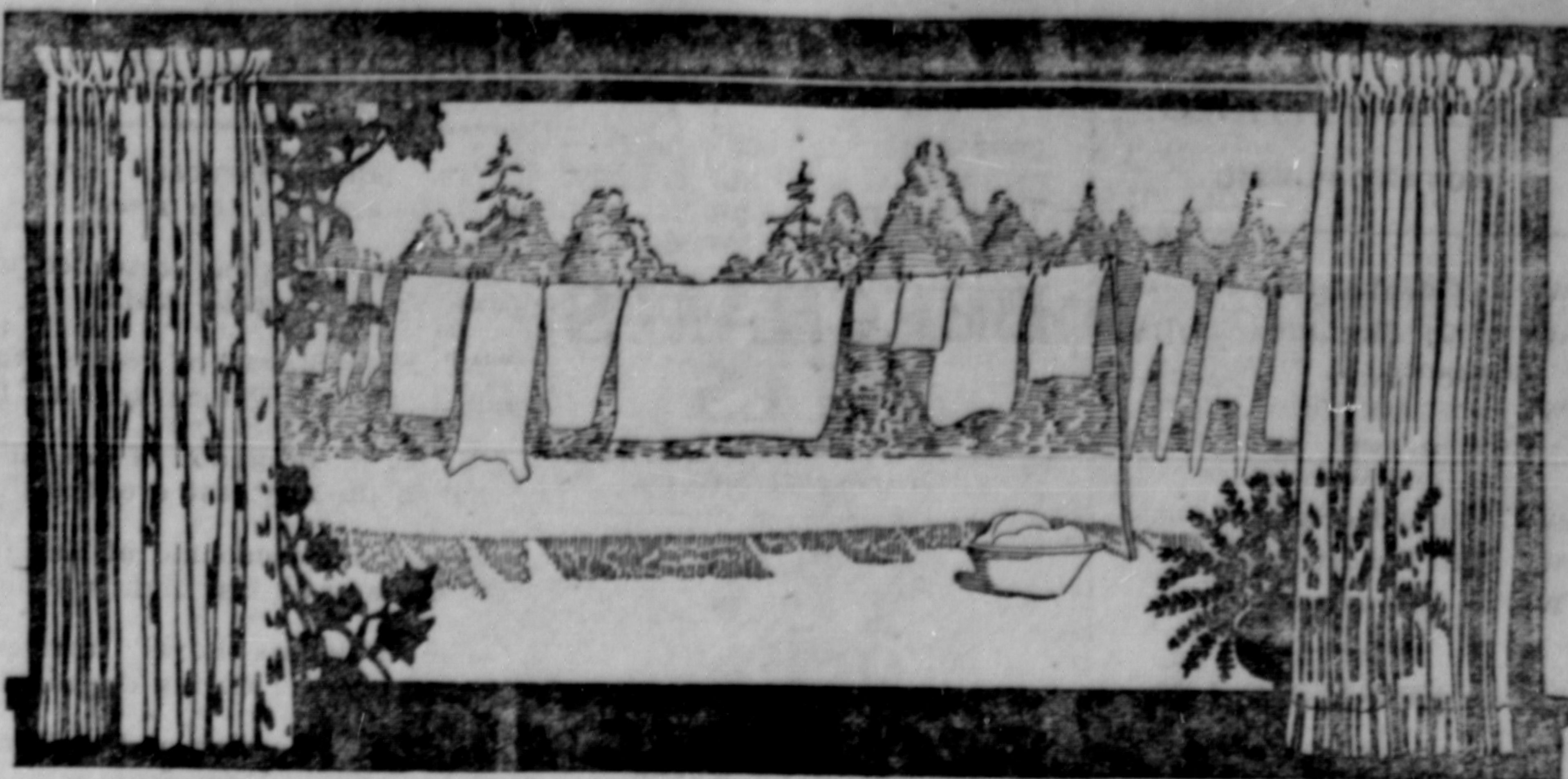
