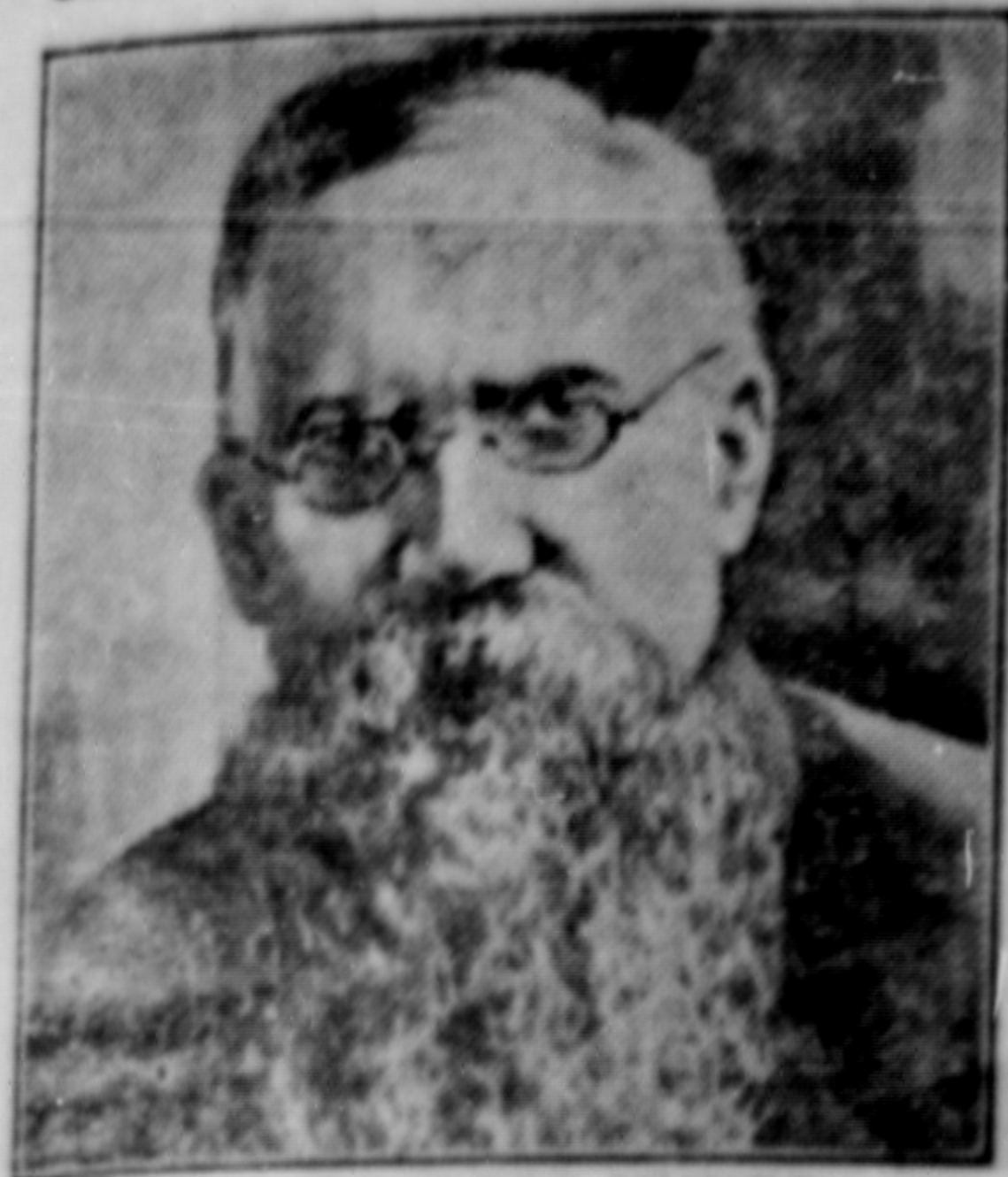

## MR. AND MRS. J. W. COLLIER CELEBRATE SILVER WEDDING

On Wednesday evening, Mr. and Mrs. John William Collier celebrated the twenty-fifth anniversary of their wedding day. A large party gathered at their home on the waterfront here in honor of the occasion, which was suitably observed. Twenty-five years ago, John William Collier married Miss Mary Ellen Buckingham at St. Peter's Church, Hindley, England. Of their family, which numbered five, four still survive and are here in Prince Rupert. The fifth, James Arthur Collier, gave his life for his King and country on November 7th, 1916, in France. Mrs. George Arter, Miss Pearl and Miss Olive, and Mr. John William Collier comprise the remaining members of the family, and are all well known in town. Mr. and Mrs. Collier were presented with many beautiful pieces of silverware from the guests to mark the occasion, and one and all spent a most enjoyable time. After supper, dancing began, and was kept up until the early hours, and everyone present voted the proceedings to have been among the best and most enjoyable.

## FLAVELLE TOO STRONG EVEN FOR LLOYD GEORGE

Toronto, May 22.—"Three times I cabled Lloyd George asking him to give instructions to Sir Joseph Flavelle, the devoted head of the Imperial Munitions Board, to co-operate with the Dominion Trades Congress in the interest of the Canadian workers. We were turned down and then upon my advice and request Premier Borden cabled twice. Again he was turned down, I have said that Lloyd George is the trickiest politician who ever masqueraded as a statesman, and I repeat it," declared J. C. Watters, president of the Dominion Trades Congress to a convention of labor men who met on Saturday to devise and draw up a constitution for a Toronto Labor party.

He made this attack upon Premier Lloyd George to explain to the convention that Canada received its instructions from Downing Street. Mr. Watters also attacked Mackenzie and Mann, Sir Joseph Flavelle and Sir Clifford Sifton.

He expressed the opinion that if the German workers had been as strongly organized industrially as politically this war would never have occurred.

## LAND REGISTRY ACT (Sections 36 and 134.)

"and in default of a caveat or certificate of his pendency being filed before the registration as owner of the person entitled under such tax sale, all persons so served with notice, . . . and those claiming through or under them, and all persons claiming any interest in the land by virtue of any unregistered instrument . . . and all persons claiming any interest in the land by descent whose title is not registered under the provisions of this Act, shall be forever estopped and debarred from setting up any claim to or in respect of the land so sold for taxes, and the Registrar shall register the person entitled under such tax sale as owner of the land so sold for taxes."

AND WHEREAS application has been made for a Certificate of Indefeasible Title to the above-mentioned lands, in the name of Frank W. Hart,

AND WHEREAS on investigating the title it appears that prior to the 12th day of October, 1916 (the date on which the said lands were sold for overdue taxes), you were the registered and assessed owners as stated below:

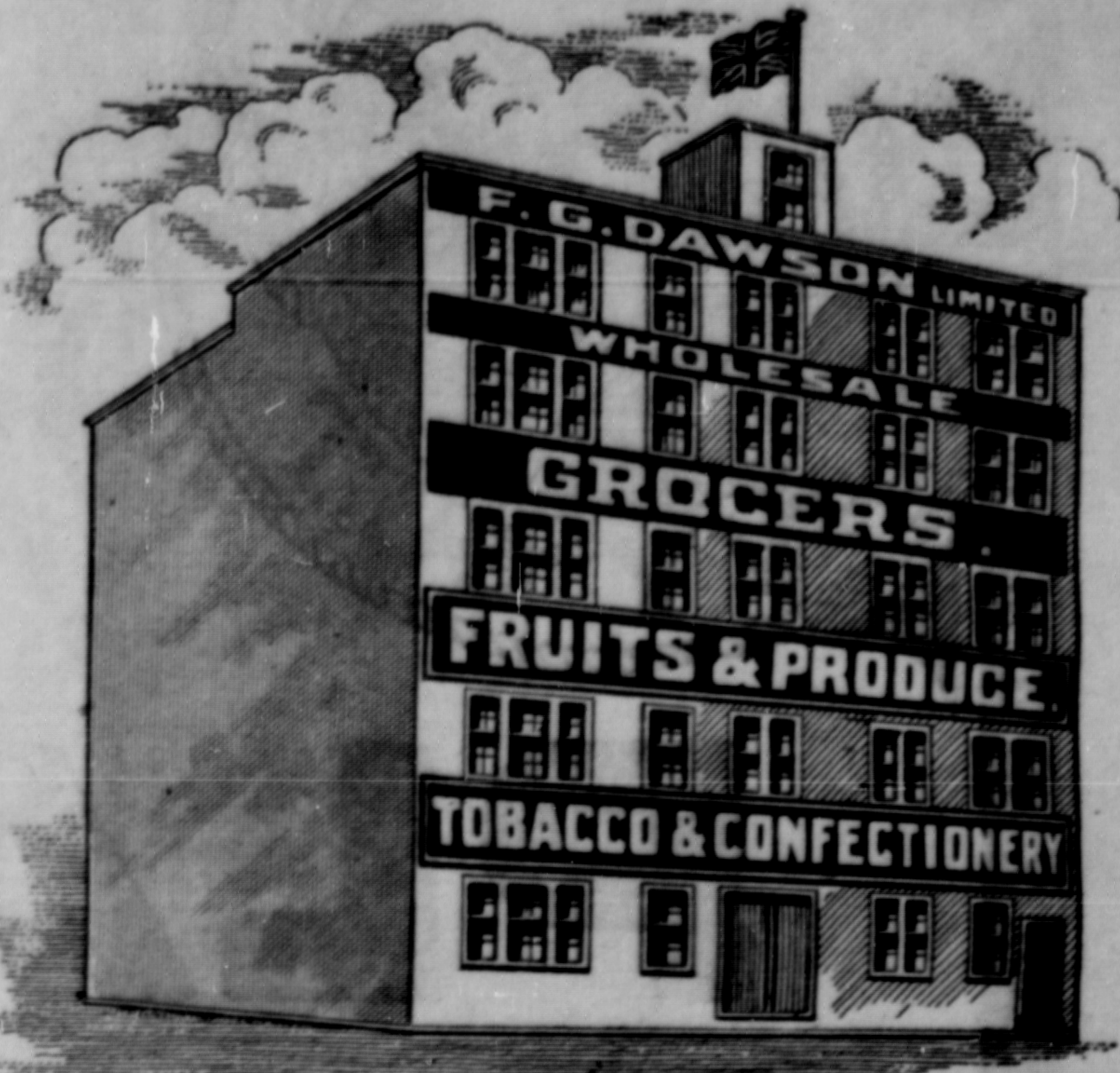
