S. Naval Man Ordered Back to Duty But Trip to Vancouver May Be Arranged.

A match is being quietly worked up between Meehan and Sergeant Tommy Burns, ex-champion of the world, of Prince Rupert, and physical instructor at Hastings Park, Wires have bene passing back and forth, and Meehan has agreed to come to Vancouver to box Burns for regimental funds. Burns has also agreed, subject to the approval of his commanding officer, to go to Frisco for a return match on the same terms that Meehan comes to B. C.

It is more than probable that the naval authorities of the United States figure that Willie has been running a little bit high-wideand-handsome, what with his match with Dempsey, his vaudeville tour with Kid McCoy, and now his proposed fight with K.O. Kruvosky, and it may be-it just may be-that the authorities are wondering what percentage of Willie's earnings are going for patriotic purposes, while he is a member of Uncle Sam's naval contingent, so they have ordered him back to duty.

And when his commanding officer is acquainted with the terms and reasons for Willie coming to Vancouver and boxing Tommy Burns, it is very likely that the trip will be quickly arranged.

Jess Willard is said to have picked Meehan as his opponent for a patriotic match in Texas, but this is believed to be another of the big fellow's attempts to dodge Dempsey or Fulton. It is pretty much a cinch, however, that should Willie get into the ring with Willard for four, rounds he would make a monkey out of the champion. His style of boxing is to jump in from the gong and keep things moving, while the mature fighter will take a round! or two to try his man out, and in a short round bout such a man as Meehan would have all the best

Anyway, such a match would be on a par with Ajax defying the lightning, and the sympathy of the crowd would be with the pigmy from the start. With Meehan and Burns in the ring a real scrap would be seen, since they are about of a height, and Willie's tactics of getting under the big fellows' guards and hammering their ribs wouldn't work out very




