#### Strike May Come At Any Time.

The union men of the city, numbering 450 persons, mostly men, have given authority to the Trades and Labor Council to call a strike at any time if they think it necessary. That it will be thought necessary sooner or later, if the strike continues in other cities, goes without saying. Frince Rupert people, in face of Saturday's vote should prepare for a strike, for it is very likely to come. It has been precipitated earlier than most of the labor leaders wished, for the One Big Union which was to have been the great weapon of offense, has not yet been organized. Similar methods are being adopted now, however, to those which would be under the Big Union.

In other cities strong citizens' committees are being formed for the purpose of maintaining law and order. In Winnipeg there is a committee of one thousand and in Vancouver and Victoria similar committees are being formed.

The necessity of the formation of such committees is found in the seditious utterances of some of the strikers and labor leaders. In some cases the men are being incited to lawlessness Re by suggestion and even in this town around the places where men congregate, threats are openly expressed and suggestions of taking things by violence are muttered. In the face of such condition a complete organization of the lababiding section of the community is necessary.

In Winnipeg there has been good order, but even there the bulletin issued by the strikers has suggested that if the men are Nineteen (19), Block Forty-two (42), hungry there is plenty of food in the houses of the rich at Fort Section eight (8), (Map 923). #### Revolutionary Movement Is Behind Strike.

Senator Robertson was right when he said that there was a revolutionary movement behind it all. This does not mean that alf the union officials are revolutionaries nor perhaps any of them.
