LICENSE BILL FOR BRITAIN

Was introduced into Parliament and Passed by Commons Recently.

The licensing bill, which was recently passed by the House of Commons and is now before the Lords is summarized as follows:

- (1) The Bill will apply to the whole of Great Britain.
- (2) Licensing justices will be the local authority in each area.
- (3) Subject to special exceptions, the earliest hour at which liquor may be supplied on weekdays will be 11 a.m., and the latest hour 10 p.m. Special exceptions will be as follows:
 - (a) In the metropolis the latest hour may be 11 p.m.
 - (b) Outside the metropolis, if the licensing justices in any area are satisfied that the special requirements of the area render it desirable the latest hour may be 10.30 p.m.
 - (c) Also in the discretion of the licensing justices the earliest hour may be earlier than 11 a.m.
- (4) The maximum number of hours of sale shall be nine per day in London and eight elsewhere, except as varied by subsection (b) above.
- (5) The sale of liquor shall cease for at least two hours in SKEENA LAND DISTRICT—DISTRICT OF QUEEN CHARLOTTE ISLANDS.

(6) The opening hours on Sunday shall be five, not more than two of which shall be between noon and 3 o'clock, and not more than three between 6 and 10 o'clock.

(7) Hotels and restaurants shall be permitted to remain open for a time not exceeding one hour beyond the latest hour authorized for the consumption of meals with or without liquor.

(8) That in clubs the latest hour of supply and the maximum number of hours shall be the same as in licensed premises, without prejudice to the question of Sunday closing in Wales and Monmouthshire.

(9) That the hours of sale for consumption "on" and "off" be the same.

(10) That the "long pull" be prohibited.

(11) That as regards dilution of spirits pre-war conditions be reverted to.

(12) No sale of liquor on credit for "on" consumption.

(13) Hawking of liquor to be prohibited.

(14) That in the areas of direct control the properties and managerial duties of the Control Board be transferred to the Home Office in the case of areas in England, and the Scottish office in the case of areas in Scotland, with an Advisory Committee in each case drawn from the locality.

(15) Sunday closing in Monmouthshire.

In the Letter Box

SUNDAY SPORTS.
Editor, Daily News—

May we convey the following message to the public through your valued medium?

Last May His Excellency the Lieut.-Governor of British Columbia issued a Proclamation through the newspapers, urging people to attend Sunday School on a certain Sunday. The hope was that they would continue to do so through the entire year. Many then asked why His Excellency made such a proclamation. The reason briefly is, that following a period of years of Sabbath breaking and lax attendance at church and Sunday School, the United States has experienced an alarming epidemic of crime and particularly juvenile crime.

Quoting Roger W. Babson, who is America's foremost financial expert and whose book you favorably quoted in a recent editorial, it was found that out of 3000 convictions in juvenile court cases, only three of those convicted were regular attendants at Sunday School. Facts like this forced the authorities to emphasize the worth of Sunday Schools and to urge more general attendance.

Church Responsible.
Since that time, however, there has continued to be in Prince Rupert an effort to draw people away from Sunday schools and churches by a series of organized sports programs on Sunday. The churches are held responsible for public morals and multitudes stand ready to criticize the church if public morals reach a low level.

The ministers did not rush into print criticizing the swimming gala committee but wrote a courteous letter, to that committee, asking that the sports be held on any day but Sunday, and suggested a friendly interview, stating that they were ready to give assistance to the enterprise if their request met with approval. If the committee of a dozen has not had hearty support from those who have attended past galas, here was a chance to have added at least six more including Mrs. Robertson and Mr. Linzey.

Not Unreasonable.
Organized sports are not featured in Vancouver, Victoria, New Westminster and many other places in British Columbia, hence we are not unreasonable in our suggestion. We do not deny that a large percentage of the public are ready to run to anything called sport, even on Sunday but we do protest that either from a religious or patriotic standpoint it is not the best way to spend Sunday and so far as the church going public is concerned we can only urge them to stay away from such things as Sunday swimming galas. We thank you for the space we have taken in your valued paper.
