Wonderful Change In World Sentiment.

"There was a time when Downing Street controlled the Empire. Today the Empire controls Downing Street," said David Lloyd George, Prime Minister of Great Britain and Ireland, in his address recently to the Imperial Conference in London.

Are We Fit to Govern Ourselves?

Often the manner in which popular government works out makes us wonder if we are really fit to undertake the vast work of governing ourselves. As an organized nation we are not always a success.

There are some who have an idea that by a sudden revolutionary move we can suddenly precipitate ourselves into the millennium. The experience of other nations has not borne that out.

In Canada we do not make a very great success at handling public affairs, but we are improving. Every year things are getting better.

Birth of the British Nations.

In addressing the premiers of the British Dominions a few days ago Lloyd George used some most significant words. He stated that those Dominions had now attained full national status.

"The British Government has been under some suspicion in some quarters of harboring designs against this gathering as a conference. We are said to be dissatisfied with the present state of the Empire, and to wish to alter its organization in some revolutionary way.

"We shall be glad to have any suggestions that occur to you as to the methods by which the business of our Dominions in London, so far as it passes through our hands, may be transacted with greater dignity and efficiency.

Would Get Standpoint Of Others.

"On all matters of common concern we want to know your standpoint," the Premier continued. "I will give you my general conception of the mutual relationship in which we meet.

"In recognition of their services and achievements in the way the British Dominions have now been accepted fully into the comity of nations by the whole world. They are signatories to the Treaty of Versailles and of all the other treaties of peace; they are members of the Assembly of the League of Nations, and their representatives have already attended meetings of the League; in other words, they have achieved full national status, and they now stand beside the United Kingdom as equal partners in the dignities and the responsibilities of the British Commonwealth."

EULOGY TO LATE MRS. JAMES B. STAPLEDON FUNERAL ON MONDAY

In connection with the death of the late Mrs. Stapledon, the Victoria Times has the following: With the passing of the late Mrs. James B. Stapledon, widow of the late Bartholomew Stapledon, at the residence of her daughter Mrs. I. W. Rudge, Abbotsford, B. C., Thursday, Victoria lost another of its pioneers.

The late Mrs. Stapledon had been suffering from partial paralysis for the past two years, having taken a stroke in the right side at that time. On Saturday last a second stroke took place, completing the paralysis. Death took place at the daughter's residence after the second stroke, and was in the nature of a merciful release from pain.

The late Mrs. Stapledon died at the age of 76 years, after a long life in which she had endeared herself to all who had the pleasure to make her acquaintance. Of a most lovable disposition, Mrs. Stapledon figured in the home life of this city for many years, coming to this city from Quebec, where she was born in 1845.

An invalid from heart trouble many of her days, the late Mrs. Stapledon was none the less a very prominent factor in the early days of this city and was universally beloved. The late James Bartholomew Stapledon, well known on this coast and in the maritime provinces in his connection with the canneries, being for some time manager of the Skeena River cannery of Turner Berton Co., Ltd., predeceased his widow in 1913.

During the late war, Mrs. Stapledon, though invalided, took a keen interest in the welfare of the Canadian boys at the front and knitted hundreds of pairs of socks and woolen comforters for the soldiers on service.

The daughters living are Mrs. F. W. Rudge and Mrs. Harry Berryman of Abbotsford, B.C.; Mrs. H. G. Johnston of Inverness, Skeena, B.C.; and Mrs. May Moody of Vancouver. The surviving sons are John Stapledon, of Stapledon and Carter in this city; and Burt Stapledon of Seattle.

The funeral took place at Victoria Monday.
