## NEW BUILDING INSPECTOR IS RETURNED MAN

**H. C. Landry Was Given Appointment on Second Ballot of City Council.**

H. L. Landrey was chosen new building inspector on the second ballot at the meeting of the city council last night.

Twelve applications for the position were received and a flurry arose between Alderman Dybbavn and Alderman Perry as to the method of procedure in making the selection. The former thought the applications should be referred to the board of works for report while the latter held that the appointment should be made by ballot. Finally the council went into committee of the whole with Aid. Perry in the chair but quickly resumed and the ballot was taken.

**The Applications.**

The applications were from F. J. Fuller, F. Shaw, a returned soldier, H. D. Belknap, W. H. Shortridge, S. Doiron, H. O. Crewe, W. L. McIlvray, T. Ross Mackay, W. B. Tattersall, F. Salter, H. C. Bailey and H. L. Landrey. On the first ballot there were three votes for Mr. Salter, three for Mr. Landrey, one for Mr. Bailey and one for Mr. Shortridge. On the second ballot the vote stood; Salter 3 and Landrey 5, and the latter was declared elected. Alderman Parker was not present, having left before the voting.

**Soldier Overseas.**

Mr. Landrey, the new inspector, is a returned man and saw five years' service overseas. Before going over he was an engineer in the fisheries protection service and since his return has been an engineer on the Walbrondo. He has had a good deal of experience in building work. One of the most important of his early duties in the new capacity will be to oversee the work on the new Morse Creek bridge.

## EXTRAORDINARY SCHOOL GRANTS

Amount of \$33,200 Approved by Council for Various Work Proposed by Board.

**PROVIDES FOR SCHOOL IN SECTION TWO**

Extraordinary estimates for school expenditure for the year 1921 amounting to \$33,200 were submitted by the school board last night at a special meeting of the city council and were approved on motion of Alderman Dybbavn, seconded by Alderman Perry. Trustees W. T. Kergin, L. W. Patmore, Mrs. E. V. Ling, Thomas McMeekin and J. C. McLennan were all present at the meeting.

The estimates submitted include \$3,500 for the erection of a single room school in Section 2 for small children, the older ones continuing to come into the city. The site for the building, which will be such as can be added to, has not yet been selected.

**Furnishings.**

The furniture and equipment for the new Hays Cove school, reduced somewhat by the decision to use some old equipment from temporary quarters, has been reduced to \$10,000 while the furniture and equipment for the new commercial classes amounts to \$1,700. A sum of \$2,000 has been granted for roads and walks at the new school including a roadway around it and \$1,000 is set aside for sewerage connection. The usual estimate for the upkeep of old grounds of \$2,000 was also passed.

**School Grounds.**

The question of the improvement of grounds at the Hays Cove school has been left to the city council who will take up the question when they are finished with the present plan of making a public playground at the corner of Sixth Avenue and McBride St.

**PETER OF SERBIA IS VERY FEEBLE**

PARIS, Feb. 16.—King Peter of Serbia, now 79 years old, is very feeble, according to reports reaching Paris from Belgrade. He is totally deaf and spends all his time in bed or in an invalid's wheel-chair. Only the Crown Prince and Princess Helene, his widowed daughter, whose husband was killed by the Bolsheviks, are permitted to see him.

While the paralysis which has affected the old monarch's right side for the last two years has improved somewhat, he is unable to walk. He has lost steadily in weight and energy since coming from his retreat in Phaleron, Greece, a year ago and has ceased to participate in the affairs of state.

He is living in a little stone house outside the city of Belgrade. His only companions are his physician and a personal servant.
