**PURCHASE HORSES CANADA AND STATES**

Russia to Replace Those Lost During War and Starved to Death.

WINNIPEG, Feb. 21.—Purchase of 1,000,000 horses in Canada and the United States by the Russian Soviet government, to replace those killed in the war and the thousands which have starved to death in the last four years, may be completed within the next few months in satisfactory financial arrangements can be made, it has become known locally.

The question of arranging satisfactory credits is all that is holding up the deal. There are no Soviet representatives on this continent in connection with the proposed arrangements, but all details are being handled by a Soviet horse purchasing commission in New York, it is understood. The animals will be shipped from Vancouver, according to present plans.

Confirmation of the impending deal, which will involve millions of dollars, was obtained from local Canadian Pacific officials, who have been in touch with the situation ever since negotiations were opened. Several horse dealers in the city particularly those of Russian extraction, are also interested in the deal.

**PRE-EMPTORS' FREE GRANTS ACT.**

The scope of this Act is enlarged to include all persons joining and serving with His Majesty's Forces. The one within which the heirs or devisees of a deceased pre-emptor may apply for title under the Act is extended from one year from the death of such person, as formerly, until one year after the conclusion of the great war. This privilege is also made reciprocal.

No fees relating to pre-emptions are due or payable by soldiers on pre-emptions recorded after June 26, 1918. Taxes are remitted for five years.

Interest on moneys advanced, accrued, due and been paid since August 1, 1914, on account of payments, fees or taxes on soldiers' pre-emptions.

Interest on agreements to purchase town or city lots held by members of Allied Forces, or dependents, acquired direct or indirect, remitted from enlistment to March 31, 1920.

**SUB-PURCHASERS OF CROWN LANDS**

Provision made for issuance of Crown grants to sub-purchasers of Crown Lands, acquiring rights from purchasers who failed to complete purchase, involving forfeiture on fulfillment of conditions of purchase, interest and taxes. Where sub-purchasers do not claim whole of original parcel, purchase price due and taxes may be distributed proportionately over whole area. Applications must be made by May 1, 1922.

**GRAZING**

Grazing Act, 1919, for systematic development of livestock industry provided for grazing districts and range administration under Commissioner. Annual grazing permits issued based on numbers raised; priority for established owners. Stock-owners may form Associations for range management. Free, or partially free, permits for settlers, campers or travellers, up to ten head.
