Canon Rix presided, and the meeting was unanimous as to the desirability of forming a local association. There is already one troop formed in connection with the Presbyterian Church, under the charge of J. A. Teng, and another is in course of formation under the auspices of St. Andrew's Church, and as doubtless more will spring up as the movement develops, it is necessary to have a central supervising body to supervise and nominate suitable persons to act as officers and to appoint badge committees of ladies and gentlemen to examine the boys for their various proficiency badges.

The following office bearers were elected: President, George Rorie; vice-president, A. W. Healy; Secretary, S. Hazett-Jones; treasurer, Edward Smith, and it was agreed that the office bearers along with the following gentlemen constitute the executive committee: Canon Rix, Rev. H. R. Grant, George Munro (Rotary Club), R. Lepine (Elks), C. C. Perry and H. L. Campbell.

The question of drawing up by-laws of the local association's guidance was remitted to the executive committee.

The recent activities of managers and sportsmen to arrange a bout for Jack Dempsey, world's champion heavyweight champion has resulted in a match being set between the champ and Bill Brennan for March 17. Other bouts with Dempsey are also in the wind and one that is said to be maturing is that with Harry Wills. There is, too, talk of a fight in England with Georges Carpentier, European champion. Perhaps, from a commercial standpoint, Jack has proved too great a fighter. General public opinion now seems to be that he is too good for these three or any other aspirants of the present time. This seems in a measure to be true and it is going to be hard to work up similar interest in a battle as showed itself on July 2 last at Jersey City. Certainly it cannot be done in the United States, it might be possible in England not because the fans there think there is much danger of Carpentier winning but because they would like to have the privilege of seeing Dempsey in action. As far as prospects are concerned Dempsey has already vanquished them before or if he hasn't done that it is altogether likely he will if he ever comes up against them. The brawny American is still far and away the best heavyweight boxer on the pugilistic horizon. He may not possess the skill of some but he certainly has the brawn and there have been no indications in the past six months to show that he has been travelling down grade at all. It looks that if Dempsey is to be beaten at all he will have to do it himself or else hold the title until he is too old to defend it.

Miss Phoebe Senkler, who spent last summer in Prince Rupert and showed here her prowess as a swimmer and canoeist, as queen is reigning over the Banff Winter Carnival this week. This popular young lady's word is law in the great outdoor playground of the Rockies and she has indeed a gay kingdom over which to rule. Crowds from various points on the outside are in attendance and the streets are bedecked with flags making a brilliant contrast to the carpet of snow beneath. Three tribes of Indians are there and in the center of Banff Avenue are Indian torques. The scarlet coats of the Mounties also lend to the color of the scene. Miss Senkler is captain of the Vancouver Amazons' ladies' hockey team and she and her retinue reached Banff last night. They will play tonight for the championship.

SYNOPSIS OF LAND ACT AMENDMENTS Minimum price of first class at 25c per acre; second class at 25c per acre. Pre-emption now confined to approved lands only. Records will be granted covering land suitable for agricultural purposes and which is now timber land. Partnership pre-emption abolished, but parties of not more than four may with mutual consent, and each making necessary improvements on respective claims. Pre-emptors must occupy claim to five years and make improvements to value of \$10 per acre, including one acre and cultivation of at least 1/2 acre before receiving Crown Grant. Where pre-emptor in occupation one and cultivation of at least 1/2 acre, pre-emptor may be granted pre-emption certificate of record and transfer his claim. Records without permanent improvement may be issued provided applicant makes improvements to value of \$50 per acre and records same and direct or indirect occupation of at least one year. Title cannot be obtained less than 5 years, and improvements cleared and cultivated, and record of at least 2 years are required. Pre-emptors holding title to land may not receive another pre-emption, if he acquires land in conjunction with his pre-emption, improvements and residence maintained on Crown granted land. Cleared areas, not exceeding 1/2 acre, may be leased as homestead, cleared and improvement condition. Title to be obtained after full compliance with conditions of pre-emption. For grazing and industrial purposes areas exceeding 640 acres may be leased by leasehold or contract. If land is to be used for industrial purposes, the lessee must be a Canadian citizen and must be a resident of the province. Natural hay meadows, inaccessible by existing roads may be purchased by leasehold or contract. If land is to be used for industrial purposes, the lessee must be a Canadian citizen and must be a resident of the province. No fees relating to pre-emption pre-emption or payable by lessee on pre-emption records after June 28, 1914. Taxes are levied for five years. Provision for return of money advanced, due and been paid since August 1, 1914, on account of payments, interest or taxes on sold lands, to purchase of town or city lots held by members of Allied Forces, or dependents, acquired by pre-emption, granted from allotment, to March 31, 1920. SUB-PURCHASERS OF CROWN LANDS Provision made for issuance of Crown grants to sub-purchasers of Crown lands, acquiring rights from purchasers who failed to comply with conditions of purchase, interest and taxes.
