Big Bill Haywood is Out of a Job and Cannot Return to States

Aging, grey, lonely and disillusioned, "Big Bill" Haywood, king of American agitators and bulking terror of many a strike, sits in a little room in Moscow drinking tea, says a Ketchikan paper. He broods over the fading visions of his Siberian Utopia.

He is learning the bitter lesson learned by Emma Goldman, Alex. Berkman and a good many others who went to Red Russia to baffle themselves in the light of the Red Dawn. Haywood's Russian "comrades" are through with him. They used him in their business and have tossed him aside. He has been thrown out of his autonomous industrial colony at Kusbass. It was this colony that was to show a capitalist world just how well and capably the workers of the world could carry on a great industrial enterprise when freed from capitalism's blighting presence.

Things Went Wrong

Things went wrong at Kusbass. The colonists were reported dying from disease. There were rumors they were starving. History was repeating itself, the history of Jamestown's "commune" of the Owenites, of Brook Farm and the learners in America, and a thousand others of these commune-dreams of the Old World, was being lived again over again at Kusbass.

Haywood had bullied his way to the top of American radicalism and he sought to bully the Reds. It was no use. They—
