Sports and Games in Afternoon with Varied Entertainment in Evening followed by Dance

Victoria Day was fittingly celebrated on Saturday by the people of Prince Rupert. The city was gaily decorated with flags and the several entertainment attractions provided during the day went off to schedule. While local showers were general in the morning the sun shone brightly at intervals and the weather in the afternoon and evening was pleasant. At an early hour people were astir on holiday bent and the crowds that gathered at the exhibition grounds were in good humor. Several parties of sportsmen took advantage of the long week end to go on fishing excursions while other owners of pleasure boats went picnicking. The majority of the citizens, however, spent the day enjoying the attractions provided at the Save the Surface carnival put on jointly by the Fair Board and Elks. The great attraction of the day was the wedding ceremony at night when Miss Marjorie May Cameron and Alex. Hudema were married by Rev. G. G. Hacker before a large congregation. Prior to the wedding ceremony the Skeena river entertainers put on a good program of songs and dancing. LACROSSE TEAM TO VISIT OCEAN FALLS

Announcement Made at Banquet in St. Regis Cafe Saturday Night

On Saturday night, in the St. Regis cafe dining hall, Ben Self and Harry Lipsell entertained the players and officials of the Prince Rupert Lacrosse Association, who participated in the exhibition game in the afternoon, to a sumptuous chicken dinner. A letter was read by Ben Self during the function from the sports committee at Ocean Falls. The letter invited the local Lacrosse Association to send a team to the paper town on July 1, the Ocean Falls team to play a return game here the following year. It was decided by the players to accept the invitation.

Sport Chat

A proposition has been made by the civic board of works to the Gyro Club that it place its playground equipment in McClymont Park instead of at the corner of McBride Street and Sixth Avenue. It is deemed that this would be a good idea in view of the fact that the city proposes putting in a swimming tank at McClymont Park. A real centralized children's park could then be provided. The city offers to assist in erecting the equipment at McClymont Park and also to appoint a permanent supervisor. The Gyro Club will deal with the offer at its next meeting.

The London (England) County Council, which is the authority for all the London Parks (the Royal Parks excepted) control 725 public tennis courts, about 110 of which are hard and the rest grass. Within the last two or three years there has been a great tennis boom in London. Before the war the game was played only by people who had lawns of their own, or belonged to clubs. Now the number of clubs has greatly increased, and the membership of many is made

up almost entirely of workers in shops or offices. Many beginners, who have nowhere to play at home, make up sets with their friends and practise on them in the parks before venturing to join a club. Last year well over 100,000 people used the public courts, and paid over \$150,000 in fees for the grass courts alone. A shilling an hour (24 cents) is charged for one class of court and ninepence (13 cents) for the other, with a registration fee of a shilling for a season ticket. Already the authorities have received this year applications for 50,000 grass court and 14,000 hard court seasons.
