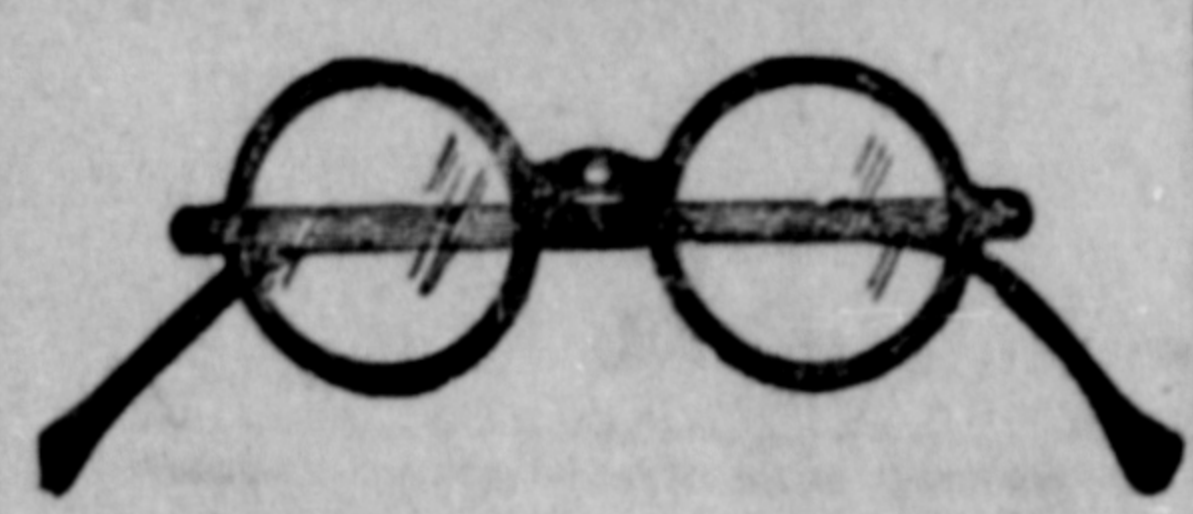

DEBATING METHODS OF CANADA ARE NOT EFFECTIVE ALLEGED

(Edmonton Journal)
Another team of Old Country university debaters has arrived in Canada and we shall before long have the opportunity of hearing it in Edmonton in the contest with the University of Alberta. They are all drawn from Cambridge. These visits have proven an excellent thing in every way. They have provided a real intellectual stimulus and are bound to accomplish much in raising the standards of public speaking. As a means of drawing the young people of the empire into closer relations there can be nothing better and an effort should be made to have Canadians pay return visits to Britain.

The young man who led off in Edmonton for the British team last winter, Nunn May of the University of Birmingham, has published since going back home some of his impressions of the tour. Much of what he says deserves close attention on the part of our budding orators. He thinks that the Canadian debaters take their subjects too seriously and would do better if they aimed at bringing more wit and humor to their speeches. They show, in his opinion, the results of too intensive training for their task. By trying to make every sentence pregnant with argument and expunging every unnecessary word, they do not have the effect on the audience and on the judges that they would if they adopted a more free and easy method.

"Our first contact," writes Mr. May, "with the packed scientific argument of a well trained team filled us with dismay. Yet the judges seemed kindly disposed to us and we lost only about four of our debates in Canada."
That the criticism is a sound one, most of those in the audiences at the two last Edmonton contests will agree. Heed should be paid to it in preparing for the coming debate with the Cambridge men.

FIELD AND TRACK MEET AT OLYMPIC GAMES SUMMER 1928

TORONTO, Nov. 22.—The Olympic track and field program will occupy eight days in the summer of 1928 at Amsterdam. The Canadian Olympic committee has received a copy of the program, which is as follows:

First Day

taken place and where the body was later found by the searchers. The scene of the crime, according to testimony, was off an old disused trail near the native cemetery.

Mrs. H. W. Morry testified that she had lived 25 years in Port Essington. Miss Chisholm had boarded at her house for nine months up to May 23. That morning, as was her custom, she left the house for a walk shortly after 9 o'clock. This was before breakfast for which she was expected to return about 10 o'clock. She did not, however, return and the alarm was raised and search instituted.

Mrs. Morry identified the clothing that deceased had worn on leaving the house on the morning in question—a brown corduroy skirt; gray woolen sweater, green transparent raincoat, gum boots turned down at the knees and camolis leather gauntlets. She wore no hat and her bobbed hair was fastened on the right side with a red barrette. The raincoat was torn on one sleeve but, otherwise, all the clothing was clean and in sound condition when she left the house. The weather was fine in the morning, there was about an hour and a half's rain in the afternoon and later it cleared up again.

Answering Mr. Patmore in cross-examination, Mrs. Morry stated that her time on the day in question was the same as the school time which was the time carried by accused. Deceased had the appearance of a strong, athletic girl.

After Mrs. Morry's evidence, the court adjourned.

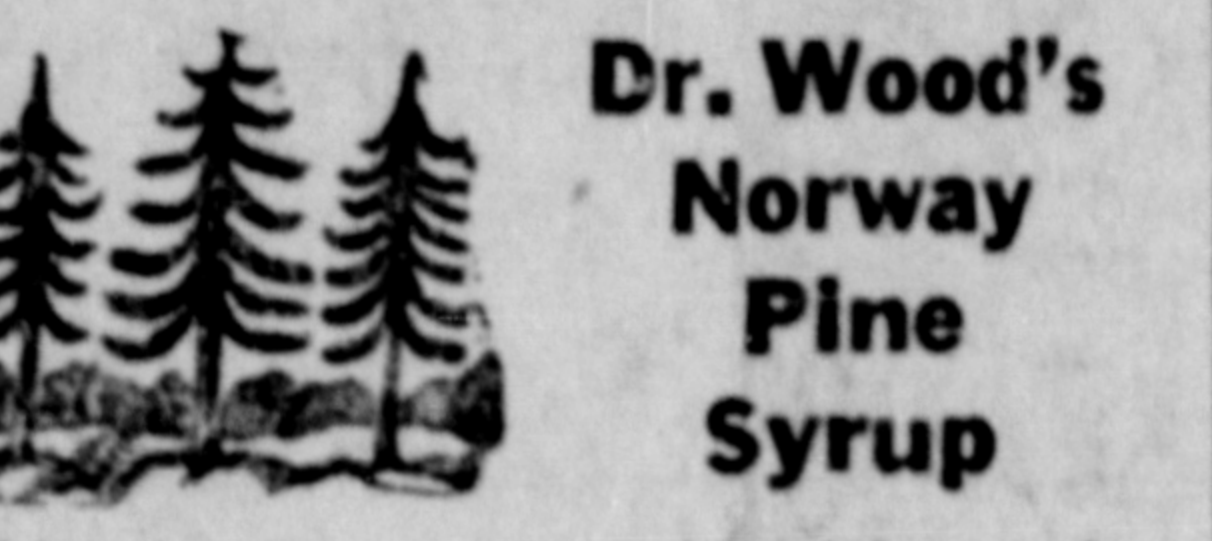

Lotteries and totalizers at races are the only form of gambling allowed in Denmark. Book-making for instance, is a criminal offence.
