


SOLID 18K OLD

REGRET OVER S. K. CAMPBELL LEAVING CITY

**Harry Birch Appointed Delegate
to Convention in September**

Expressions of genuine regret were voiced at the regular meeting of the hospital board last night when the resignation of S. K. Campbell, president of the board, was received. Mr. Campbell, who has been promoted to an inspectorship in the service of the Canadian Bank of Commerce, will leave for the south on Saturday of this week. J. H. Thompson, vice-president of the board, was in the chair at last night's meeting and those present included Directors G. P. Tinker, S. D. Johnstone, Mrs. Morrissey and Leo Waugh and Secretary Harry Birch.

Mr. Birch was appointed delegate to the convention of the B.C. Hospitals' Association which will be held in Vancouver in September. It was announced that it had been decided to pool the expenses of all delegates. This will lighten the cost of sending a delegation from Prince Rupert to this convention which it was originally intended to hold here.

On account of the overcrowding that has been experienced during the past few months in the present accommodation at the hospital, it was decided to kalsomine and equip with beds the ward in the basement so that it may be ready for use in case of emergency.

An expenditure not to exceed \$100 was authorized for the new walk to the Nurses' Home which will be built by the city.

Mrs. R. F. Perry left on Tuesday for Taft, California, to visit her daughter. She expects to be away about two months.
