

### SIDEWALK ON SEVENTH AVENUE IS PROPOSED

Board of Works to Report on How Far It Will go—Designed to Protect School Children

Primarily to serve as a protection for the traffic of school children, the city council is planning the building of a sidewalk on McBride Street from Sixth to Seventh Avenues and along Seventh Avenue to Hays Cove Circle or beyond.

The board of works having recommended that local improvement bylaws providing for the work be introduced, discussion at last night's council meeting developed as to whether the sidewalk along Seventh Avenue should terminate at the circle or continue around to Sixth Avenue. Some of the aldermen felt that it would meet the requirements to have the sidewalk built just as far as the circle. Ald. Casey pointed out that in all probability it would become necessary in the near future to close the trestle on the north side of the circle and in that case, all traffic would be diverted to the south side. There would then be congestion there and he felt that it might be wise to have the sidewalk put in there so as to protect pedestrians.

It was decided to refer the matter back to the board of works for further report.


