## APPOINTMENTS ARE DEFERRED

Forty Applications Are Received For Five Vacancies on Staffs of Local Schools.

The school board at its meeting last night opened forty applications for five vacancies on the staffs of the various schools and, after spending a couple of hours in going through them, deferred the making of definite appointments until a special meeting that will be called in the near future.

The meeting received the resignations of Henry O'Neill from the staff of Booth School and of Miss Beatrice Burke from the High School staff. These are in addition to the resignations of Miss Larsen, who resigned during the spring from the staff of Seal Cove School on account of ill health and for whom Miss Cross has been relieving, and Miss Creighton and Miss Weatherhead, who resigned from the Booth and Borden Street staffs respectively.

Miss E. M. Lauder, of Borden Street school had a letter before the board requesting that she be transferred to Booth School to take Mr. O'Neill's division.
