## REVISIONS IN PRAYER BOOK

REVISIONS WILL GO BEFORE CONVENTIONS, CHURCH ASSEMBLY AND FINALLY PARLIAMENT

LONDON, March 3—(Canadian Press Despatch).—Next month the new book of common prayer will undergo final revision by the bishops. The Archbishop of Canterbury has stated that he hopes that on March 29, the bishops will be able to present the measure and its schedules to the Convocations and to obtain their consent to its being laid before the whole assembly for final approval, and so ultimately before Parliament. The Church Assembly meets in July, so that if these stages are passed successfully, the new prayer book should be placed before Parliament in the autumn.

In the new Book setting forth the bishops' proposals, which is enjoying an immense sale at present, the original prayer book is given section by section, and following each section are the variations, carefully distinguished, for permissive use.

The Bishops emphasize the fact that their proposals are not binding. Parishes may still keep exclusively to the book of 1662, or they may elect to use parts of the old and parts of the new. In any case, only one book will be required for Church services, and in one cover Church people may find the old and the new.

There are abundant evidences that the Bishops have proceeded on a conservative basis. They have given greater elasticity in the form of services and
