

## PRINCE GEORGE

William Miers, general road foreman, has returned here from Forestdale where work has been started on the nine mile diversion in the highway to Hazelton which will change the location of the road between Rose Lake and Forestdale to eliminate a number of bad hills.

A road camp is being opened this week at the point near Mud River where a cut-off is being made on the main highway. The diversion is to be open for traffic in July.


