Mikola Martinowicz, the man who s believed to have been the owner of a suitcase which landed at the local baggage room some months ago and was found to contain cracksman's outfit, is coming up at the Supreme Court Assizes in Prince George next Monday for trial on one charge of having had explosive substances under his control and another of being in possession of forged bank notes.

Martynowicz has continued as a man of mystery to the police since his arrest. While seeking to rent a shack in Prince George he dropped some papers. These on being picked up were found to consist of a one dollar Dominion of Canada note and two pieces of white paper upon which negatives of the dollar note appeared. The papers all had a strong smell of lysol. The find was reported to the police and a search for Martynowicz was started. He was picked off the C.N.R. train bound for Prince Rupert, largely as the result of his being in possession of paper currency having a strong odor of lysol. He was later committed for trial.
