GOOD ROCK MAN HAD BAD LUCK

Dangerously Spectacular Shot on Wednesday Morning was Due to Fault in the Rock Imperceptible from Surface.

Chief Vickers' investigation of the shot which threw rock wildly down First avenue near the Westholme Lumber Co.'s yards led to the appearance in the police court yesterday of John Anderson to explain the matter.

John Anderson, however, was known to be a careful rock-man, and this was the first unlucky shot he has fired since he came to the townsite. He said that he had put in a shot the morning before which had only just moved the rock. The unlucky shot had the same charge, three boxes of powder, in a 19 foot bore.

Magistrate Carss dealt leniently with the case imposing a nominal fine of \$5 and costs, and warning Anderson to attend to the matter of brushwood which is intended to prevent fragments from flying.

In this case, however, it appears that the blast blew out from below owing to the presence of two imperceptible seams in the substance of the rock below the surface.
