JYKELL AND HYDE MYSTERY IN REAL LIFE COMES TO LIGHT

MAN WHO HAS LIVED DOUBLE LIFE FOR YEARS COMES SUDDENLY INTO REMEMBRANCE OF FORMER SELF AS IF RETURNED FROM THE DEAD.

A man who says he is George A. Kimmel, whose skull recently was operated on by Chicago surgeons, has issued a statement in which he declared he lived a Jekyll and Hyde life.

"If you remember the story of Dr. Jekyll and Mr. Hyde you can understand my plight," he said. "After fourteen years of darknessness I have regained my lost personality, and my better nature has asserted itself.

"I now remember every detail of the assault which changed my life. I know the names of my assailants. Their attack had been carefully planned. I was slugged on Sixteenth street, St. Louis, in July, 1898, after having been taken there drugged from the Midland Hotel, Kansas City.

"I had \$520 in the American National Bank at Kansas City. One of my enemies telephoned in my name and had the money taken to the Midland Hotel. Since this operation I remember counting that money when it was given me by the cashier. I now remember dropping a coin as I counted it. This was picked up by the cashier and returned to me.

"Another fact that came back to me since the operation is my return to Niles, Mich., where I became cashier of the First National Bank, taking the place of George Howard, who was believed to have been drowned in a lake near the city."

The Kimmel claimant said that the names of the three men who, he says, slugged him and caused him to lose his memory will not be told until the mother of George A. Kimmel, who branded the claimant as an impostor, begins her case in St. Louis this month for recovery of \$25,000 from an insurance company in which she says her dead son held a policy.

ROASTED MEN STILL ALIVE

Horrible Atrocities Perpetrated at Lhasa by Incensed Tibetans Furious at the Chinese.

Hongkong, May 20.—There has been serious rioting against Chinese at Lhasa, the capital of Tibet, during which many Chinese were roasted alive after an attack on the Chinese quarters in which many on both sides were killed and wounded.

The affair followed a statement by the Thibetan Lama that Chinese were destined for divine punishment. A fight ensued and the Lama fled to the Sela monastery, which was fired. The Chinese quarters were then attacked by angry Tibetans and many were roasted alive.
