## PT. EDWARD WINS TITLE

Overcoming a determined last minute attempt by their rivals to stave off defeat, the Port Edward basketball team defeated Acropolis Hill 32 to 31 Wednesday night in the latter's gymnasium to win the "A" Section championship.

This game was not an Area Basketball League play-off but a fixture to determine the winner of "A" Section. Both teams and the winners of a City-Officers sudden-death game will be included in the play-offs with the champions of "B" Section.

A packed house witnessed the court struggle which saw Henson secure half of the winners' points—16—to emerge as top scorer.

Neither club was able to score with much regularity in the early part of the initial quarter until Acropolis, trailing 4 to 6, tallied three baskets to go ahead, 10 to 6. The hill cagers added another field goal before the frame's end to bring the count to 12-6.

The visitors came back strongly in the second quarter, scoring 10 points to their opponents' one and forging a 16-13 lead by half-time.

Early in the third session Wallingford of Acropolis was injured and retired to the sidelines with a dislocated shoulder. The teams were on fairly even terms in this quarter and at its end the Port Edward squad still led, by 27 to 22.

With little more than a minute remaining in the game Willoughby and Deiss scored in quick succession for Acropolis to shave the visitors lead to 32 to 31 but there the basket-getting ended.
