EVERY MEMBER has the privilege of checking with the Bureau when he is asked for credit accommodation by a NEW CUSTOMER, or a new resident of the city. His membership in the Bureau gives him the right to obtain a credit report which will confirm or deny all the statements made by the applicant when applying for credit. This will confirm information regarding his employment, etc., and particularly how he has taken care of his past commitments. In the case of a newcomer, this will be obtained from the Credit Bureau where he last resided. His membership in the Bureau makes it necessary for him to report to the Bureau the names and addresses of all accounts paid according to agreement, as well as those not paid satisfactorily.

In other words, you make your own credit record.
