

Two James Dean Films Win Seven Oscar Bids

HOLLYWOOD — Four of Warner Bros.' 17 1955 Academy Award nominations went to "East of Eden" and three to "Rebel Without A Cause," both of which films starred James Dean.

Dean himself was nominated for an Oscar for his performance in "East of Eden," his very first starring motion picture. Dean's nomination for "East of Eden" marks the first time that a player has ever been honored with this distinction posthumously.

Dean died in the era of his sports car with another auto last September shortly before "Rebel Without A Cause" was released and immediately after he had completed his role in George Stevens' forthcoming production of Edna Ferber's "Giant."

Audiences in the first national Audience Award poll, last fall voted Dean the best actor of the year.

In addition to James Dean, other Academy nominations for "East of Eden" included Jo Van Fleet, best supporting actress; Elia Kazan, best director; and Paul Osborn, author of the best screenplay.

Miss Van Fleet made her film debut in "East of Eden" as Dean's mother. Kazan previously won Oscars for his direction of two films — "Gentlemen's Agreement" and "On the Waterfront."

For "Rebel Without A Cause," Academy nominations have gone to Natalie Wood, as best supporting actress; Best picture: "Mister Roberts"; Best supporting actress: Peggy Lee, for "Pete Kelly's Blues"; Miss Lee lost fall picked up an "Audie" as the most promising new female personality.

Best supporting actor: Jack Lemmon, for "Mister Roberts."

Best cartoon: "Speedy Gonzales."

Best sound: "Mister Roberts."

Best special effects: "The Dam Busters."

Best song: "Unchained Melody," from "Unchained."

Best score of a drama or comedy: "Battle Cry," by Max Steiner.

Best one-reel short: "Gadgets Galore."

Best two-reel short: "24 Hour Alert."

Best story and screenplay: "The Court-Martial of Billy Mitchell," by Milton Sperling and Emanuel Lasker.

Oscars will be presented Wednesday, March 21 on the stage of Los Angeles' Pantages Theatre.

The broker, who asked his name not to be used, said British Columbia generally is experiencing a deficiency in eggs and imports from Alberta and Saskatchewan cannot meet the demand.

Grade A large prices range between 63 and 65 cents a dozen.

U.S. Seizes Romanian Funds

WASHINGTON — The United States government Monday seized more than \$13,250,000 that had been deposited in New York City by the National Bank of Romania.

Attorney General Herbert Brownell said the money would be used to help satisfy claims of U.S. citizens against the Romanian government.

The money was "frozen" by the alien property custodian during the Second World War.
