INCREASING IMMIGRATION An analysis of the figures of immigration from the United States into Canada last month shows that 38 out of the 48 states of the Union contributed to the swelling tide of American citizens pouring into the Dominion.

Immigration to Canada via ocean ports during the month of April this year was 4,437, as compared with 35,283 for April last year, an increase of 17 per cent.

In discussing this highly satisfactory increase, J. Bruce Walker said that proportionately the increase of settlers west of the Great Lakes was much greater than ever before.
