

MAN CONFESSES TO MURDER OF LITTLE CHILDREN

TURKEY APPEALS TO POWERS FOR INTERVENTION--SERVIAN PRESS MAKES TROUBLE

CAME FROM WINNIPEG TO CITY TO APOLOGIZE FOR A THREAT

RUSSIAN CLAIMED HE CAME ALL THE WAY FROM WINNIPEG
TO ASK PARDON FOR THREAT OF MURDER--WANTED
TO COMMIT BIGAMY.

Verging on what might have led up to a tragedy in domestic life was the simple little story unfolded with the greatest difficulty through the aid of an interpreter in the police court this morning.

Put in synoptic form, it was as follows: Luka Ivanovich Lapinovich, known in this country as Mike Donavich, a pleasing and prepossessing looking young Russian, seven years ago, back in his native land, married the girl of his choice. One year later, leaving his bride with her father, he emigrated to Canada, settling in Winnipeg. The old adage that "absence makes the heart grow fonder" worked in a reflex fashion, however, and Luka fell in love with a pretty young Canadian girl and wished to marry her.

His wife's brother, who is also in this country and at present in Prince Rupert, becoming aware of the state of affairs, proceeded to take steps to thwart such a bigamous act. Thereupon Luka wrote a letter to Mike Kruck, the brother, addressed to his post

office box in this city, saying he was tired of his present wife and was going to marry a girl whose photograph he enclosed. He further said that if the former put any obstacles in his way he would see to it that he was put out of the way. The threat including the accused's wife also.

An interval of nearly four months then elapsed. Last Wednesday Luka arrived in the city on the Prince Rupert, from Winnipeg and went straight to his brother-in-law's house with the avowed intention, so he is said to have declared, of excusing himself for making the rash threat.

At the house Kruck asked him if he had a gun on him, and he declared he had not. The former, however, not wishing to take any chances, got his own gun trained on his errant brother-in-law whilst his wife searched him for verification of his statement. This was as far as the case went in the police court this morning. Magistrate McMullin committing the accused for trial, and he will come up for election this afternoon.

HUMAN FIEND TELLS OF HIDEOUS CRIMES

PUBLIC MEETING WILL BE HELD TO DISCUSS SEWERS

MEETING NEXT WEEK TO EXPLAIN SEWERAGE SYSTEM—ALD. MORRISSEY CANNOT HAVE DECORATIONS—COUNCIL WILL NOT DISCUSS ENTRY OF CORPORATION.

Alderman Clayton last night proposed that a public meeting to discuss the sewer bylaw be held in one of the theatres. The 27th inst. was decided on, and the Mayor was given authority to make all necessary arrangements.

A court of revision of the municipal voters' list is to be held in the city hall on Tuesday, December 10th. The court will consist of the Mayor and Aldermen Douglas and Dybhavn. Alderman Morrissey brought down the wrath of his colleague, the finance minister, upon his head by suggesting that the Council take steps toward beautifying the city telephone office building. He wanted to have it painted, with possibly two coats of paint if necessary.

Alderman Douglas instantly arose to his feet with horror and indignation depicted on his countenance and denounced his worthy brother for his absolutely wanton extravagance and recklessness. Was not he, the finance minister of the city, doing his utmost to tide over their fiscal difficulties and endeavoring to make two ends meet? He was

astounded to think Alderman Morrissey was pursuing a course he had seen fit to follow all along, of interfering and making suggestions about subjects of which he knew very little about. The matter was dropped.

A gentleman representing a patent fire and waterproof roofing called the Brooks brand of asbestos, addressed the Council upon the subject of its introduction into the city. He was desirous of seeing the Council pass a bylaw favorable to his company's chances of doing business here. The sample was turned over to the Fire Chief and Building Inspector to test and report.

Alderman Clayton made a tentative motion that a plan followed in Edmonton, of loaning the money on hand for a sinking fund to responsible citizens for improvements on their property be adopted here. He showed where a far better rate of interest would be thus obtained, whilst pushing forward the growth of the city. Several aldermen had objections to raise

SERVIAN PRESS LOUDLY DENOUNCES AUSTRIA AND MAKES AFFAIRS WORSE

The Attitude of the Press Complicates Matters---Turks Suffer From Cholera---Powers Asked to Intervene---Bulgaria Wants Turkey Expelled From Europe

(Special to Daily News.)

Vienna, Nov. 19.—The Austro-Servian difficulties have been rendered more serious by the hostile tone assumed by the Servian press in its denunciation of Austria and her demand of Serbia to keep off the Adriatic Sea. The situation is a grave one and the action of the press is making it far worse.

Constantinople, Nov. 18.—The Sultan is preparing to appeal to the powers to intervene and make peace. The heavy fighting continues about the city and the

allies declare that nothing but the complete annihilation of Turkish rule in Europe will be accepted by them.

Vienna, Nov. 18.—Terrible stories of the ravages of the cholera among the Turkish troops and the treatment accorded to the victims are told in the Frankfort Gazette. Hundreds of the soldiers are said to be afflicted with the disease, and in spite of this they continue to report for action with guns in their hands.

Constantinople, Nov. 18.—A detachment of 1,000 bluejackets

has been loaned by the British cruiser Weymouth to the United States to guard her embassy, as the American station ship Scorpion has been allotted to duty on the Upper Bosphorus and the American cruisers are not expected until the latter part of the month.

London, Nov. 18.—The Times correspondent at Sofia declares that the Bulgarians have lost fifty thousand men from wounds and disease during the brief hostilities. This is one out of every forty of the male population.

POOL ROOMS TO OPEN SUNDAYS IN FUTURE

Council Make Eleventh Hour Decision and Quash Their Own Bylaw—Clayton and Dybhavn Oppose.

At the meeting of the City Council last evening a letter was read from the proprietors of the pool rooms in the city asking the Council to rescind the bylaw enforcing their closure on Sundays.

Aldermen Maitland, Montgomery, Bullock-Webster and Morrissey spoke in a decided manner in support of the petition. The ground they all took was that anything partaking of the nature of class legislation be abolished. The several clubs of the city offered privileges to the possibly wealthier and more fortunate male members of the community, and it was working a distinct hardship on the large number of working men, most of whom had no home of their own, who had absolutely no place of resort where they could foregather on a Sunday.

Pool and billiards was asserted to be a game of skill and science. No gambling or card games were ever allowed in the pool rooms.

Aldermen Dybhavn and Clayton opposed the request, thinking that it was a poor policy at the eleventh hour of the Council's life to turn down their own bylaw.

A motion to grant the request was carried.

There will be no basket ball games tonight.

INDIANS TO RECEIVE VOTES BUT NOT LAND

McBride Would Deny Indian Ownership of Reserves, but Would Give Him the Franchise.

Ottawa, Nov. 16.—Premier McBride and Attorney General Bowser of British Columbia are taking up with the government here the old question of the title of Indian lands in British Columbia. The Indians are the wards of the Federal government, and the Provincial government refuses to recognize the title of the Indians to the reservation lands on which the Dominion government has placed them.

The Indians carried an appeal two years ago to the British Throne, a deputation having gone to England to ask for the King's intervention in determining their rights. The missionaries say that they cannot succeed among the Pacific Coast Indians until their grievance is settled. The Premier is not willing to admit the Indians' claim to ownership of the lands they are now on. He proposes, instead, to give them the voting franchise and the right to own land on purchase and then move them from the lands they are now on to other and less valuable lands.

Eventually, after she denounces the Lion and refuses to marry the son of a man who has so little heart, it all works out to the satisfaction of everyone, even the young lady whom the old financier picked for his son's wife.

In the role of the Lion, Mr. Rex Snelgrove was exceedingly clever and left nothing to be desired. His part called for some strong acting, and on every occasion he was equal to the task.

Mr. S. M. Griffith, as Senator Vincent, was particularly good and played his part in the finished manner that at once characterizes him as being an artist of long and varied experiences.

Mr. Richard Frazier, as the son of the Lion, also left nothing to be desired, and by his strong, clean-cut acting won the spontaneous applause of the audience. In the third act especially he shows to decided advantage, playing his part with an astounding reality.

Mr. Harry Lancaster, the "third groom in the second bed chamber of the youngest son of England's queen," was very comical in his comedy role, which he did not overdo in the least.

NOTES OF INTEREST OF THE BALKAN WAR AND THE ALLIES

There is no pauperism in Serbia, in the sense in which it is understood in the west. The poorest have some sort of freehold property. There are a few poor people in Belgrade, the capital, but neither their poverty nor their number has necessitated an institution like a workhouse.

Serbia is an agricultural country, where almost every peasant cultivates his own freehold. The holdings vary in size from ten to thirty acres mostly. Of the total area (11,930,740 acres) 4,607,520 acres were cultivated in 1904, and 3,816,620 were under woods and forests.

Carpet weaving is one of the oldest industries in Serbia. The product is manufactured principally at Pirot, in Southeastern Serbia, and the carpets are named after this place. The chief characteristics of these carpets are that they are made of pure wool, dyed with natural colors by local dyers, who pride themselves that the process of dyeing and color mixing is a secret transmitted by father to son, and is known only to the inhabitants of Pirot.

The area of Montenegro, who opened the campaign, is officially given as 3,255 square miles, considerably less than the size of Wales.

From 1389, when they first successfully maintained their independence against Turkey, the Montenegrins—fierce and implacable foes—have waged almost incessant war against the Turks, their hereditary enemies.

Montenegro is allied to Italy by marriage, Princess Helena, the third daughter of the reigning king, Nicholas I (he has three sons and six daughters), having married the present King of Italy in 1896.

The population of Turkey consists of an extraordinary mixture of races. In European Turkey the Turks are about 2,000,000, the Greeks and Bulgarians 1,300,000 and the Albanians 1,500,000. In Asia the Turks are about 7,000,000, the Kurds 1,000,000, the Greeks 1,000,000 and the Armenians over 2,000,000, while the rest is made up of Syrians, Jews, Franks, Gipsies, Tartars, Circassians, etc.

In Turkey elementary education is nominally obligatory for boys from six to eleven years of age, and for girls from six to ten years of age, education being free. All schools are under government control, but there is no interference with the religious education of the different communities.

Macedonia, which is the centre of the whole trouble—for Bulgaria, Serbia, Montenegro and Greece believe that Turkey is so weakened by the war with Italy and by internal dissensions that the moment is favorable to throw off the Turkish yoke under which their kinsmen and fellow Christians in Macedonia have been chafing and suffering for many years—fell into the hands of the Turks in the sixteenth century.

To the north of Macedonia lie

Bulgaria, Serbia and Montenegro, with Greece on the south. The population of the coast districts are Greeks, whilst in the interior Christian Bulgarians greatly preponderate. The agitation in Macedonia for reforms in government and the brutal oppression of the Christians in 1902-3 by Albanians, secretly supported by the Turkish authorities, led to open revolution. In its suppression terrible atrocities were perpetrated by Turkish soldiers, whole villages were massacred and a fierce vendetta kept up on both sides. And, in spite of a scheme of partial reform drawn up by the powers, the state of Macedonia is still very bad.

Turkey's army is outnumbered in the field against the Balkan states. Her total land fighting force is 300,000. Bulgaria can place 350,000 men in the field, Serbia 110,000, Montenegro 30,000 and Greece 50,000; but it should be mentioned that Turkey has great reserves of efficient men.

Bulgaria is a very small country, with a total population of only a little over 4,000,000, or rather less than Ireland, which it only slightly exceeds in area.

The Balkans is the name given to the Balkan peninsula, which includes the following countries: Turkey in Europe, with its possessions, Macedonia and Albania; Bulgaria, with Eastern Rumelia; Serbia, Montenegro and Greece.

It is the Balkan league which has been formed by Bulgaria, Serbia, Montenegro and Greece to free their kinsmen and fellow Christians in Macedonia from Turkish oppression. The league hopes to take advantage of Turkey's weakness after her unsuccessful war with Italy. The countries of the league are bound to make war together and may not conclude peace individually.

The Ottoman navy has been in the course of reorganization for the last two years under British admirals and a British staff of navigating torpedo boat and gunnery officers. The navy at the present time consists of a dozen men-of-war, eight destroyers and fourteen torpedo boats.

New manufacturing plants in Fort William actually under construction that will cost nearly \$3,000,000, will be in operation early in 1913, and will employ 2,000.

The Fort William October Customs receipts total \$191,000, against \$186,000 in 1911, giving an increase of \$4,700.

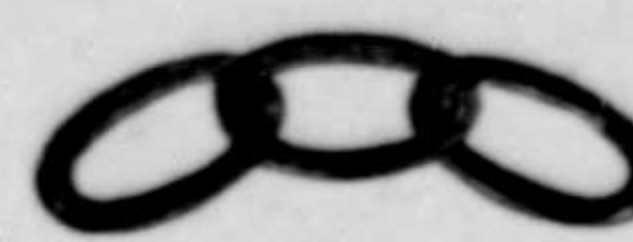

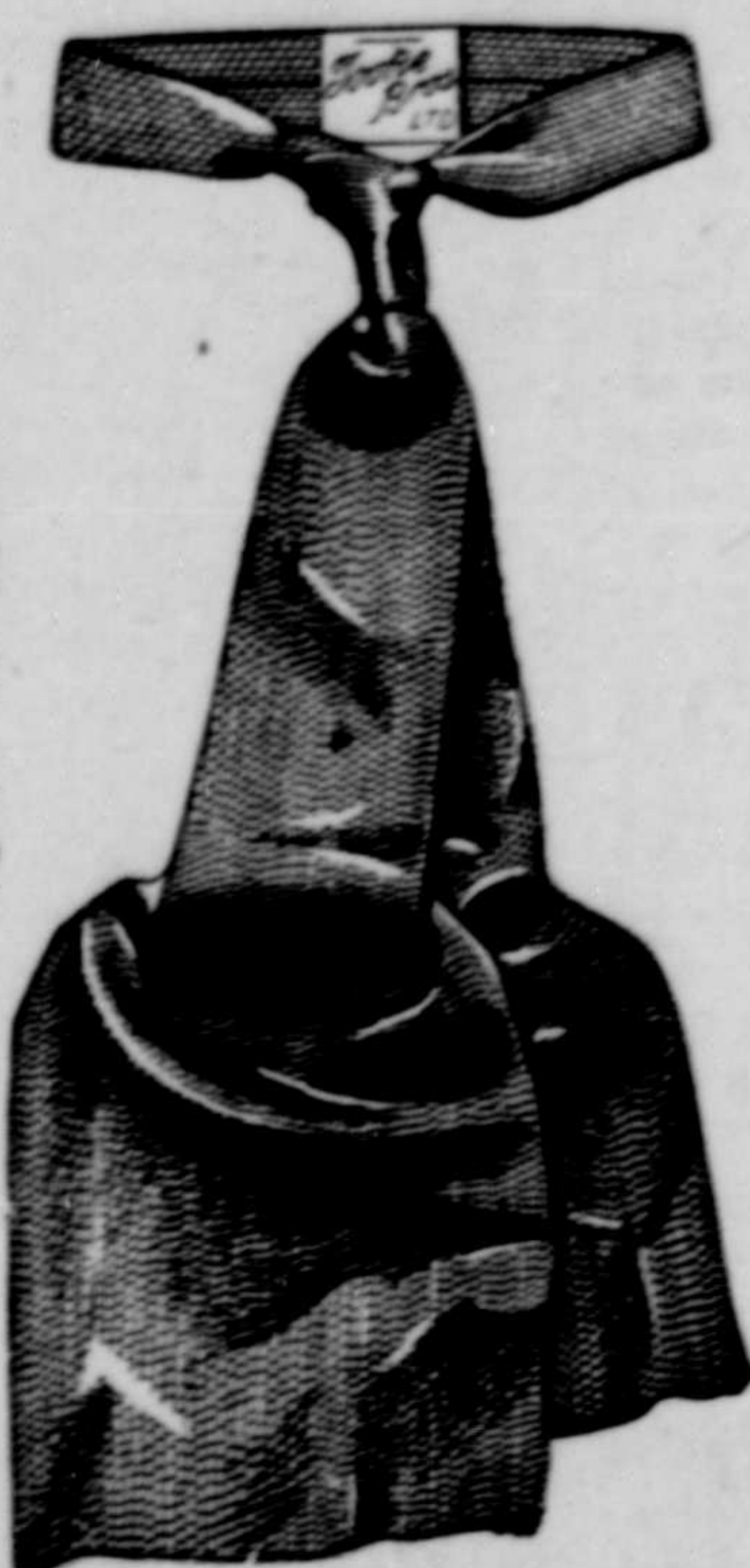

NEWS NOTES OF THE GREAT WEST

In Calgary excavations have commenced for a new building for implement manufacturers to cost between \$140,000 and \$150,000. The building will be of stone and brick with a concrete foundation. It will have a frontage of 125 feet.

Bank clearings in Victoria for the week ending November 7th, amounted to \$4,703,000, as compared with \$3,389,000 last year, being an increase of 38 per cent.

In Winnipeg bank clearings for the week ending November 8th, amounted to \$4,574,000, being 25 per cent. greater than any previous record. The building of an apartment block is announced, to cost \$20,000.

A new theatre is announced in Vancouver, costing complete \$1,250,000. It is to be ready next year. The Progressive Club are planning for the unveiling of a statue of Captain George Vancouver in 1915.

The building permits in Winnipeg pass \$19,000,000. They include a large creamery costing \$350,000, and an apartment block costing \$150,000.

A cold storage plant at Fort William, costing \$50,000, is announced, and also another steel lift bridge over the Kaministiquia.

Old Timer Here.

Harry Evans, who during the early pioneer days of Prince Rupert, when it consisted of Knoxville, Vickersville and Rupert Road, was probably one of its best known characters, passed through the city yesterday morning on the Princess May en route to Skagway. "Fatty" Evans, who amongst his many other accomplishments, was a "speller" of no mean order, used to be seen at the G.T.P. wharf, in a uniform, that would have been the envy of the Lord High Admiral in "Pinafore," announcing the many excellencies of the historic Calumet restaurant and hotel, to the crowds of incoming passengers on the boats. It is as a piano tuner, though, that Harry will go down to fame, his ability in this line being a matter of almost international knowledge. He will return in a week or two, to spend some time in Rupert, in the prosecution of his calling.

to the scheme, and it was ultimately left for the city solicitor to look into and report to the Council later.

In the matter of the city's relations with the Prince Rupert Hydro-Electric Co., Ltd., the following motion was carried, the proposer being Alderman Clayton. "That the city would be prepared to buy power at the city gates, but not for the company to come within the city."

With very slight difference the council were unanimous in the opinion that this was the only wise and safe course to pursue. Alderman Clayton said that even if the city had to pay a little more for operation if controlled by the city, the money went into the pockets of the citizens. Experiences of other cities was in favor of holding on to civic franchises.

Alderman Douglas agreed with this entirely. Ald. Morrissey was not in favor of turning the company down too harshly.

Ald. Montgomery did not think it necessary to let the company in here in order to cut off Port Edward.

Alderman Kerr was not wildly enthusiastic over what he deemed Alderman Morrissey's idea the company were a parcel of public philanthropists. It was the first charity company he had ever come across.

The mayor took very little part in the debate beyond stating emphatically that he would have nothing to do with any discussion other than the one of the city purchasing the power at the city gates.

In Victoria the Canadian Bank of Commerce have opened a branch at Oak Bay, the first bank in that municipality.
