Many people showing blackened eyes and bruised faces as a result of the disturbance.

MONTREAL INVITES FAMOUS SCIENTIST

(Special to The Daily News.) Montreal, March 5.—The city authorities have extended an invitation to Dr. Friedman, the celebrated German scientist, to come to the city and test his cure for tuberculosis.

CANADIAN NORTHERN AND ELECTRIC POWER

Company Applying for Water Rights at Various Places Along the Line.

New Westminster, March 5.—The Canadian Northern Pacific Railway Company are making preparations for the future electrification of their line in the Fraser Valley should the need arise. They are making application for water rights at various points along the line where electric power may be generated at comparatively small cost.

They are applying for the right to erect two dams near the point where the Nicolum River empties into the Coquahalla River just east of Hope. It is proposed to erect a hydro-electric plant there capable of developing 30,000 horse power. It is also proposed to drive a two-mile tunnel through the divide to the Sumalow River and to divert this stream from the Skagit to the Nicolum River.

NEW SERVICE RIFLE FOR BRITISH TROOPS

If Successful, Will Render the Lee-Enfield Rifle Obsolete.

London, March 5.—The British War Office is experimenting with a new service rifle, which, if it proves successful, will render the Lee-Enfield practically obsolete. The new rifle is automatic, but can be converted into a magazine loader or a single loader at will. It is strong enough to take a high velocity bullet.

One thousand rifles of the pattern are now in the hands of the government. If the new arm is successful the Lee-Enfield will be thrown away.

ROWING CLUB HAS SPLENDID IDEALS

Hope to Fit Up the Upper Deck of Hazelton as a Comfortable Club House—Meeting To-night.

This evening at 8:45 a general meeting of the members of the Prince Rupert Rowing and Yachting Club will be held at the Court House when important business in connection with the program for the coming season will be discussed. This club, which was started by a few enthusiasts during the early days of Prince Rupert's history, got down to business last year and through the energy and enterprise of a number of the members put its affairs into good shape, and the institution upon a firm and substantial basis. The old river boat Hazelton was purchased and thoroughly overhauled and refitted for use as a boat and club house, and anchored on the waterfront between the government wharf and the Rupert Marine Iron Works. Here members are able to keep their boats and canoes, an excellent floating slip being available for launching purposes. The club secured a four oar coxless racing shell which was used by a large number of the members many of whom possess great proficiency in the aquatic art.

This coming year it is hoped to greatly increase the membership of the club when steps will be taken if possible to fit up the upper part of the hulk as a club house where members and visitors will be able to meet and enjoy the many pleasures of the waterfront with all the privacy of a house boat. Situated as Prince Rupert is upon one of the finest natural harbors in the world, and dependent largely at the present time for her outdoor amusement upon aquatic exercises, it is incumbent upon everyone who has the interests of the city at heart to do everything to support this club. (Special to The Daily News.) Montreal, March 5.—All this morning there was a run on the City District Bank, which has thirteen offices in this city, for some unknown reason. The demands were all met promptly and by noon the excitement was all over.

FRANK ETTOR, I. W. W. LEADER, TURNED BACK

Authorities Classed Him as Anarchistic Agitator and Refused Him Entry.

Vancouver, March 5.—Those who had been expecting to hear addresses in Victoria, Nanaimo and Vancouver by Frank Etor, I. W. W. organizer from Seattle, will be disappointed, unless Mr. Etor gets special permission from Ottawa to enter Canada.

Etor, who was booked for addresses at the above mentioned places, attempted to enter Canada at White Rock on Saturday night. He was put through the usual examination accorded immigrants and his answers to questions were such as to cause the Canadian authorities at White Rock to class him as an undesirable and refuse him entry. He accordingly went back to Seattle. All immigration offices on the Canadian boundary and coast will be notified and if Mr. Etor, without special permission from Ottawa, tries again to enter Canada, he will be liable to arrest and imprisonment.

His case was no different from dozens of others who are turned back every week and the authorities had no special orders to deal with him. His description of himself caused the authorities to class him as an anarchistic agitator and therefore an undesirable.

NO ROYAL TRIPS ABROAD THIS YEAR

King and Queen Will Reside at Buckingham Palace Until July.

London, March 5.—Not for many years has the court passed so much time in London as it will pass this summer. Except for short absences at Easter and Whitsuntide, the King and Queen will reside at Buckingham Palace until July when they will go to Lancashire. When they go to Windsor at Whitsuntide, they will not occupy the castle but will take up their quarters at their old and favorite residence, Frogmore Cottage. Some time in the spring, the King will also take a brief yachting holiday and go to Plymouth to look around the drydock. It is now certain that there will be no foreign trips this year, not even to Paris.

King George, whose patronage of horse-racing is well known, has announced his intention of attending the Goodwood meeting in August, during which time he will be the guest of the Duke of Richmond and Gordon at Goodwood House. Thence he will proceed direct to Cowes for the yachting week. The Queen will not accompany the King to Goodwood, but will go to Cowes later. The Prince of Wales at the close of Oxford Lent term will rejoin the King and Queen at Buckingham Palace and spend part of his vacation at Sandringham.

NEWFOUNDLAND WILL AID IN DEFENCE OF EMPIRE

IS OPENING NEGOTIATIONS WITH IMPERIAL AUTHORITIES—DUTIES REPEALED ON TEA, SUGAR AND SALTED MEATS

(Special to The Daily News.) St. John's, N. F., March 5.—With a view of participating in the naval defence of the British Empire the Newfoundland government will open negotiations with the Imperial authorities, according to an announcement made to-day by the new Governor. The latter also gave notice of abrogation of duty on tea, sugar and salted meats, as a result of which the revenue will be reduced by \$400,000 annually.

WILL NOT OCCUR AGAIN SAYS ALD. BULLOCK - WEBSTER

SECRETARY OF THE AGRICULTURAL SOCIETY REGRETS McRAE BROS. AND THE NEWS WERE NOT ASKED FOR TENDERS

To the Editor of the Daily News: Dear Sir,—It is with great regret that I read your editorial in the issue of March 4th, in which you have associated the two ideas of the Agricultural Association and politics.

So far every effort has been made by both myself and those who have worked so strenuously to make the Association the success which it ought to be, and will be, to keep it absolutely outside the sphere and influence of politics.

This will be obvious to any fair-minded man who has followed the matter carefully.

From the very inception there have been prominent men in both political parties associated with the early formation of the Agricultural Society.

The matter to which you refer, viz., the printing of the by-laws of the association was brought up by the mayor at the Council meeting on Monday night as an argument in extenuation of his own actions.

Let me here point out two facts: Firstly, that the Mayor who is such a stickler for correct procedure should not have

GIGANTIC SMOKESTACK TO BE ERECTED AT DRY DOCK

WILL TOWER 183 FEET HIGH AND IS LIKELY TO BE COMPLETED THIS PRESENT YEAR—MANY CONTRACTS HAVE BEEN LET.

Authoritative information is to hand as to the letting of important contracts in connection with the \$3,000,000 G. T. P. drydock, that is in course of construction at Hays Cove. The large amount of work that has so far been done is but a comparatively small part of this gigantic undertaking. Up to the present the laying out and partial completion of the area to be used for wharves, waterfront, yards, etc., upon which the various buildings, workshops and power houses will be located is all that has so far been undertaken. This summer a start will be made upon the superstructure and before the end of the year there will be a considerable difference in the appearance of the works in progress at Hays Cove.

The contract for all the steel to be used in the construction of this great drydock has been let to the United States Steel Products Co. The Dominion Iron and Steel Co., who were given an opportunity to tender for the supply of steel, were unable to do so on account of the vast amount of work they have already on hand. For this reason the contract had perforce to be given to the American corporation.

The Wineland Building and Engineering Co. of Vancouver have secured the contract for the construction of the re-inforced concrete power house as well as the superstructure of all the buildings.

For a very important feature of the work, the erection of a smoke stack 183 feet in height, the greatest specialists and experts in this line of work have been secured, the Webber Chimney Co. of Chicago. A contract has been let to them, and it is understood that they are already making arrangements to get material on the ground. It is likely this work will be completed before the Fall. This firm have completed several contracts in this line in the province already, the work being of the most satisfactory nature.

The G. T. P. Railway Co. are now calling for tenders for the construction of 12 pontoons for

WILL NOT DO
IT AGAIN.

Ald. Bullock-Webster, secretary of the Northern B. C.
Agricultural and Industrial Association has promised to be a
good little boy in future. In his letter in to-day's "News"
in regard to the printing of the Assn. by-laws his only excuse
for not asking McRae Bros., Ltd., and the "News" to tender
for the work is that the five hundred copies printed by A. O.
Franks (who runs the "Empire" job plant) for \$17.50 were
"said by persons qualified to judge to be excellent value for
the low price paid." While he expresses regret for his error
and promises not to make the same mistake again, Mr.
Bullock-Webster goes out of his way to show his venom for
the "News." In publicly expressing his appreciation of the
support given by McRae Bros. to the Agricultural Society (to
which the "News" takes no exception) it is rather strongly
implied that the "News" has not given assistance to the
organization. The Secretary is either adopting dangerous
tactics or he is at least most undiplomatic. Mr. Bullock-Webster
entirely mistakes the motive of the "News" in its criticism
of his action when he refers to "tail

twisting." The "News" was
not criticising Mr. Bullock-Webster as a private citizen
nor Ald. Bullock-Webster as a member of the council. Its
criticism was directed at the Secretary of the Agricultural
Society for adopting methods which were not only unfair but
which, if followed out, will bring the association to certain
ruin.


Last Sunday night at Mount

BRITISH RAILWAYMEN
ON VERGE OF STRIKE

Insist on Reinstatement of Dis-
missed Guard—United and
Determined as in 1911.

London, March 5.—Mass meet-
ings of railwaymen held yester-
day in London, Leeds and Shef-
field, Stockton and other centres
demanded by resolution the im-
mediate and unconditional reinstat-
ement of Richardson, the
guard dismissed by the Midland
Railway. The alternative is a
general strike. Cautious and re-
sponsible union leaders declared
that, failing to secure justice for
the dismissal of the guard, they
will call a national stoppage of
work by all railway employees.
The crisis might come in a few
days.

As regards the unity and de-
termination of the men, the situ-
ation is expressed as "August,
1911, over again."

The case for the Midland Rail-
way Company is stated fully in an
official memorandum. Rich-
ardson's attitude is said to have
been offensive to his superior
officers. It is held that oral in-
structions are essential, that no
Board of Trade regulation is con-
travened and that all guards have
known since 1909 that, by the
train control system, they are to
take oral orders from the con-
trol officers.

The joint committee of the
men's union will meet today.

APPROPRIATION IS SET AT \$2,250,000

Vancouver Hotel of C. P. R. Will be Larger than First Planned

Vancouver, March 4.—The Canadian Pacific Railway Company has increased the appropriation for the new Vancouver hotel to two and a quarter millions. The original appropriation, announced by Sir Thomas Shaughnessy when on the coast last year, was for the amount of \$1,500,000 so that the amount has been increased by nearly one million. Mr. Skene, who is the contractor for the hotel, and who built the Empress at Victoria at a cost of \$1,600,000, states that material changes have been made in the plans, the proposal now being to have the central tower sixteen stories high, with two ten storey wings, and a roof garden on top. Three hundred and fifty thousand dollars have so far been spent on the new power plant and the erection of a temporary wing on the rear, on Robson street. The wing will be turned into a high class rooming house when the new main buildings on Georgia Street are completed.

PRINCE DETERMINED TO BECOME A PIPER

London, March 5.—The students of Magdalen College were wrong in thinking that when the Prince of Wales took to learning the bagpipes, that he would soon get tired of it and give it up. They could not understand what pleasure he had in blowing such "unearthly noises." Others laughed at those who tried to emulate the prince and learn the bagpipes too. They have given up—they had to, to escape certain consequences. But they were wrong about the prince, who is said to be more than ever determined to become a piper.

BEST TEAM, SAYS LACROSSE MAGNATE

Con Jones, Returned from Two Months' Trip, Says Vancouver Will Be Strong.

Vancouver, March 5.—"Prospects for a first-class lacrosse team for Vancouver this season are very bright," remarked Con Jones, the local lacrosse magnate, when he returned this morning from a two months' jaunt around the continent that included a side trip to the Panama Canal. Con has been in California for the past two weeks. He spent some time in Toronto, Montreal and Ottawa, and then went to New York. From there he visited New Orleans, and then took a steamer trip to the Atlantic of the Panama Canal. "I had a long talk with the prominent men in the Big Four while in the east," remarked the Vancouver boss, "and I think we will eventually be able to get together on the proposed national commission for lacrosse. I have plenty of star players in view, and fixed up a number of deals while in the east that will ensure Vancouver having the best team it ever had. We are going after the Minto cup again this year, and we propose to have it back here next September."

HYLAND AFTER BAYLEY

Fighting Dick Wants to Get Match with Canadian Champion.

Calgary, March 6.—Harry Lombard, the oldtime Chicago lightweight boxer, who is now located in Edmonton, has assumed the management of Fighting Dick Hyland and wants to get a match for him with Joe Bayley or some other coast boxer. There will be no boxing around Edmonton until May 24, when Joe Bayley and Kid Scaler will come together and Harry wants to get some work for Hyland in the meantime. Lombard says he will bet \$1000 on Hyland against Bayley in a straight rules mixup with five-ounce gloves. Hyland boxed Scaler on six days' notice and reduced 12 pounds in that time, only to lose the decision. The worst he should have received was a draw. "I think Bayley is a great little fighter," writes Lombard, who is well known to coast fight fans, having performed at North Vancouver on sundry occasions. "But Hyland is a better man and I am willing to gamble that way."

Y. W. C. A. Campaign.

New Westminster, March 5.—The campaign for funds to provide for the establishment of a local Y. W. C. A. commenced in the city this morning. At a meeting of the Women's Council held on Saturday it was decided to endeavor to raise \$1000 by March 15 and with the proceeds to rent a house and furnish it. This will be used as the Y. W. C. A. headquarters until funds are obtained. An effort will be made to collect \$1 from each lady.

FORGED MORTGAGES, TITLES AND CHEQUES

Money Paid Out on Worthless Papers at Edmonton.

Edmonton, March 5.—Information now in the hands of the police here indicates that a wave of forgery is sweeping over the province and that a number of important documents have been forged in Edmonton. A few days ago \$500 was secured from the Royal Bank's branch and at LaCombe and Stettler by means of clumsily forged land titles. It appears that the title used for each bank had reference to the same quarter section of land southeast of Edmonton. A few days ago \$1000 was obtained from Ewing & Harvie on forged mortgages. In neither case has the culprit been captured. Last week two neatly executed forged cheques were passed on the Merchants Bank here and \$6300 was paid out. The signature was that of a construction firm working with headquarters here. On the charge of committing these forgeries Gustav Berg or Gustave Blanc, as he is known here, was arrested in Calgary yesterday.

ON BETTER TERMS

Name of Federal Appointee Has Been Sent to Sir Richard McBride

Victoria March 5.—It is understood that the name of the Dominion Government's appointee on the royal commission which is to investigate the financial relations between this province and the federal authority (better known as better terms commission) has been communicated by Mr. Borden to the provincial prime minister and will be announced by Sir Richard McBride in about a fortnight when also the province's representative on this important tribunal will be named. According to expectations the greater part of the commission's work will be performed in this province, sittings being held also at Ottawa and London.

AN OPEN LETTER.

To the Editor News:

Permit me, as a member of the Commonwealth and more particularly as one of a small band of Ontario men who were unfortunate enough to have been present Sunday evening at gospel meeting held in the Empress Theatre, to publicly thank you for your editorial criticisms on the sermon of the reverend Mr. Kerr Under the cloak of a Christian minister it is lamentable that such personal references should be permitted to reach the public ear.

That the parson was honest in his convictions there may be many who will generously admit, but the incalculable injury done to the plastic mind of the earnest seeker after truth who came there for instruction, cannot be estimated in its far reaching effect.

I am willing to go further and hold it nothing short of crime, however unintentional, for any man from the pulpit of any temple of any religion on earth to fling any unkind and unchristian statement at a congregation—statements in any way liable to scan the sensitive surface of the soul. I say sensitive surface of the soul, for what soul is more sensitive and receptive than that of the one who, filled with vague misgivings and doubts of the traditions of the cradle, comes blind and helpless to the shrine of Christianity, seeking he knows not what—anything to allay the ocean of blinding discouragement and disconcert with which he finds himself surrounded whenever he attempts to fathom the unknown.

The world is teeming with weary pilgrims, surrounded by great foaming waves—waves that roll and buffet them without mercy—without interval—without rest, and with eyes strained to the utmost tension, looking anxiously, looking earnestly for a lighthouse. What wonder then when landed there they become receptive, prostrate themselves at the foot of the shrine and drink of its waters.

Be these waters ever so pure and life-giving, of what avail it should the minister drop poison in the cup? "Watchman, what of the night? The myriad foe in close array comes on to try our might. A night assault! And if thy trump mistake a single sound I'll hang upon these battlements the watchman on his round!" So much for the man who dares to cast hidden innuendoes from the pulpit, throw a bunch of men under a ban, and possibly drive a single soul from the feet of Christ. Dit it ever occur to Mr. Kerr, when in his fanatical conceit he answers—"No one knew to whom I referred." Did it ever occur to him that no one knew to whom he did not refer?

Now a word as to the cause of this tempest: Christ said—"He that is without sin among you let him first cast a stone at her." From Christ to Plato and down the ages to the brainy men of today, all of them pity her, many of them would save her, but none of them cast stones at her. She is under the feet of the world and deserves our pity, not our condemnation.

It was not my desire, nor is it my intention, to enter into a theological discussion. Just a word: In his address to the envoys of Rome Spartacus said—"See you yon rivulet, high on the mountainside? Slenderly it winds, but soon is swelled by others meeting it, until a torrent, terrible and strong, it sweeps to the sea!"

So, in my humble opinion, would the religion of Christ advance, if the world could but eliminate wild shooting in the ranks of its ministry, redlights, calciums and hippodroming. VASSAL.
