ALL AMERICANS ARE WARNED TO LEAVE MEXICO

UNITED STATES MOVING HER ATLANTIC FLEET TO PACIFIC, FEARING TROUBLE WITH JAPAN

BRYAN'S FAILURE TO IMPRESS THE CALIFORNIA LEGISLATURE

PRESIDENT NOW FEARS TROUBLE WITH JAPAN AND IS PREPARING TO SEND THE ATLANTIC FLEET TO PROTECT THE PACIFIC COAST

(Special to The Daily News.)
New York, May 2—A special dispatch from Washington is published in Hearst's newspaper as New York American, to the effect that the United States government is preparing to move its Atlantic fleet to the Pacific, bringing a possible attack upon the Pacific coast in the event of serious trouble with Japan over the California Alien Land Act.

Bryan's Mission Failed
Sacramento, May 2—Hon. W. Bryan, Secretary of State, left tonight for Washington, his mission having failed.

California, in the fullness of its right as a state, may enact a law barring Orientals from membership of land, but such action would be against the earnest wish of President Wilson, and the national administration. This was the substance of the message he delivered as the personal representative of the President and as Secretary of State. It was delivered at a secret conference attended only by Governor Johnson, Lieutenant-Governor Wallace and the one hundred and twenty members of the Legislature.

"I have said all that I have had to say," announced the senator, towards the close of the meeting. He added that any further advances to the legislature would require special authorization from Washington.

When asked whether the arguments of the secretary of state had changed his opinion on the matter, Governor Johnson replied one word, "No."

Stand Taken by Governor.
The position on the passage of the alien land act taken by

Governor Johnson and stated in reply to Secretary of State Bryan may be summed up as follows:

"The bill proposed for passage by the California legislature can call forth no just criticism from the national administration, nor from any foreign nation.

"Here in California it is not a question of whether the Japanese government takes offence at what we do, but whether we give that government just cause for offence. I do not believe that the proposed law prohibiting ownership by aliens who are ineligible to citizenship gives the Japanese just cause for taking offence."

Bryan in Conclusion.
Toward the close of the conference Mr. Bryan rose and said: "I have said all that I came to say. I have answered all of the questions that have been asked, and my mission here is ended whenever you may feel that you have conferred as much as you like with the representative of the President.

"I came with no programme. Simply to confer. I have presented the President's views as I understand them. I have communicated to him this afternoon several propositions after listening to what you have had to say. Tonight I shall submit to him the further questions you have asked me, calling attention to the statutes of Washington and Arizona, and I shall be prepared tomorrow, I hope, to give you his answer."

Those who expected Secretary Bryan to expound a new theory of states rights were disappointed, as were those who expected rumors of war or other sinister predictions.

ENEMIES OF EMPIRE OPPOSE RECIPROCITY

London Newspaper in Discussing Effect of Centennial of Peace Celebration

London, April 29—The Daily News and Leader (Liberal) editorially discussing the peace centenary celebration between England and the United States, says: "Next year's commemoration will bring this country into complete sympathy not only with the United States but with Canada. "Canada, it is important to remember, has as profound an interest in Anglo-American peace as we have. Her borders run for thousands of miles side by side with those of the United States and not a fort or a gun or a sentry serves to mark the fact. There is no greater testimony to the triumph of civilized relationship than this.

"They, in this country, are the greatest enemies, not of peace only, but of the interests of Canada and of the empire who seek to promote artificial checks to free commercial intercourse of these neighboring peoples. We have nothing to lose and everything to gain by the continuance and development of the friendliest relations between the United States and Canada."

"WAR, REAL WAR," THE SUFFRAGETTE SLOGAN

Most Militant of All Returning from Europe Arrested as Soon as She Landed.

(Special to The Daily News.)

London, May 2.—"From now on it will be war, real war." This was the ultimatum delivered by the militant suffragette leaders at their meeting last night. Undaunted by the capture of their stronghold by the police on Wednesday night they declared their determination to carry on the fight until victory is won. They were not disturbed by the police at this meeting.

But it appears to be a real war with the authorities also. They still hold possession of the headquarters of the militants and of the leaders whom they arrested, and last night added to the number awaiting trial by the arrest of Miss Annie Kenny, one of the most militant of the suffragettes. She was returning from the continent and the arrest was made directly she set foot on British soil.

Berlin, April 29.—The Berlin Neueste Nachrichten, one of the Chauvinist papers, whose contention with armament industries was recently scored in the Reichstag debates, naturally falls foul of Secretary Bryan for his international peace proposals, saying: "Mr. Bryan is in a great hurry to become the international laughing stock. But we must flatly decline to have as guidance for our policy the sickly agitator's twaddle with which he has been tickling the ignorant, conceited Yankee brains. This chattering demagogue will please be good enough to mind his own business and not worry about improving the world. Otherwise he will show very little sense of the responsibility attaching to the office with which he has been rewarded for his election activities."

BRYCE BIDS FAREWELL TO THE PEOPLE OF THE UNITED STATES

FRIENDSHIP OF THE NATIONS EMPHASIZED IN HIS SPEECH BEFORE PILGRIMS' SOCIETY.

New York, April 26.—Rt. Hon. James Bryce said farewell to the American people tonight at a dinner given here in his honor by a Pilgrims' Society of the United States. After six years as British ambassador to this country, Mr. Bryce will sail for home from San Francisco on May 3, via the Orient. Sir Cecil Spring-Rice, his successor, will arrive in New York early next week.

Many noted men sat at the guest table with Ambassador Bryce, who in his speech emphasized the relations of friendship existing between his great country and the United States. The ambassador sat at the right of Mr. Joseph H. Choate, former American ambassador to Great Britain, who is president of the Pilgrim Society. At Mr. Choate's left was Mr. Walter Hines Page, present American ambassador.

Mr. Bryce did not touch directly upon any issue now pending between the American and British governments. This statement, however, was regarded as significant: "With good will and with a recognition that one of any nation's highest assets is that sense of national honor which will make it live up to its international obligations, all questions between nations can be adjusted, and I am sure that any question between your country and mine will be adjusted in that way."

MEXICO AGAIN PREPARING FOR NEW SANGUINARY REVOLUTION

PROVISIONAL GOVERNMENT SPLIT INTO FACTIONS — ALL AMERICANS NOTIFIED TO LEAVE COUNTRY WHILE THE GOING IS GOOD

(Special to The Daily News.)
Mexico City, May 2—It is reported on the best of authority that another revolution in this republic is pending and liable to break out at any moment. Orders have been issued by the Federal Government that all Americans must leave the country while there is still time to make rail connections with the coast. The northern constitutionalists are about to advance on Mexico City and take advantage of the friction that now exists in the provisional government.

Washington, April 29—A rapidly growing situation in Mexico City, fraught with friction between the Huerta and Diaz factions of the provisional government, is reported in confidential advices, and these reports are augmented by agents of the Carranza constitutionalists arriving here. Robert Pesquiera, a member of the Mexican House of Deputies, arrived here today to succeed Gonzales Gante as confidential agent of the Carranza forces. Gante has been assigned to a special mission, the nature of which is not disclosed but it is believed he is going to Europe.

Reports of the situation from Mexico City confirm earlier advices of the tenacity of the relations of Diaz to Huerta. Between the two officials practically all government forces in the federal district have been divided in two armed camps. Huerta has added to the infantry at the National Palace and Diaz has encamped much of the artillery on his estate, Hacienda del Cristo, about 30 miles away. Senor Mondragon, minister of war, is in virtual possession of the citadel where other artillery are quartered.

LOTS OF EASY MONEY FOR NEW HAZELTON.

In their appropriations for this year the provincial government allowed the tremendous sum of \$400 for constructing sidewalks in New Hazelton, reports the Omineca Herald. The money market is pretty tight, so four hundred dollars is some money. It will nearly build a couple of street crossings. The Citizens' Association should pass a special vote of thanks to the provincial government and the local member.

RUPERT CONGRATULATED BY VICTORIA COLONIST.

In a recent editorial headed "Prince Rupert's Elevator," the Victoria Colonist states that "the announcement of Mr. J. E. Dalrymple, vice president of the Grand Trunk Pacific, of intention to erect at once at Prince Rupert a grain elevator of ten million bushels capacity is of exceptional interest and importance. We congratulate the people of the western terminus of the new transcontinental on this new assurance of a great future for their city, and feel that the news will serve as an added stimulus to Victoria to expend further effort to see that similar facil-

ities for the handling of grain shall be established at this port.

But the announcement is of first rate importance in that it removes from the field of debate all question as to the practicability of the handling of grain cargoes via the Panama Canal. For ourselves, we have never had any doubt about the matter, but from time to time it has been hinted that such shipments would be found impracticable. This is now disposed of. And the decision of the company clears up another point—that is, in regard to the matter of the transcontinental lines hauling a considerable portion of the wheat of the prairie provinces to the Pacific Coast."

The opposition is graciously permitted to debate the closure resolution, but must not move any amendments. And this is Mr. Borden's idea of parliamentary government!

DEVELOPING BEAUTY SPOTS FOR PLEASURE OF TOURISTS

WHAT THE RAILWAY AND GOVERNMENT IS PLANNING JUST BEYOND THE ROCKIES TO STIMULATE SIGHT-SEEING TRAVEL

Edmonton, April 28.—After conferring with P. C. R. Hersey, Dominion parks commissioner, Colonel Maynard Rogers, recently appointed superintendent of Jasper Park, left the city last night for Canada's national playground. He will later be joined by the commissioner himself who will leave the city this evening.

Together they will arrange for the building of several thousand dollars worth of roads, the plans for which were arranged by Mr. Hervey during his recent visit to Ottawa. The roadmaking programme will include one from Fitzhugh to Pyramid Lake, which has already gained a reputation as being one of the loveliest spots in Jasper Park. Trails will also be opened to Punch Bowl Falls, the sight of which has called forth admiration from every one who has had the pleasure of seeing them.

The laying out of the township of Fitzhugh will also be another procedure that will command the commissioner's attention. Plots for the various buildings, both administrative and residential, will be laid out during this survey, and all buildings that will be later erected will be designed so as to be in keeping with their picturesque surroundings.

In addition to the massive hotel to be erected by the Grand Trunk Pacific Railway, T. Weiss of Minneapolis has made arrangements for the construction of a tourist house, modern in every detail, which will cost in the neighborhood of \$100,000.

It was stated this morning that application for lots in the township of Fitzhugh will neither be received or entertained until such time as the survey has been finally completed. It being gov-

ernment property the land will then be leased under various regulations.

A buffalo park in Jasper Park will also be located this year. It will be stocked with the finest specimens from the park at Wainwright. Plans are well under way at the present time in connection with the buffalo at Wainwright to divide them into four separate paddocks. This will be done for the purpose of scientifically handling the breeding buffalo.

THOUSAND MILES IN ONE DAY'S FLIGHT

French Aviator Crossed His Country from South to North, Landing in Holland.

Kullum, Holland, April 28.—A flight of more than 1,000 miles by aeroplane was completed here today by the French aviator Ernest Francois Guillaux. He made only two stops during his flight from Biarritz, in the extreme southwest of France, which he left yesterday morning, descending to replenish his fuel at Bordeaux and Villacoublay. The entire trip was made in a little more than twenty-two hours, the aviator leaving Biarritz at 4:22 a. m. Sunday and reaching this city before daybreak today.

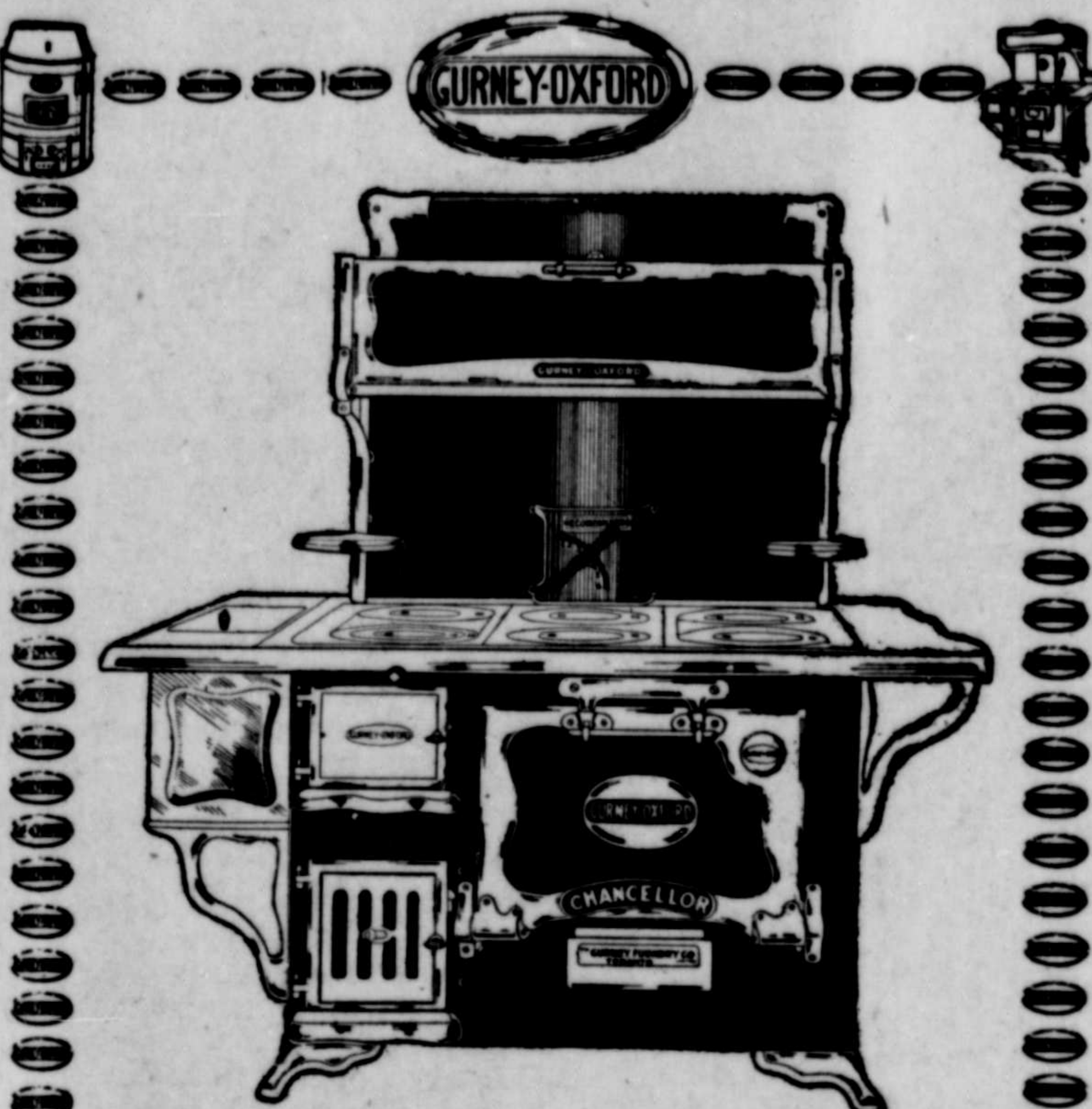

MONTENEGRO MAY HOLD SCUTARI FOR A TIME

Ambassadors Deem It Unadvisable to Proceed with Coercive Measures at Present.

(Special to The Daily News.) London, May 2.—At the meeting of ambassadors held yesterday afternoon for the purpose of considering Montenegro's contumacy in the matter of Scutari, there was a full discussion of the subject and it is understood the representatives of the powers considered it unnecessary, or at least unadvisable, to proceed with immediate measures to coerce Montenegro.

Russia Gives Warning.

Cettinje, May 2.—The Russian minister has presented the note of his government to Montenegro, urging an immediate compliance with the demands of the powers for the evacuation of Scutari. It is intimated that a policy of defiance will likely lead to the ruin of Montenegro.

KITKATLA WOMAN DIED AT HOSPITAL

Mrs. Alex. Scott, Died This Morning After Very Brief Illness.

Mrs. Emma Scott, admitted to the hospital about 5 o'clock last night, suffering from intestinal trouble, died at 8 o'clock this morning. Deceased, who was about 50 years of age, was a native of Kitkatla. She is survived by one son, Alex., who resides in the city, and a daughter living at Kitkatla. The remains are at E. L. Fisher's morgue. Alex. Scott left today for Kitkatla to confer with his sister in regard to the funeral arrangements.
