

## THIRTY-TWO LIVES LOST IN STEAMSHIP DISASTER

### FORTY-FIVE OF THE SURVIVORS ARE NOW COMING SOUTH ON THE STEAMER JEFFERSON

### CROWD LEFT HERE LAST NIGHT TO GO TO SHUSHANNA

ON WHARF LOOKED LIKE RE-ENACTMENT OF THE OLD KLONDIKE DAYS IN SEATTLE—MORE MOUNTED POLICE ON BOARD.

The excitement over the Shushanna gold strike is rising to a new heat. When the Princess Sophia went north last night it was as if a scene from Vancouver or Seattle in the old Klondike days was being re-enacted. The steamer was crowded with people who were determined to try their fortune at the diggings. A big crowd got on board their packs on their backs. The wharf was crowded with people who went to see the sight. It looked as if the whole town there.

### THREE PRINCE RUPERT MEN REPORTED AMONG SAVED

#### Number of Those Lost in Sinking of "State of California" is Now Placed at Thirty-Two--No News as Yet Concerning Miss Wilson

Telegrams announcing that D. R. O'Neill and Thormund Brown of this city were among the saved were received last evening by friends of these men in the city. Word has also been received at the government telegraph office that George O'Dell was among the saved. No news has yet been received of Miss Wilson, who was reported to be missing.

There were 130 passengers and a crew of 66 on board. The last report says that all but thirty-two were saved. Other reports put the number of lives lost at from twenty-five to thirty-eight.

Some of the passengers on board the State of California recorded in the Seattle office are Mr. and Mrs. John Van Delass, Los Angeles; Blanche Fridd and Marion Harlan, Portland, Ore.; Miss Alice T. Johnson, Vancouver.

**Thirty-two Lost.**  
Juneau, Aug. 18.—Thirty-two lives were lost when the steamer State of California sank in Gambier Bay. The vessel was in Stephens Passage when she hit an uncharted rock.

Lila Ward, the daughter of the assistant general manager of the Pacific Coast Steamship Company, was drowned, with her mother.

The State of California was one of the oldest vessels on the north Pacific Coast. She had been about forty-one years in service and was considered in her day one of the best steamers on the coast. She plied out of San Francisco for many years, and only during the last year or two entered the Alaska service.

The steamer was of 1,260 tons register and carried a crew of seventy-six men. The skipper, Captain T. H. Cann, was well known on the waterfront, waterfront, where he was very popular. His fate has not yet been learned.

### AUSTRALIA WANTS CONFERENCE CONCERNING PACIFIC SQUADRON

THE MINISTER OF COMMONWEALTH PRESENTS POLICY OF GOVERNMENT TO PARLIAMENT—DESIRES RECIPROCITY AMONG DOMINIONS

London, Aug. 14.—When parliament convened yesterday the prime minister, Hon. Joseph Chamberlain, outlined the policy of the imperial party. He advocated the best consideration of international reciprocity and the arbitration arising out of the imperial conference of 1909, which was an important bearing on the programme of the commonwealth and imperial interests in the Pacific.

It is suggested in the Liberal party that a conference on the subject is advisable at an early date and communications regarding the defence of the Pacific are being addressed to the naval authorities.

Meanwhile the government is adhering to Admiral Henson's defence scheme.

The prime minister declared that the government was opposed to the principle of preference to unionists where the public service was concerned, and intended abolishing it.

Mr. Cook intends to introduce a bill which will prohibit the arbitration court ordering preference to be given to unionists and which will, also, exempt rural workers from the operation of the arbitration act.

The prime minister further stated that the government will maintain the accepted protective policy and will leave tariff revision to an interstate commission, which will deal chiefly with the question from an industrial and commercial point of view, particularly as regards the effect of the tariff on the investment of capital.

#### The Worst Report.

The worst report received came yesterday evening. It has not been confirmed by other reports.

Victoria, Aug. 18—8.45 p.m.—Ketchikan reports that steamer City of California belonging to the Pacific Coast Steamship Co. struck an uncharted rock leaving Gambier Bay at 8.30 o'clock on Sunday morning. The steamer had been taking on freight at Cannery and was coming out on the southeastern shore of Admiralty Island when the accident occurred. The ship commenced to settle immediately and a terrific explosion blew up the deck and the ship disappeared from view three minutes after striking the rock. It is impossible to state

#### with any degree of certainty the number of people lost, although one report states that out of 170 passengers not more than thirty were saved. There seems to be no doubt but that the loss of life will be very heavy. Already ten bodies have been recovered.

It is reported that a large number of the crew were lost including one wireless operator and the fourth engineer.

J. H. Rogers, the local agent of the Pacific Coast Steamship Co., reports that nineteen persons took passage from Prince Rupert on the ill-fated steamer. Of these thirteen were first-class and six second class. Having sent in the passenger list to the head office

The steamer had just left the cannery in Gambier Bay, which is just below Juneau, when she struck a rock. This was at 8.38 Sunday morning. She immediately began to settle. As she went down the compression of air in her boilers caused an immense explosion, blowing up the upper decks. Between thirty and thirty-eight of those on board are reported to have been drowned.

### STATEMENT ABOUT EXPENSES OF JOURNEY CONTRARY TO FACT

MAYOR PATTULLO REMARKED ON CERTAIN MISREPRESENTATIONS CONCERNING HIS MISSION TO ENGLAND—ESTIMATES WERE PASSED.

"May I inquire as to the particulars of this item of \$5,000 for incidentals?" asked Alderman Bullock-Webster in the suavest of tones at the council meeting last evening. The council was considering such estimates for the year as remained in dispute after last meeting.

"In connection with this," said Mayor Pattullo, "I want to see that there is no more misunderstanding. The Empire newspaper has stated that the mayor's expenses on his trip to England were \$5,000. This is absolutely contrary to fact. I said that one of the items under the head of incidentals for which the sum of \$5,000 was asked was the cost of the journey of the city solicitor and myself to the east and to England. I have not yet had time since my return to total up the expenses of the trip, but I surmise that they amount to about \$4,000."

Alderman Maitland thought the council should have details as to the cost of the trip.

Alderman Dybhavn, seconded by Alderman Naden, moved that the clause be adopted. In reply to Alderman Maitland, it was pointed out by Alderman Naden that the council was now going over the estimates, not over the accounts, which would be considered on another occasion.

Alderman Bullock-Webster also questioned the amount set aside in the estimates for salaries. He thought that the work was getting less and the salaries getting bigger. He didn't see how there could be enough work at present to keep some of the officials busy.

Alderman Naden then pointed out that if the staff had been the right size last year there was something wrong somewhere, as the financial report was six months late in getting out.

The mayor thereupon pointed out that the accounts were in a very bad muddle last year. "Another year like last year," he said, "would have meant, beyond any doubt, government intervention to protect the credit of the city. By the end of this year, however, the finances of the city will be in as good a state as those of any private corporation."

Alderman Bullock-Webster also questioned the point relating to the unpaid accounts that were left over from last year.

One item was entered as being necessary to meet the deficit, the other to meet the debts left by last year's council. Alderman Bullock-Webster thought that these were only there for effect. He wanted to know if the item of

### CANADIAN TO OPPOSE SOLICITOR GENERAL

London, Aug. 19.—Harry Simon, K.C., of Toronto, late director of the Union Life Insurance Company, has been chosen as a candidate for the constituency of Northwest Manchester.

He will have as his opponent a member of the cabinet of the same name as himself, Sir John A. Simon, K.C., the solicitor-general. The latter has announced that he will give up his safe seat in Walthamstow to contest Manchester constituency because, as he says: "It will be a critical campaign for many causes which Liberals hold dear, and among the most important is free trade."

This intention, it is alleged in some quarters, is due to the desire of those radicals devoted to Premier Asquith, to lessen Lloyd George's influence in the cabinet. All of which goes to show that the Toronto man is in for a hot political battle.

DOMINION TO MAKE BIG SHOW AT FAIR

Her Exhibits at Panama Pacific Exposition Will Cost Five Hundred Thousand

Ottawa, Aug. 14—Canada's plans for participation in the Panama Pacific Exposition at San Francisco are yet in the formative stage, but the exhibit, it was learned today at the department of agriculture, will be of much the same lines as similar exhibitions elsewhere.

The natural resources of the country will of course be the basis of the showing to be made.

A year ago, Mr. William Hutchison, Dominion exhibition commissioner, went to San Francisco, on the instruction of Hon. Martin Burrell, Minister of Agriculture, and selected a site for the Canadian building. It is the intention to start construction work this fall. The structures and the expenditure in arranging and transporting the exhibits will cost probably half a million dollars.

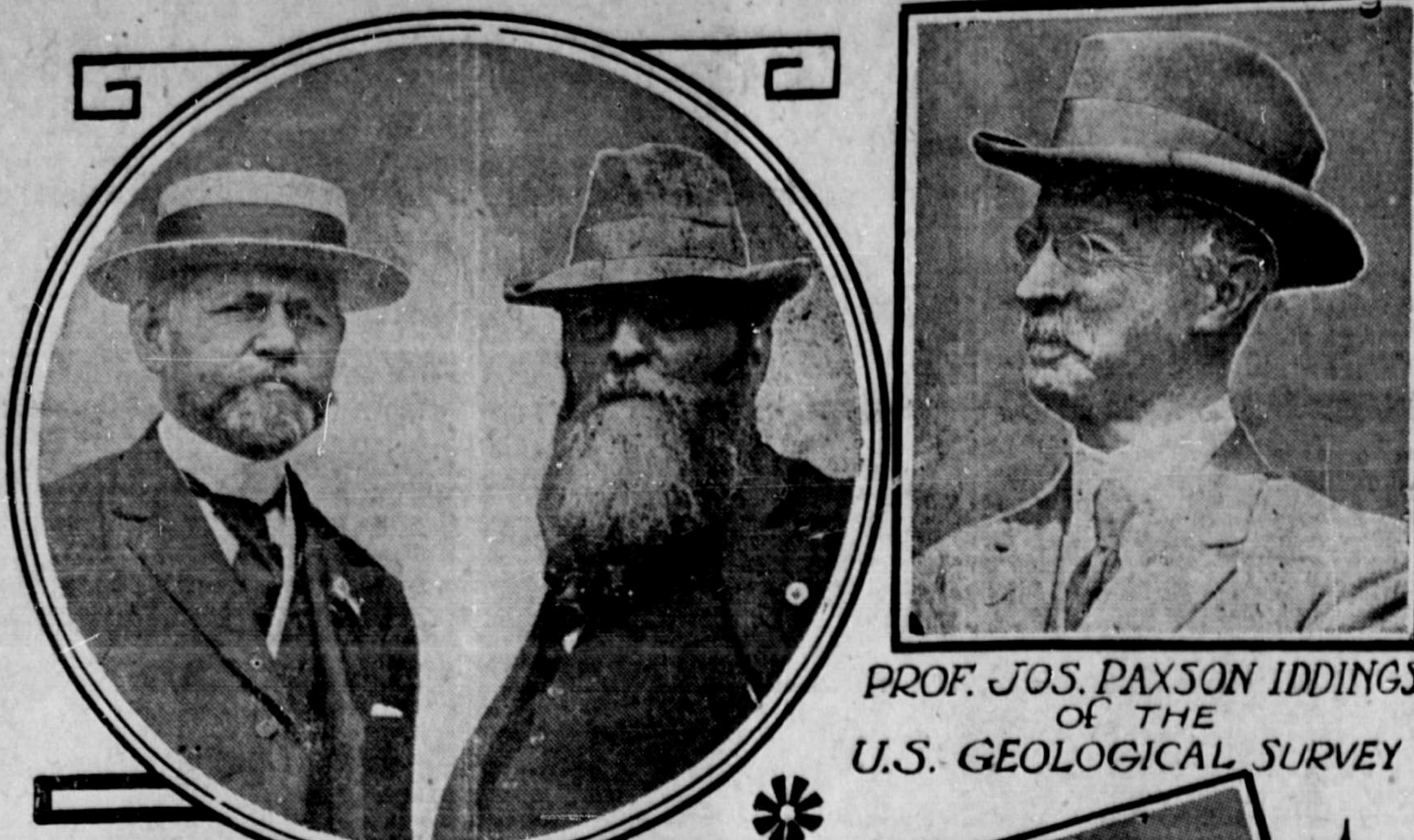

IN PICTURESQUE UNDRESS ARTIST LIVES IN FOREST

BOSTONIAN TRIES AN EXPERIMENT TO PROVE THAT HE CAN LIVE IN THE FORESTS OF MAINE JUST LIKE PRIMITIVE MAN.

Boston, Aug. 14.—Joseph Knowles, a Boston artist, has begun a remarkable experiment to prove that he can live in the Maine forests, twenty miles from a settlement, just as did prehistoric man. He will discard all clothing, will make the woodland furnish his food and shelter and will defend himself from animals or other foes only with the aid of his bare hands or with such weapons as he may furnish with them.

For two months he will make his home in the depths of the virgin forest that surrounds Big Sencer Lake. Twice a week he will go to the borders of the forest to leave communications, inscribed on birch bark, for his friends. He began his life in the woods on August 4th, and word of the strange experiment has just been brought here by a guide who accompanied him to the place where he left civilization behind.

Knowles is 44 years of age, has never married and has always lived a life of adventure. He is one of the few white men who have mastered the art of making fire by rubbing sticks. That accomplishment, he says, is all that is needed for a life in the open by a man of his robust health.

Guides who are familiar with Knowles' plan say he can accomplish the feat he has planned. They say the methods he has worked out to gain food and shelter are practical and that with his knowledge of the forests he will suffer little from the life.

While he is in the woods Knowles will grind pulp on the

rocks and press it on birch bark, thus making a paper on which he can depict the wild life of the forest. He will manufacture his water colors from the berries and roots and brushes from the skins and tails of wild animals.

FOUND AMUSEMENT BY HAVING AN EGG FIGHT

Two Boys Who Broke Into Freight Cars Get Severe Reprimand.

Ed. and Fred Head, two boys about 8 or 9 years of age, received a severe reprimand from the police magistrate this morning for their misconduct. They were found by the police to have broken into a G. T. P. freight car and smashed a number of eggs. They are not thought to have taken the eggs home to eat, but were simply throwing them at each other and smashing them in a spirit of mischief. As they were so young the police magistrate let them off this time with a warning but said that if a member of the police force would call regular on their parents for some time to come to see that the lads were being kept at home.

The police are on the lookout for other youngsters who are damaging property in this fashion.

FOUGHT WAR AGAIN ON LINER PANONIA

Greeks, Servians, Bulgarians and Turks Fight in Steerage on Atlantic.

New York, Aug. 14.—Officers of the Cunard liner Panonia, which arrived here from Trieste, report that a miniature Balkan war occurred almost continuously during the twenty-six days' voyage. Among the steerage passengers were several hundred ex-volunteers, Greeks, Servians, Bulgarians and Turks, who were returning to this country after taking part in the Balkan war. Frequent riots between these hostile factions in the first few days resulted in several combatants going to the sick bay with severe stab wounds.

Captain Capper thereupon ordered a general disarming, but the fighting continued with whatever missiles were at hand. The nationalities were separated into groups, but on meeting for meals the battle was resumed.

As a precautionary measure the stewards removed the knives and forks from the tables, all the steerage passengers of whom there were 1,421, being obliged to eat with spoons.

It is stated that the women in the warring camps fought as fiercely as the men.

THE NEW ORGAN

"Daily Telegraph" Started Off Very Well.

The first issue of the new Liberal paper in Montreal, the Daily Telegraph, was a great success. The presses were completely overtaxed, and the management was obliged to ask contemporaries to aid in printing the editions. It was the greatest initial success in Canadian journalism.—Canadian Mail.

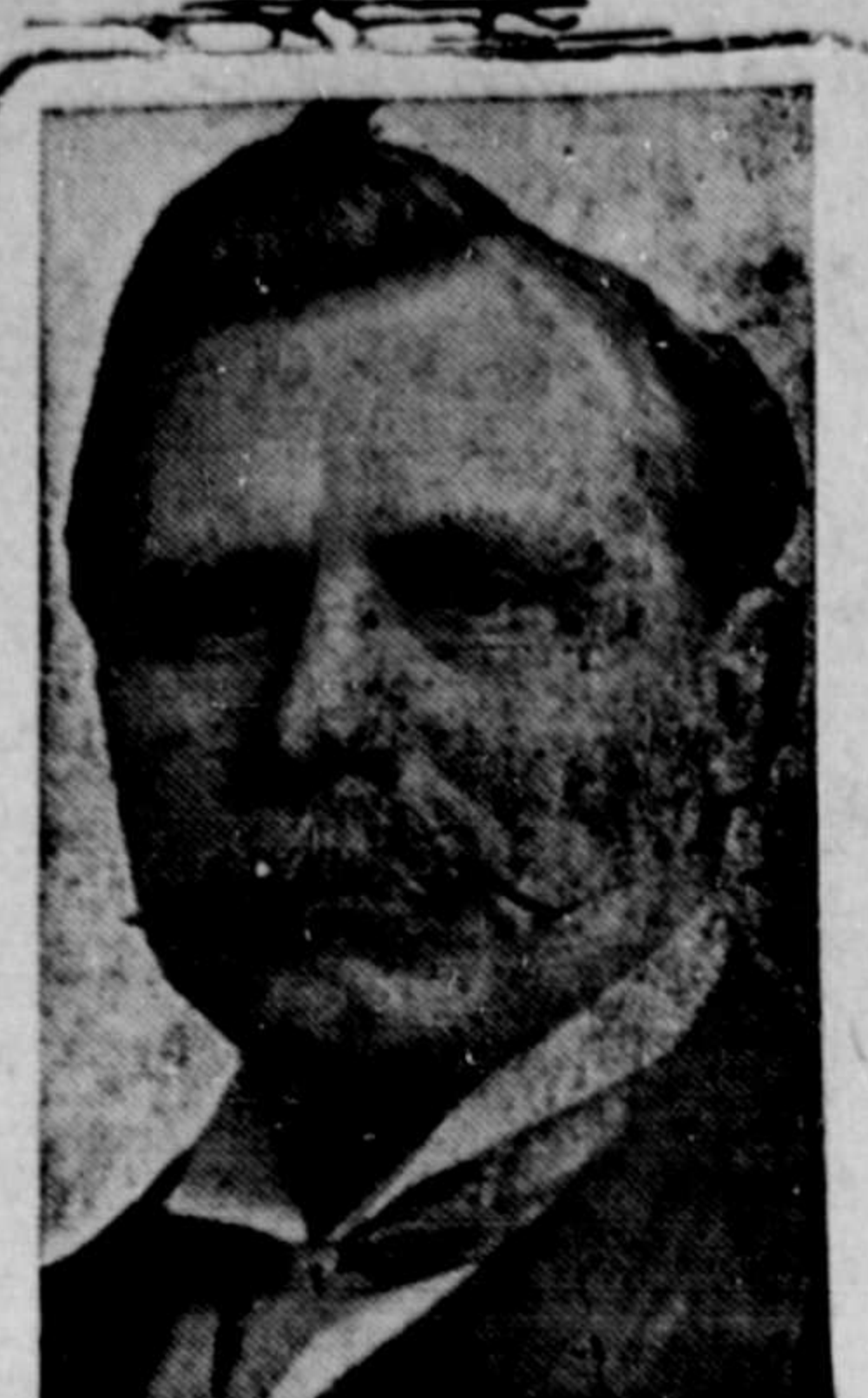
FIVE THOUSAND MILE ROAD

unpaid taxes, which would affect this, was not existing when the present council was elected.

"These items are certainly entered for effect," said Mayor Pattullo. "They are there for the effect of showing that these sums have to be paid."

The statement showed a total overdraft of \$30,000 at the end of 1912. There were also outstanding accounts which had to be paid amounting to \$14,000. In addition, about \$11,000 had to be returned to the telephone account. This made the \$55,000 of debt mentioned as left over by last year's administration.

The estimates were finally all passed and also the bylaw which fixes the rate for the year at 16.90, or, with the rebates, 14.40 mills.

YET MORE SUSPICIONS CONCERNING JAP SHIP

What Cargo Did She Bring From Japan to This Coast?

It is reported that the crew of the Japanese steamer Kinkasa Maru were engaged all night in loading ballast for the trip to New Westminster. The officers of the vessel count on weighing anchor this afternoon.

This work, done by the crew last night, has caused more rumors to circulate concerning the purpose of the vessel in coming to these coasts. The question is being asked, if she is now shipping ballast for Vancouver what did she have aboard on her trip from Japan?

Among the officers of the vessel are former naval men who served in the Russo-Japanese war. The captain, whose name is Koga, has been before this in vessels coming to the British Columbia coast.

As the boat stopped overnight very close to Cape Chacon, off the south end of Prince of Wales Island, various suspicions are afloat as to her purpose in going there. Many people connect her trip with the smuggling of Orientals into this province or Alaska.

RACED TRAIN

Aviator in Monoplane Was Victor in Contest.

Washington, D. C., Aug. 14.—C. Marvin Wood, the American aviator, attempted a non-stop race in his monoplane with a train from New York to Washington and thence to Fort Myer, Va., for exhibition flights. He reached his destination late in the afternoon after he had been compelled to interrupt his flight on a farm near Gaithersburg, Md., sixteen miles from Washington. Wood won his race with the train, making the landing at Gaithersburg at one minute after 9 o'clock, forty minutes before the train rolled into the station. He failed to break all the American records he had hoped to smash, but claimed to have established new marks for non-stop flying between two points and for duration.

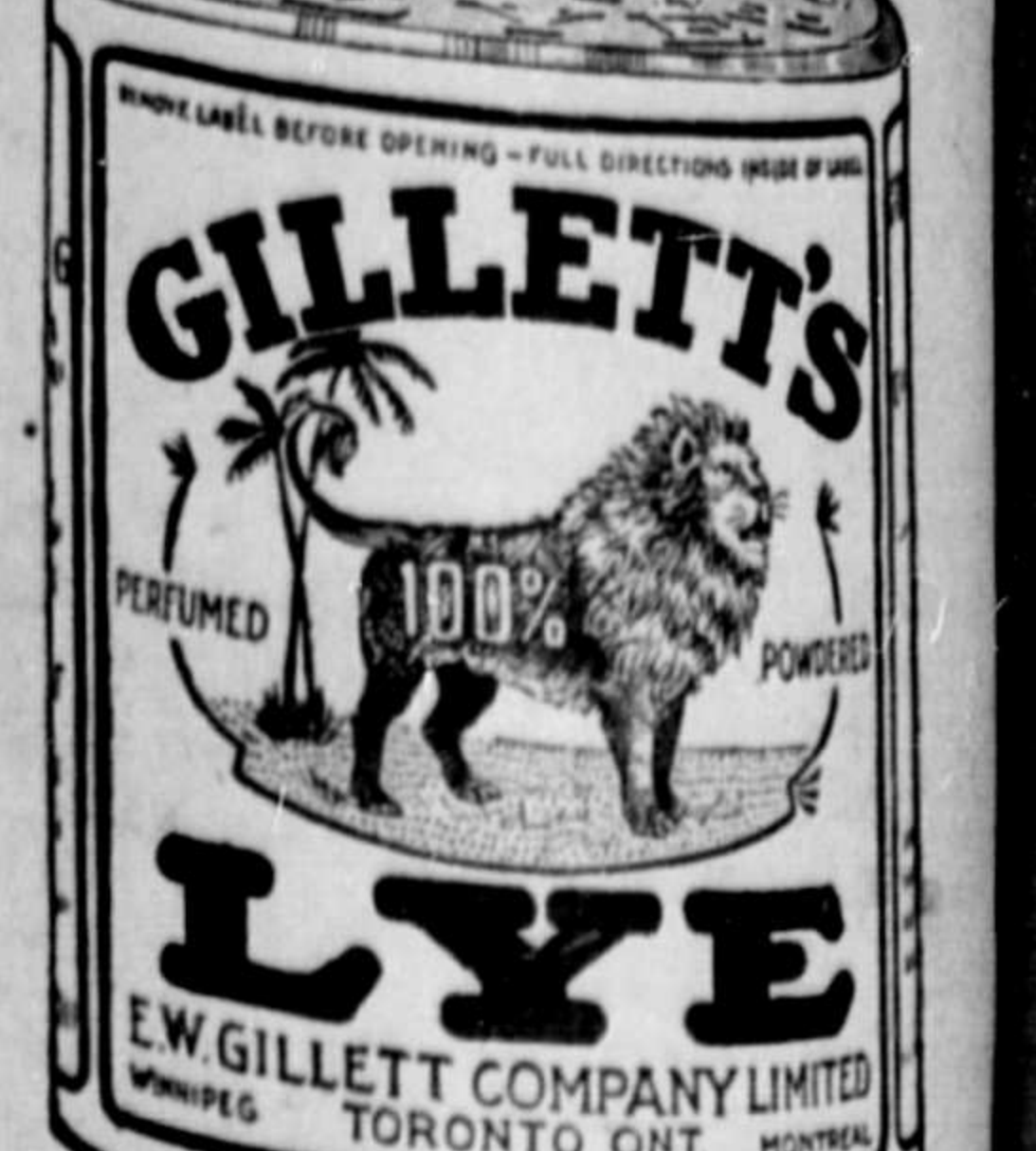
