FLEEING MAN SHOT DEAD BY SPECIAL CONSTABLE

VICTORIA HALFBACK KILLED ON FOOTBALL FIELD---TUG ESCORT AND BARGE GEORGIA SAFE

PROBABLY DEMENTED MAN SHOT DEAD AS ONE OF BANK ROBBERS

IT IS SAID HE WAS CHASED BY HALF BREED SPECIAL CONSTABLE, WHO SHOT THE MAN DEAD NEAR SKEENA CROSSING.

One victim has fallen to the deadly aim of the special constables scattered over the country in their search of the New Hazelton bank robbers. That he was an innocent and probably demented man appears to be the truth from the meagre reports of the affair brought down by the passengers from New Hazelton on yesterday's train. The victim is dead, shot through the lungs by a special constable who took a pot shot at him when the man refused to stop. The dead man is supposed to be a Finn who has been working for the railroad contractors in New Hazelton. He disappeared from his boarding house a week ago, and his chum believed him to be temporarily unbalanced mentally. He has a pay check

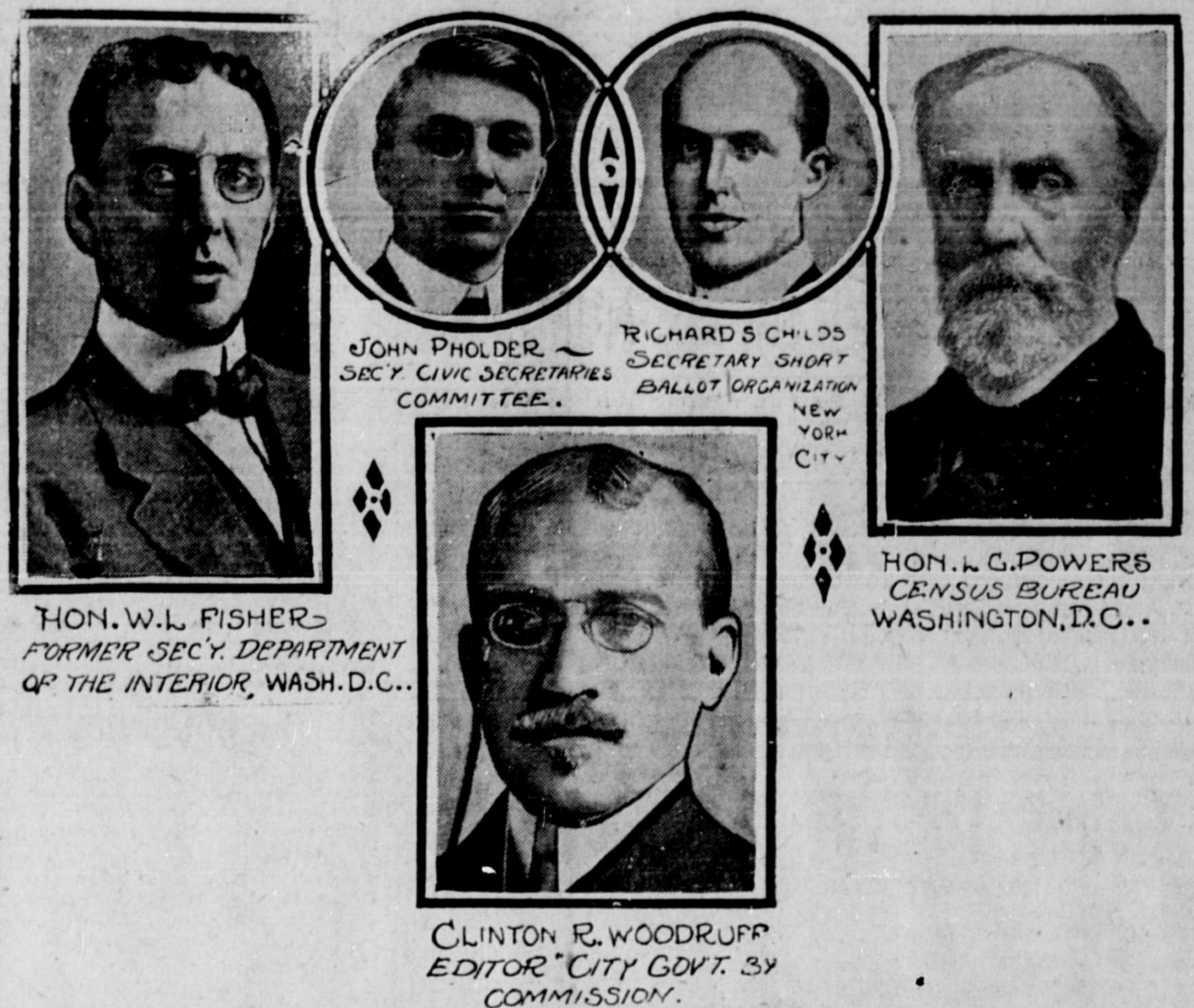
coming to him from the company. On Friday night a half breed special constable named Edgar, who has been located at Skeena Crossing watching for the bank robbers saw a man cross the bridge. He ordered him to stop but the man took to the woods. The following morning the constable, with assistants took up his trail and after following him for hours finally caught sight of the man. They again ordered him to stand but the man ran on. The constable raised his rifle and the first shot was fatal. When the train left New Hazelton yesterday the body had not been brought in but it was thought that the dead man was the one who disappeared a week before and had been wandering in the woods ever since.

NE TEMERE DECREE HAS RUNG THE DEATH KNELL OF DIVORCE

REV. FATHER BUÑOZ DEFENDS HIS CHURCH LAW---REPLIES TO CRITICISM OF REV. F. W. KERR---WHAT ABOUT THE TEA PARTIES?

"Does anyone know of a home in British Columbia that has been broken by the Ne Temere decree? If they do I would like to hear of it. I will expand that remark to include all of Canada and the United States. The death knell of divorce is rung by the Ne Temere." This was a pointed statement by Rev. Father Bunoz in his lecture last night on the defence of the Ne Temere and a reply to the criticism of the Catholic Church made by Rev. F. W. Kerr one week previous. Father Bunoz said he approached the subject with reluctance for while he was always glad to explain the doctrines, the practices and laws of the R. C. church, this was the first time he had been called upon to reply to unjust criticism from a christian pulpit. The criticism had been in bad taste and unprofessional. So far as the church was concerned it was like a pellet thrown against the rock of Gibraltar. Prince Rupert is a community of many creeds and no creeds, with people from various nations and of many languages. Anyone who would break up the good relations existing between the various elements in the city is not working for the good of the city. What has the R. C. church done in Prince Rupert to cause religious animosity? The priests are far too busy to bother with the

business of others. They preach of God and the precepts of the church, against evil, pride, jealousy and other vices, and explain the virtues. The Ne Temere is not new. It was first made by the Council of Trent 300 years ago and it has been in existence in Quebec ever since the colony started. It is not a decree to over-ride the civil law. Many prominent Protestants have defended it and want it applied to their own denominations. "The clause relating to the marriage of Protestant and Catholic outside the church," said Father Bunoz, "applies solely to the internal legislation of the church." A marriage outside is legal and the children of the union have all the privileges of the land. A priest will respect such a union. But a civil marriage is null and void according to the sacraments of the church. Has not the church the right to legislate for its own members. Marriage as a sacrament essentially belongs to the church. "It is not right to so often call upon the laws of the land in religious matters. Our statesmen should be free to devote their talents to civil matters and not be worried with church affairs. The church should look after its own interests. The policeman is not the guardian to the road to Heaven, nor is the jailor the keeper of the key to the Home of God. Let us breathe freely. Give us only necessary laws and let these be well observed. "The Catholic church is teaching that the bond of matrimony cannot be broken asunder. How can that church break up the home? She is working for the unity of the home." The speaker recited instances where he refused to marry couples because he lacked information concerning the parties in one instance, and because in another one the party had been divorced, yet the papers the following day announced a very pretty wedding. Touching on the question of raffles the lecturer asked "the author of the friendly criticism" to be consistent. He recalled one raffle which was not connected with the Catholic church. "The selling of tickets for a doll is adapted to our methods and desires for making charity. If you can point to an evil in it I

An armed guard escorted a wagon load of mail taken off the steamer Spokane to the post office this morning. The mail contained five sacks of gold from Alaska to Vancouver by registered mail. The Spokane brought down a big cargo of mail from Alaska and that portion consigned to Vancouver was transferred at this port, through the post office to the steamer Prince Rupert. The transfer was made before daylight. There were 21 passengers on the Spokane for Prince Rupert and 150 passengers for Seattle.

TUG ESCORT NO. 2 AND BARGE GEORGIA SAFE

Adrift in Queen Charlotte Sound Rescued by ss. Chicago and Govt. Boat Estevan
The G. T. P. tug Escort No. 2 and the Barge Georgia which was reported adrift in Queen Charlotte Sound on Saturday night are now safely at anchor at Albert Bay. The tug was picked up by the ss. Chicago on Saturday, but the barge could not be found. Later the Escort and government boat Estevan started in search of her and the Estevan picked her up this morning.

For a time there was much concern over the safety of Capt. Bradley and his assistant on board the barge, for while she is a stout craft there was grave danger of her going ashore. The tug and barge left here last Sunday after bringing several cars up for use on the railway. Two empty cars were aboard the barge for the return trip.

FOOTBALL PLAYER IS KILLED AT ALL BLACK VICTORIA GAME

FULLBACK OF VICTORIA TEAM GETS KICKED ON HEAD AND DIES ALMOST INSTANTANEOUSLY --- VANCOUVER GAME CONSEQUENTLY CANCELLED

(Special to The Daily News.)
Victoria, Nov. 24.—By a grievous chance the victorious tour of the New Zealand All Black Rugby team has practically ended in a tragedy. The team had played all the coast universities, and in but one or two instances had these teams been able to score at all. The New Zealand team, after playing here was to play at Vancouver on Tuesday and then return home with its kit full of honors. During the game played Saturday afternoon between the All Blacks and a local team of fifteen, Ogden, the

Victoria full back, in a sharp scrimmage, got kicked on the head. He died while being carried off the field. What action, if any, will be taken will not be known until after the holding of the inquest. The score for the match was 35 to 0 in favor of the All Blacks. Vancouver, Nov. 23.—As a result of the tragic ending of the football game in Victoria Saturday, the match scheduled between the All Vancouver team and the New Zealand players for tomorrow has been cancelled.

BURGLARS WERE BUSY SUNDAY NIGHT BUT GOT LITTLE LOOT

ENTRIES WERE ATTEMPTED AT FIVE PLACES AND FOUR WERE ENTERED SO FAR AS AT PRESENT REPORTED TO THE POLICE

At four o'clock on Sunday morning the police were called up and informed that the glass in the door of J. A. Kirkpatrick's store on Sixth Street had been smashed and that it looked as if a burglary had been attempted. The police were on the scene in short order and found that a burglarious entry had been made and that the till had been forced open. Mr. Kirkpatrick was communicated with and on his taking stock later found nothing missing but the contents of the till, amounting to \$7.

The police next found that the next store, that of Charles J. Keithly on the corner, had also been broken into, and upon this they started upon a general investigation. It transpired that Mr. Keithly had emptied his till on Saturday night, so he lost no cash.

Across the street on Second Avenue the store of I. Grossman was discovered to have been broken into. From there the burglars carried away several small pieces of jewelry and \$2 in cash.

It was evident that a determined attempt had been made to break into the Bryant clothing store on Sixth Street, but that the thieves had been probably interrupted before they accomplished their purpose.

At the new department store of Pride, Nash & Co., corner of 6th Street and 3rd Avenue, the attempt to break in was successful but the robbers, as far as known, had their trouble for nothing. This ends the series so far reported.

During yesterday several suspects were placed under arrest, and are being held for further developments.

Fingers Amputated

Beraard Cassidy, an employee of the Sash & Door factory had one hand badly gashed by a broken slab while at work in the mill this morning. He was hurried to the hospital where it was found necessary to amputate one finger and part of another on the injured hand.

CANADA CUT QUITE A FIGURE AT UNITED STATES LAND SHOW

EXHIBIT COVERED SPACE OF TWO THOUSAND SQUARE FEET BRITISH COLUMBIA GIVES A LOAF OF BREAD TO EVERY WOMAN VISITOR

Chicago, Nov. 23.—Saturday was Canada Day at the United States Land Show at the Coliseum building here. The show attracted the largest crowd that has yet been in attendance since the opening day. Canada reigned supreme.

The largest representation of agricultural produce of any section of North America was exhibited at the show of the Canadian government. The exhibit was in charge of J. White, superintendent of the emigration agencies in the United States. It covered a space of 2,000 square feet and was the admiration of all who visited the show.

At the joint exhibit of the Dominion government and that of the Province of British Columbia there was given away a loaf of bread to every woman visitor. The C. P. R. presented to every man who was present a tobacco pouch filled with prize grains from the Dominion. The Canadian exhibits attracted the attention of the entire at-

tendance and was the subject of much favorable comment.

BORDEN'S CONDITION
TOO SAD FOR WORDS.

Premier Borden of late has given Canadians considerable room for thought—and has naturally gone to the States to furnish the material. On November 1st it was announced in the Conservative official press that Mr. Borden was exhausted with his tremendous labors at the capital, while his ministers had been joy riding all over the country. It was stated that the premier was in ill health, and therefore he had gone for a six weeks' holiday to the Southern States. When the Devil was sick, The Devil a saint would be; When the Devil got well, The devil a saint was he. According to the New York newspapers of November 3rd, it transpired that Canada's very sick and suffering premier had gone straight from the enervating atmosphere of Ottawa's parliamentary buildings to the warmer (it might be styled hot) climate of the Great White Way of New York City. The very first thing that the suffering premier did there to alleviate his physical distress and sickening languor was to attend a jolly Sunday evening dinner of actors, given at the famous Lotos Club in honor of Cyril Maude, a "chappie" from the English boards, don'tcher-know. This was a dinner at which magnums of champagne were much in evidence, and at which there were a number of New York's theatrical firmament to make merry withal. At this Sabbath entertainment the Right Honorable Robert Laird Borden, K. C., LL. D., premier of Canada, despite his exhaustion and the saddening feeling of weakness, found strength to make a speech to

the joy-makers. It was a long speech, too; so long that its length was duly commented upon. The New York Herald, notably one of America's safe and sane newspapers, had its reporter accompany Mr. Maude to the dinner, and the Herald's report says: "It was learned from Mr. J. E. Dodson, actor, who was the host of the dinner, that Mr. Maude had better wait until Mr. Borden, premier of Canada, had ended his speech. Mr. Borden was not half way through, and after waiting ten minutes Mr. Maude requested that some one get him a glass of champagne and a chicken sandwich. He got it, and ate the sandwich in a few mouthfuls. . . . Melville E. Stone, general manager of the Associated Press, was toastmaster. He introduced Mr. Borden, Canada's premier, who remarked facetiously that naturally every statesman liked to get the opportunity of speaking, and he proceeded to show at length how much he liked it. "In regard to reciprocity between this country (the U. S.) and Canada, Mr. Borden said that Canada had no objection to such a treaty and that Canada felt that she had done her fair share toward it. He said that he regretted that it had not come to pass, but he added that 'Canada will conduct affairs so as to be a bond between the United States and the British Empire.'" After the "No trade nor truck with the Yankees" campaign of 1911 Canadians will be astonished at Mr. Borden's New York speech, as his fellow members of All Saints' Church, Ottawa, will also be to hear that when away from home to recuperate his health he enjoys himself at Sunday evening revels with theatrical people.

M'BRIDE LOSING WORKERS BY
BOWSER'S PECULIAR ACTIONS

HIS DISCRIMINATIONS AMONG THOSE BEING PROSECUTED FOR
VIOLATION OF SUNDAY SELLING LAW CAUSING
GREAT INDIGNATION.

Victoria, Nov. 20.—Attorney General Bowser's discrimination in the matter of the prosecution of merchants who sell goods on Sunday has brought about more trouble in the camp and the premier is finding himself called upon to exercise his conciliatory manner with the faithful who have threatened the government with the loss of their support and influence. A large number of the tobaccoists affected have been giving their support to the Conservative party here for the past two or three elections, and some of the best known of them have been influential in the councils of the party and in active campaigning

for the McBride government in season and out. They say that they have no objection to the enforcement of the Lord's Day act if it is enforced without favoritism, but so long as the Empress and other hotels and the C. P. R. stands are allowed to stay open and sell to all on Sunday while other dealers are to be heavily fined, they will protest against Mr. Bowser's attitude. Some of the merchants have resigned from the Conservative executive and one very influential man told members of the government that after this his vote and of his family will be cast for opponents of the government and all their influence will be used against it.

INDIAN TRIBES OF DOMINION
RAPIDLY INCREASE NUMBERS

TUBERCULOSIS IS STILL AN AWFUL ENEMY WHICH THE DEPARTMENT ENDEAVORS TO FIGHT, BUT THE INDIAN IS NOT DYING OUT.

Ottawa, Nov. 20.—The red man of Canada shows no signs of following his American brother to the happy hunting grounds of their forefathers westward in the land of the setting sun. In other words, the Indians of Canada are increasing in population and are becoming more industrious, intelligent, moral, self-reliant and self-respecting citizens throughout the land which their forefathers originally owned. This is the outstanding feature of the report of the department of Indian affairs issued today. The Indian population of Canada is given as 106,490, as against 104,960 at the end of the

last fiscal year. There were decreases in some of the tribes, but these were mostly caused by the Indians moving from one province to another. Quebec shows a gain, its present Indian population being 12,842, an increase of 25 per cent. for the year. The Indian is rapidly becoming better educated. At present there are 249 day, 59 boarding and 49 industrial schools in operation during the year, a total of 426 of all classes. The Indian, according to the report, is losing the love for "fire water." The government, however, and its agents have been very active in their desires to suppress the illegal traffic in intoxicants and during the past year the fines collected aggregated approximately over \$2,000 more than those collected the previous year. Crime and immorality during the year was very light and there was not a single vicious criminal case reported to the department. The birth rate during the year averaged about 35 per thousand, while the mortality rate was about 28 per thousand.
