

## KITWANCOOL INDIANS DIPLOMATICALLY APPEASED

A NEW SYNDICATE TO SUPPLY BUILDING MATERIAL --- PUBLICITY EXHIBITION IS NOW OPEN

### SYNDICATE NOW PREPARING FOR A VERY LIVELY BUILDING BOOM

WILL BE ABLE TO PLACE GRANITE GRAVEL, DIMENSION ROCK  
AND PRESSED BRICK ON MARKET WITHIN 60 DAYS

Prince Rupert has long felt the want of cheap building material. Common clay brick has been selling at three dollars per thousand and pressed brick at four dollars and fifty cents, while sand and gravel was held in the vicinity of four dollars per yard. With these conditions it was out of the question to think of erecting permanent buildings on a large scale.

Many local property owners have been waiting patiently till the time when these conditions would change, in order that they might improve their property, and now their wishes are about to be gratified. A local syndicate, headed by Mr. N. J. McLeod, has secured a granite quarry on Smith Island, near the Skeena river, and are about to put in a plant that will turn out all grades of crushed granite and sand, as well as dimension rock and pressed brick.

Mr. McLeod has just returned from Vancouver, where he has purchased the entire plant, and it is expected that it will be on the

ground within thirty days. A gang of men have been at work clearing the ground for the plant and buildings necessary.

The quarry in question is excellently situated for economic operation. Mr. McLeod, in selecting the site, had in view the fact that there is a large amount of granite in this district and in order to successfully compete with all comers he must have some special advantages. This is to be had in the fact that the rock is situated on tide water and at an elevation that will enable it to be handled entirely by the gravity system. Then the quality of the rock is excellent, without any of the breaks and fissures seen in most of the local granite. He has also secured one of the government leases at Cow Bay and expects to store his material there in bunkers.

With all these special advantages, Mr. McLeod is confident that he can cut the price of building materials in two, which should result in a building boom for this city in the very near future.

### DISTURBANCE KITWANCOOL QUIETED BY CHIEF OWEN

INDIANS HAVE NEVER HAD BOUNDARIES OF THEIR VILLAGE  
FIXED—TOOK SURVEYORS INSTRUMENTS AND GUNS

Again all is calm and peaceful in Kitwancool village in the quiet valley 16 miles of the G. T. P. from Kitwango. Last week there was riot and threats of shooting but today the survey party of white men are working unmolested beside the Indian village.

Provincial Chief of Police Walter Owen was the peace maker. When surveyor Price wired for assistance he took in a bunch of twelve men. On arriving in the valley he sent an interpreter in with a letter and the following morning met the chiefs.

"The Indians have a grievance, all right," said the chief, "but whether it is due to the neglect of the Indian Department or to the Indians themselves I do not know."

This Kitwancool village is hundreds of years old, and although an Indian reserve is recognized as being there its boundaries

have never been fixed. The Indians have been trying to get the whole valley reserved but so far no specific reserve has even been made. Last year surveyors for private parties ran a line right through the village and got the natives agitated. Consequently when this last party were seen operating within half a mile of the village the Indians got excited and went down in force, taking the instruments and guns.

Chief Owens promised to lay their case before the authorities so that the Indian Department would be acquainted with their grievance and the natives decided to accept his suggestion.

Warrants had been issued against three of the Indians and these were served. The two were taken to Hazelton charged with molesting a surveyor. They were let off on suspended sentence. The police returned on yesterday's train.

### PUBLICITY COMMISSIONER'S EXHIBITION ROOM OPEN

ALREADY VISITORS ARE GETTING INTERESTED IN DISPLAY  
OF RESOURCES—FREE INFORMATION BUREAU.

Already strangers are commencing to utilize the bureau of information of the Board of Trade, and hardly a boat arrives from the south that does not have its quota of visitors who are directed to the office of Publicity commissioner. Here they obtain literature appertaining to the city and district, and Mr. P. F. Godenrath is prepared to interest them in the opportunities the new north has to offer in every line of industry.

On Saturday there arrived Herman Nimphins and Adolf Stromeyer, two Germans who are desirous of locating here. Mr. Nimphins is an architect by profession and his friend, Mr. Stromeyer, is an importer. They are now studying local conditions and gathering information relative to Prince Rupert and its resources. Should they elect to stay here, it is quite possible that several other influential Germans of Cologne would become financially associated with them.

The commissioner's office is gradually assuming shape, and it will only be a few days before Mr. Gilbert Burrows will have

completed the installation of a magnificent exhibit of the ore resources of the various mining divisions surrounding Prince Rupert. Four special glass cabinets have been provided for this department. Mr. Godenrath is daily expecting shipments of vegetables and grains for the section devoted to agriculture and special stands are being provided to accommodate this class of exhibits.

The rooms will also be tastefully decorated with enlarged photographs showing scenes along the line of the Grand Trunk Pacific Railway and Portland Canal. Messrs. Harrison, Gamble & Co. have presented two fine frames, one containing pictures of Port Edward and the other "snapshots" of Tyee Park. Mr. Sidney Smith, of the Atlin Construction Company, is providing some views of local fishing scenes. The bureau, however, has ample wall space yet to be utilized and those having interesting views of the townsite or district could render a good service by letting the Board of Trade secure copies.

#### MAYOR HAD BUSY DAY

Visited the Slide at Shawatlans on Saturday Afternoon.

Mayor Pattullo was a busy man Saturday. Not satisfied with spending the morning in the city hall cleaning up office work which had gathered during his absence on city business in Victoria, he arranged with the city engineer and Alderman Naden to visit Shawatlans Lake and personally inspect the rock slide which occurred there a few days ago.

The slide was on the south side of the lake and along the line proposed for laying the water pipe. Had the pipe line been in it would have been destroyed and tremendous damage done. As it is the party were unanimous in the opinion that the water pipe will now have to be laid along the other side of the lake.

A gang of men are now at work clearing the debris at the foot of Shawatlans Lake which interferes with the temporary pipe line there.

## SULZER AND CLEMENTS.

Mr. Justice Clements, of the B. C. Supreme Court, has been found guilty of fraud and ordered to pay back money wrongfully obtained as mileage fees by representing his place of residence to be Grand Forks instead of Vancouver. His crime was not in getting this money by fraud because other judges admit they have been guilty of the same practice; his sin was in refusing to respond to the crack of the whip of the Tory bosses in Vancouver. It is a parallel case with that of Sulzer and Tammany Hall. There is no doubt that Justice Clements was guilty of a wrong, a very grave wrong, and one to be condemned, particularly in a man who occupied an exalted position representing honor and justice. Yet this fraud, as it is called, is not peculiar to this judge, nor is it a sin of recent commitment. It has been going on for years. But it was never called to account until the judge gave a decision in the course of his duties which was unfavorable to one of the Tory bosses in Vancouver. There is no doubt in the mind of the public that had Justice Clements handed down a decision contrary to his belief of what was fair play and justice these travelling fees and the charge of fraud would never have been heard of.

Justice Clements will have to accept the disgrace and pun-

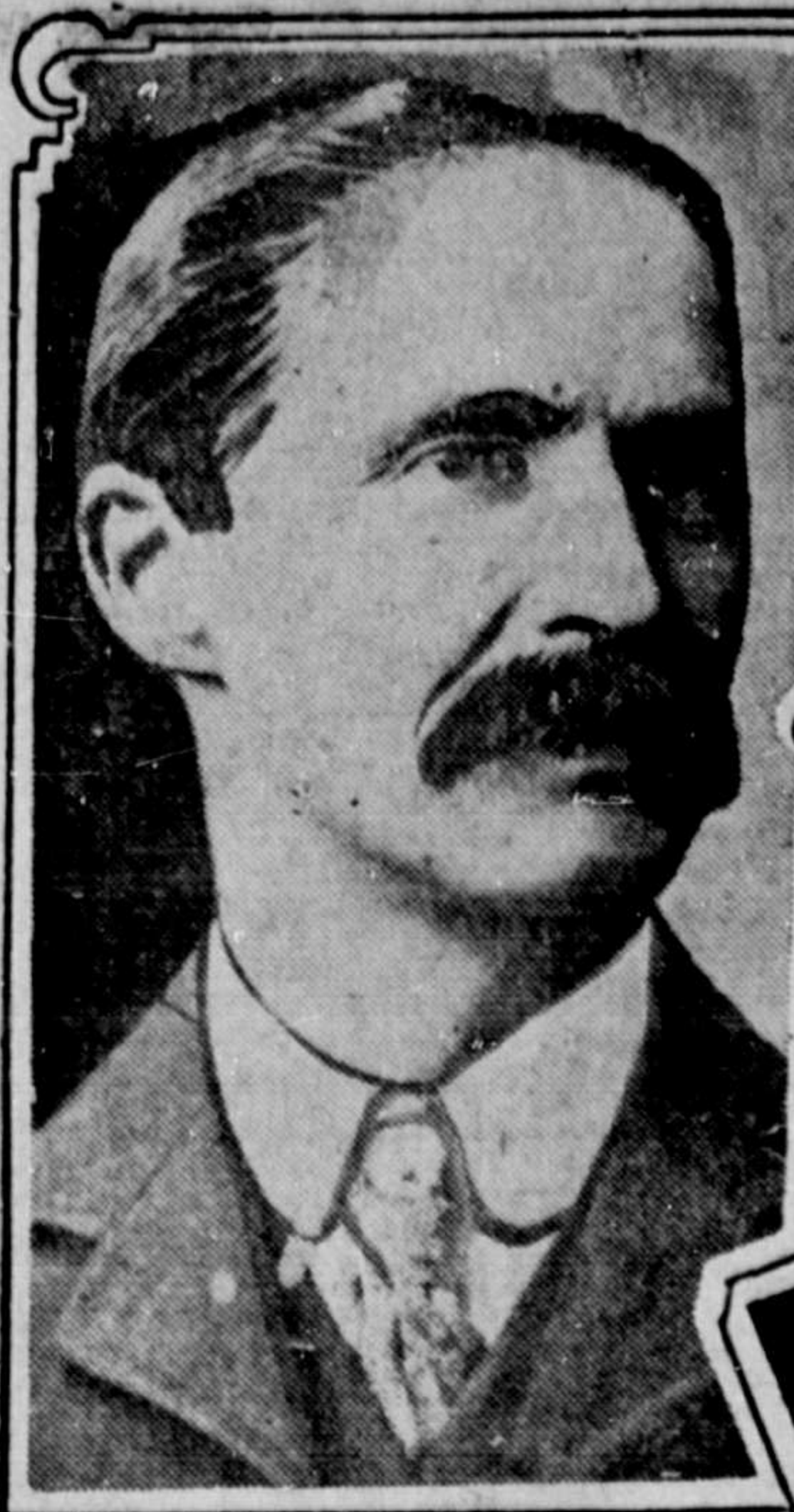
ishment for his wrongdoing without looking for public sympathy, yet the public cannot but admire his strength of character in standing out against the dishonest politicians.

McGowan, the Tory member of Vancouver who is credited with having been the author of Justice Clements' prosecution, once referred to the Supreme Court as being composed of "two lunatics, a fool and a fugitive from justice."

In comparison with the judiciary of the United States Canadians have always boasted that our judges are free from the contaminating influence of party politics, but apparently in British Columbia politicians can make and unmake judges. The Clements' incident is a sorry blow to our pride.

"Everybody can't be a road boss," says a Tory paper. "Tis true! Nor can everybody be employed on the road gang, for there are many settlers in Skeena district now who refuse to vote Tory even at the expense of a summer's job."

Sir William Van Horne, of C. P. R. fame, has been doing the anvil chorus on the Hudson Bay Railway and the wheat route via the Panama Canal. Sir William is not the first man who could never see any good in the other fellow's idea.

Washington, Nov. 27.—In the historic east room of the White House, at 4.30 o'clock yesterday, the Rev. Sylvester W. Beach, pastor of the First Presbyterian church at Princeton, N.J., which the President attended when he was the head of Princeton University, joined together in wedlock the president's daughter,

White of Baltimore, who was a classmate of Miss Wilson at Goucher College, Baltimore; Miss Adeline Mitchell Scott, daughter of Prof. Wm. B. Scott, of Princeton University (Miss Scott was a girlhood chum of Miss Wilson); and Miss Marjorie Brown, a daughter of Col. F. T. Brown, of Atlanta, Ga., and a second cousin of the bride on the maternal side.

Dr. Wilfrid T. Grenfell, who was best man, is noted as an explorer and philanthropist. Mr. Sayre worked in Labrador at the Grenfell Mission, founded by Dr. Grenfell.

Miss Wilson's wedding gown was of heavy satin of cream

white tint, so faint that it seemed almost pure white. Rare old lace, heirlooms in the family of Mrs. Wilson, was freely used in embellishment of the bridal gown.

The gown had a three yard court train of the full width of the satin. The foundation skirt had the most fashionable lines—close at the feet and slightly crinkled at the hips. The skirt was slashed at the side seams in the back so that the bride could walk easily and gracefully, but the parting was entirely hidden by the folds of the train.

The veil was of tulle, and orange blossoms were used to fasten its soft folds. The flowers came from Columbia, S.C., the old home of the Wilson family.

The bridesmaids wore white or the palest ivory crepe de chine in a new high lustre tint. The trimmings were a tunic over dress of hydrangea net. The girdles were of a deeper tone of net and satin.

TO INCREASE INFLUX  
OF AMERICAN FARMERS

C. P. R. Colonization Agents Start Great Colonization Campaign with "Movies."

Chicago, Ill., Nov. 29.—A convention of great importance and of future influence upon the development of Western Canada was held here yesterday, when the Canadian Pacific Railway colonization agents, from Portland, Oregon to Portland, Maine, and south to the international boundary of Mexico, under the direction of J. S. Dennis, assistant to the president of the road, gathered to discuss ways and means for an active colonization campaign during the coming year.

The agents are all keenly enthusiastic over the prospects in their respective territories for a continued and increasing movement of the better class of American farmers to the Canadian West. The new terms under which the railway sells lands to practical farmers, just beginning to be fully understood, will, it is predicted, result in an unprecedented movement to Western Canada. An active publicity campaign will be continued in the United States, including the use of forty motion picture reels depicting the life, scenery and development of Western Canada, with lectures by speakers well acquainted with the conditions.
