Shipbuilding Company Assigns for Benefit of its Creditors

Vessels may be completed by Liquidator as was done in
 Toronto in similar case; Government protected
 against loss

OTTAWA, November 5.—The Prince Rupert Drydock and Engineering Co. has gone into liquidation, according to information received by the Government. Two ships, each of eight thousand tons, were under construction by the company for the Canadian Government and were about three quarters finished. The Government is protected against loss by a stipulation in its contract entitling it to take over the vessels and also by a guarantee company for \$332,000. It is probable that the department of marine will endeavor to make an arrangement with the liquidator for the completion of the ships as it did with the liquidator of the Dominion Shipbuilding Co. of Toronto. Officials say the delay in completion of the ships will be small compared to the situation of possible unemployment. The Government cannot make any immediate move to relieve the situation because such action might prejudice the Government claim under the guarantor's bond by the London Guarantee & Accident Co. In view of the distress due to non-payment of overdue wages, the Government has asked the consent of the guarantee company to pay off the workmen by the Government. The guarantee company will be pressed for an agreement along these lines. The guarantee company has the option of completing the ships but failing this the Government will probably do so.

Grouse Supper Spoiled By Arrival of Officers

Harry Ross, Escaped Prisoner from City Jail, Found in
 Digby Island Shack Yesterday; Committed
 for Trial

Harry Ross, the prisoner who escaped on Saturday night from the city jail, was rounded up on Digby Island yesterday afternoon and coming again before Magistrate McMordie on a charge of breaking jail was committed for trial on this more serious offence. Before the accused was sentenced he broke out, saying that he had not yet received justice in the court and he was able to prove his innocence of the first charge. He complained of being railroaded and that he was not getting a square deal. He got little sympathy from Magistrate McMordie who ordered him to sit down. The city police had been searching for Ross for three days. On the first day they went to the cabin at Mile 1 where he was supposed to have lived with Joe Verino. The place was deserted but a gramophone with 62 records and a quantity of potatoes were located. Fugitive Not Far Off. Next day the police went back and took the gramophone and the records but the potatoes were gone. There were signs of someone having been there and a crab supper having been eaten. The officers came to the conclusion that the fugitive was not far off. Yesterday afternoon a party consisting of Dominion Constable Watkinson, Sergeant Adams and Constable Campbell set out in the Dominion boat "Leila" for a marine hunt. Metlakatla and Digby Island were searched and finally on Digby across from Casey Point, a man was seen walking on the beach and also a boat was noticed. Covered With Guns. Going ashore the officers made a detour up a hillside and approaching a cabin from the rear covered the occupants with their guns and saw Ross sitting down inside. With him was Joe Verino and they had sat down to a grouse supper before them. Asked if he had a gun, Ross admitted it and is alleged to have said "It is lucky for you that you came from the back and covered me as quickly as you did." Both Ross and Verino were arrested and appeared in court this morning. Ross was committed for trial with little delay. Warden Bailey and Sergeant Adams gave evidence as to the man having been in jail one night and not being there in the morning. The lock on the door leading from the jail to the courtroom was discovered broken by Warden Bailey when he came on duty on Monday morning. He immediately called muster and found Ross missing. Ross will appear before Judge Young this afternoon to elect for trial. This morning he questioned Warden Bailey as to whether the lock was broken before his escape. He asked Sergeant Adams if he had jurisdiction to arrest on Digby Island. This, however, was assured by the presence of Dominion Constable Watkinson with the arresting party. James McDonald, charged with drunkenness, appeared in police court this morning and pleaded not guilty, but Magistrate McMordie convicted him, imposing a fine of \$10. Chief Vickers, in giving evidence, said the accused had attempted to pass things through a hole in the jail window before he was arrested. He had been warned but was later in the day picked up by Constable McGinehy in a drunken state. Alex. McMullin was also fined \$10 for drunkenness.

Conservatives in Victoria and
 Prince George Choose men
 to Contest Seats.

VICTORIA, Nov. 5.—Conservatives here last night nominated Canon Hinchcliffe, R. Ross Sutherland, W. W. Northcott, and Alex. Stewart to contest this constituency. Other nominations are: Prince George—Sam Cocker of Vanderhoof, Conservative, defeating H. A. Carney and Dr. Alward. Yale—J. R. Cameron, C. P. B. agent at Ashcroft and returned soldier, Liberal, defeating Joseph Wallers, and R. J. Stewart. Revelstoke—Dr. W. H. Sutherland, Liberal. Richmond—Reeve Pearson, Conservative. Sidney and Islands—Geo. Clark, Conservative. Including last night's nominations there are now 110 candidates for the 47 seats in the Legislature and the big parties have yet to nominate in 12 constituencies.

Miss Clara Parsons Becomes Bride
 of Duncan Kennedy at
 the Manse.

The wedding was solemnized last evening at 8:30 at the Manse of Duncan Kennedy, carpenter foreman at the cold storage plant, and Miss Clara Parsons, daughter of Mrs. R. Parsons and sister of Captain Parsons, Rev. Dr. H. B. Grant officiating. The ceremony was a quiet affair and there were present only the relatives and immediate friends of the contracting couple. Both Mr. and Mrs. Kennedy are very well known at Seal Cove and will receive the hearty felicitations of many friends. Testifying to the esteem in which they are held there were many beautiful presents of cut glass and silverware and other tokens. Following the wedding Mr. and Mrs. Kennedy left amid a shower of confetti and rice to spend a brief honeymoon in Vancouver, the bride wearing a most becoming travelling suit of nigger-brown velvet with hat to match. On their return they will be at home on Seal Cove Circle. Mike Zeresky, charged with the theft of \$105 in cash and a silver watch from a Hindu, has been committed for trial and appears before Judge Young this afternoon.

MAN DIED ON MAIN STREET

David Hanley, Ship Fitter, Col-
 lapsed and Passed Away in
 Drug Store

David Hanley, aged 55, a ship fitter at the local shipbuilding plant, died last night in Orme's Drug Store after having collapsed on the street outside. Death was due to heart failure and no inquest is to be held. About 9 o'clock Hanley was noticed by passers by on Third Avenue to stoop for something he had evidently dropped on the street. Instead of rising, however, he collapsed backward and by the time they had had an opportunity to come to him, he was unconscious. He was immediately removed to Orme's drug store where artificial respiration was attempted but without avail, for within 45 minutes he was declared dead. Provincial Constable Ackroyd was on the scene and was joined later by Sergeant Adams and Constable Campbell of the city force. Dr. West was called in and pronounced life extinct. Hanley was a native of Belfast, Ireland, but had no immediate relatives in this country. Before coming to Prince Rupert he was in Seattle for a short time. He was known intimately by Albert Kelly, of the Ennad Block, was a Presbyterian and was single. The funeral arrangements are in the hands of the B. C. Undertakers.

CRANBROOK, Nov. 4.—Premier Oliver in an address here said he favored the abolition of near beer bars because it is the chief avenue through which boys and girls acquire the habit of drinking.

Aggressive Campaign to Assist Those who Come To Settle in Country

CRANBROOK, November 5.—Outlining the policies and constructive programs of the Provincial Government with respect to industrial expansion, immigration, colonization and irrigation projects, Premier Oliver last night strengthened his already formidable position in the district. The Premier made no extravagant promises but recited the objects which his administration was striving to attain in a manner that suggested their realization in the near future. "Conditions in the old land are such that many people are preparing to come to Canada to settle," he said. "The time has come for an aggressive campaign to assist these people to become established. We have thousands of acres awaiting the building of roads, which will assure us settlers locating thereon."

Manson is Chosen To Run in Omineca

Gets Unanimous Support of Convention
 Held Last Night; Liberals and Con-
 servatives give him Support

SMITHERS, November 5.—The Liberal convention last night was well represented and A. M. Manson was the unanimous choice. His nomination was enthusiastically received by a number of former Conservatives who were in the convention. Although complicated by there being four candidates in the field, Manson's election is considered almost assured, all fair-minded men agreeing he is the best representative Omineca ever had. Francois Lake went strong for Manson and contrary to the expected rule of former Conservatives returning to their old camp, those who voted for him in 1916 and others are now coming forward to his support and volunteering to go on his nomination papers. As Murray has deserted the soldiers and gone straight Conservative, the returned men feel under no obligation to him and unhesitatingly support Manson.

Harding, at the election celebration of the "home folks" last night declared that the Versailles League of Nations was "now deceased" although the new administration intended to see that the nation played its part in a new international association founded on peace and justice.

Choosing Candidates For the Election.

Everywhere throughout the province the Liberals are nominating strong candidates and there is little doubt but they will win and the Oliver Government be returned to power. This is very apparent in Vancouver city where Mrs. Ralph Smith heads the list of nominees and there are on the slate such men as Ian Mackenzie, president of the Great War Veterans' Association. The other men are well known and have been in the public eye for a long time.

The name of Farmer John Oliver is still one to conjure with. In throwing in allegiance with a local candidate it is well to consider, is that candidate ready to support the best premier British Columbia has ever had? Oliver is not the most polished premier, but has rescued the province from a financial quagmire and carried out more progressive legislation than any other man in the short time he has been there.

Oliver has not lavished money on the constituencies. He did not have it to lavish. He had nothing left him to commence with but a burden of debt. Now what is the condition? The country is again prosperous and the credit of the province is good. This borrowing more capital to pay debts cannot go on forever. It leads eventually to ruin; Oliver has saved us from ruin. Those who want to see a continuation of sane government will throw in their lot with those who support Premier Oliver.

Nothing to Hope From Bowser Scheme.

At the meeting of the Prince Rupert Liberal Association Wednesday night W. E. Williams drew attention to a pledge made by W. J. Bowser that if he became premier he would jackpot a large portion of the taxes and allot it to the different districts on the basis of population. This meant that most of the money would go to Vancouver. Here we are trying to open up an empire and if takes money to do it. Prince Rupert district would get almost nothing under such a scheme.

The same men who are backing Mr. Bowser and his policy are the ones who are saying Prince Rupert has not had proper support from the Liberal administration. As a matter of fact the plan given out by the leader of the opposition is designed to capture the voters of Vancouver and Victoria and must alienate the country voters and those living in the smaller communities where expenditures are needed and financing is always difficult.

No Political Divisions Over Vital Matters.

It was good to see members of all political parties uniting Monday at the Board of Trade rooms in an effort to deal with the shipyard troubles. There was no question of party or politics. The interests of Prince Rupert and of the shipyard workers were the only subjects under consideration and these were talked over without friction or anything but the most earnest desire to arrive at a solution. This was a most refreshing condition and indicates that we are not altogether depraved by political bias.

Prince Rupert to Dock Here.

The Prince Rupert is to be docked here when she comes off the rocks at Swanson Bay. The first intention seems to have been to take her south but the activity of Col. Beck backed by the Board of Trade has been instrumental in securing the docking of the vessel here. The Colonel is always on the job when it comes to looking after the needs of his constituents. In this case he did a lot of good work which we are glad to know proved effective.

DUAL VOICE MAY BE SPIRIT

Man from Mr. Collier's Home Town Sings Tenor and Bass Together

J. W. Collier of this city has received a number of newspaper clippings from his old home town of Leigh, Lancashire, England, telling of the man, Edgar A. Dickenson, who sings with a double voice, taking both the tenor and bass parts at one time. Mr. Collier knows the family well. Gramophone records are now being made from his songs.
The discovery of his voice was accidental. Dickenson was following his trade of window cleaning and was singing at his work when a professor of music passed by. Hearing the odd voice, the professor stopped and listened and then questioned the man and told him what a wonderful voice he had. His singing has caused a furore in the old country.

Supernatural Power

The Evening Chronicle of Leigh says:
"The Leigh 'dual' vocalist has come to the conclusion that his tenor voice is the only voice over which he has complete control. He says his bass voice, when in combination with the tenor, is controlled and operated by some supernatural power, possibly the spirit of some departed musician. J. Hewat McKenzie, principal of the British College of Psychic Science, to whom Mr. Dickinson applied for a test of his theory, told the London Evening News: 'We shall first hear the voices and then see for ourselves whether he is controlled by a spirit operator. In this test we shall use clairvoyants. They will put themselves in a state of semi-trance to observe if there is a spirit form in the astral plane controlling Mr. Dickinson's bass voice. I have known of mediums when controlled by different entities, singing bass, treble and tenor, but not simultaneously.'"

TRY TO PURCHASE RAILWAY HOTEL SITE

VICTORIA, Nov. 5.—Negotiations have been started by an American hotel syndicate desiring to acquire part of the block bounded by Government, Belleville, Douglas and Elliott Streets for the site of a fine tourist hotel. This property is owned by the Grand Trunk Development Co., which bought it eight years ago to build a Grand Trunk Hotel here similar to the Fort Garry in Winnipeg, the Chateau Laurier at Ottawa and the Macdonald at Edmonton, but did not proceed with the scheme.
Now that the Grand Trunk has been taken over by the Dominion Government it is considered unlikely that it would go ahead with new hotel schemes, although the property has since been held by the company.
The site which the Grand Trunk Pacific acquired here, and which the American hotel syndicate is seeking, overlooks the Parliament Buildings and the Empress Hotel and its gardens. It is close to both the Grand Trunk and the C.P.R. wharves. The American hotel syndicate plans to establish a big hotel here because of the increasing popularity of Victoria as a winter resort.



SCHOOL BOARD AND THE WORK AT HAYS COVE

Matters Pertaining to Construction Now School Aired at Monthly Meeting.

The October estimate on the construction of the new Hays Cove school amounting to \$14,704.65 was presented by Contractor S. P. McMorde to the school board last evening and was ordered paid. Materials yet to be bought for the school include paint, hardware and hardwood. It is thought by Architect J. W. Potter that delaying the purchase of these materials may benefit the board to some extent for the prices are falling in some cases.

Mr. Potter intimated at the meeting last night that bricklaying to the main roof would be completed by Christmas and possibly by the middle of December. There are now eight bricklayers engaged on the work and five more are expected from Edmonton. This work is being done with dispatch and the men in charge are good organizers.

Hoist Tower.

Col. McMorde's claim for payment of the hoist tower again came up and has been left over until expert advice may be obtained from outside contractors. Col. McMorde claims that he should be paid for the tower while the board takes the point that that is included in the wording hoist and as such should be provided at the expense of the contractor as set out in the contract. The claim amounts to somewhat over \$400.

Pattinson & Ling sent in a request that they be allowed to borrow some conduit from the new school but this was turned down as the conduit supply is very short and this firm might not be able to replace it when desired.

Compensation Board.

A complaint was received from the Workmen's Compensation Board that Contractor Watts in charge of carpenter work had not made his returns under the act. No insurance is to be put on the new building until the roof has been put on. Steen & Long will be now at work on some of the roofing.

The city council has not yet taken any apparent action on the provision of sewers at the school and the board is communicating with the city in this matter.

WILL BUILD SEINER FOR FISHING OUT OF PORT PRINCE RUPERT

Captain Pete Rorvik left last night for Vancouver where he will have work commenced on the building of a big seiner for the N. M. & R. Fishing Co. The new boat will be 65 feet long and will be powered with a 60 h.p. semi-diesel engine. It will take about three months to build and will be ready for herring fishing in March. The new craft will be one of the largest seiners working out of this port. Captain Rorvik will return in about three weeks.

The School Board is to pay a boy \$10 a month to do the janitor work in the manual training school.

FEW MINISTERS ARE AT OTTAWA

Some in Europe and Some Touring Over the Country—New Crisis Breaking In

OTTAWA, Nov. 5.—Canada will receive the absent treatment from its Government for more than a month. Premier Meighen and Hon. J. A. Calder will spend about four weeks in the West. Sir George Foster, Minister of Trade and Commerce, and Hon. C. J. Doherty have left for Geneva to attend the assembly of the League of Nations and will be gone for six weeks, being assisted at the assembly by Hon. N. W. Rowell, who will join them in England. Sir George Perley is also leaving for England this week to carry on once again for a period until a new High Commissioner is appointed. Nothing will be done before next year at least with respect to this appointment.

The Tariff Commission, made up of Sir Henry Drayton, Minister of Finance; Senator Robertson, Minister of Labor, and Dr. S. F. Tolmie, Minister of Agriculture, will be going away in about a week or thereabouts, further depleting the number of available ministers.

Hon. J. D. Reid, Minister of Railways, is away in England, but may return in the near future. This week sees Hon. Hugh Guthrie back from attending the League of Nations Financial Conference.

Give New Ones a Chance.

Sir James Loughheed is Acting Premier and the new ministers, Hon. Messrs. McCurdy and Wigmore, will be given a great chance to be acting ministers for many departments. There remain at the helm, besides these, Hon. A. L. Sifton and Hon. G. C. Ballantyne, who will lose at the end of the month his deputy minister, Alex. Johnston. Mr. Johnston is taking a two-months' holiday before going to the Empire Steel Company at the end of the year.

Minister at Washington.

Unless events precipitate crises needing Federal action, it is intended that "marking time" shall be the chief occupation at Ottawa. No minister plenipotentiary will be appointed to Washington, and, indeed, the whole situation with regard to this appointment is causing grave perplexity. Australia has given notice that she wants a minister at Washington as well. It had been intended that the Canadian minister should be British Ambassador in the absence of the latter, but, with ministers from Australia and possibly New Zealand and South Africa, that arrangement would no longer be regarded as suitable as at first. Some changes in the plan may be devised.

Stopping Importations.

Another matter which will come before the remnant Government in Ottawa is the giving effect to the recent provincial votes on prohibition. An order in council must be issued within 60 days to decide the date when importation into provinces shall cease. One western democrat has written to the Government saying that fish men stocked up against the drought to come and importing that the poor man should be given an opportunity to do the same. There is little likelihood of haste in setting a date when importations shall cease.



WHISKEY FROM PRINCE RUPERT

Former Police Chief at Douglas Charged with Importing Liquor to Alaska

George L. Johnson, former chief of police of Douglas and later deputy U.S. marshal under Marshal Tanner, is charged at Juneau with transporting whisky from Canada to Alaska on the gasboat Eagle, Sadie and Iris, says the Alaska Dispatch. It is asserted that the Eagle conveyed whisky from Prince Rupert to Port Chacon, from which the boats Iris and Sadie transported the liquor to Douglas. The counts include allegations of possession of liquor and transportation from Canadian to American territory.

June 12 is the alleged date of the first whisky running and the offence bringing the tenth count is asserted to have been committed October 1.

Johnson resigned his office to Marshal Tanner on October 8, the same day that he was arrested on an assault and battery charge filed by Captain Fred Magill. Johnson had been a deputy for approximately two years.

Guilty of Assault

He appeared before Commissioner Burton and entered a plea of guilty to the assault charge. At that time he requested to produce evidence before sentence was pronounced. The commissioner continued the case, when evidence was introduced in behalf of the defendant as well as in behalf of the government. Commissioner Burton imposed a fine of \$75 to include costs. Johnson is represented by Attorney John R. Winn.

Out on Bail

Bail on the charge of importing whisky to Alaska was fixed at \$3,000, which amount was promptly furnished by Juneau friends of the accused deputy.

Deputy Johnson's record as a marshal was excellent, it having been his duty to make the more important criminal arrests in Southeastern Alaska. He was active during fish piracy in the past two years.

CARNEGIE LEFT LARGE FORTUNE

Gross Value of Estate Set at \$26,893,024—Reduced by Gifts.

PITTSBURGH, Nov. 5.—The appraisal of the estate of Andrew Carnegie has been completed and published here. It shows a gross value of \$26,893,024 and a net estate of \$23,247,161, which is even less than the estimate of Mr. Carnegie's fortune (between \$25,000,000 and \$30,000,000), made at the time of his death.

The huge fortune which he once possessed was reduced to these relatively small figures by the many public and private gifts Mr. Carnegie made during his life. The appraisal shows to what degree Mr. Carnegie succeeded in carrying out his purpose to dispose of the great bulk of his fortune before his death.

Mr. Carnegie's real estate in the vicinity of Pittsburgh is valued as follows: At Glencairn, \$179,687; Oakmont, \$157,589; Homestead, \$4,700. He had land in Canada and Minnesota valued at \$43,294.

The estimated value of Mr. Carnegie's real estate in New York is \$1,200,933, made up as follows: Residence at Fifth Avenue and Ninetieth Street, \$977,833; 155 West Fiftysixth Street, \$100,000; 52 to 55 East Ninetieth Street, \$66,800, and property at St. Andrew's Golf Club, Mount Hope, West Chester County, deeded to him in 1901, \$16,300.

At the time the will was filed it was estimated that the bequest going to the Carnegie Corporation as residuary legatee would amount to about \$20,000,000, but the provisions of the New York law were not considered when that estimate was made. The schedules show that the share of the Carnegie Corporation will be only \$10,663,580, subject to whatever charges are made in the valuation of the assets in the transfer tax proceedings.
