Mayor McClymont has Offer from States for City Bonds

Mayor McClymont has an offer from the States for city bonds to cover School and Section Two Bridge; Rate is low

Mayor McClymont returned last night after visiting the financial centres of the east in an endeavor to sell city bonds for the school and Section 2 bridge. He was not very successful as the market is in a bad condition just now with all sorts of municipal bonds offering at almost any price. While Canadian bonds would not consider buying, he received an offer from an American firm and he recommends that the City Council accept the offer.

Mayor McClymont said he had offered the bonds to eleven Canadian firms but none of them would make an offer. He had also interviewed the manager of the Bank in regard to carrying a loan in the building of the school. The manager strongly advised disposing of the bonds if they were not to be sold by the school, but promised not to see the bonds until after the school. There is \$80,000 borrowed on account.

CHARLES BARNES WAS FOUND DEAD IN BED AT HOTEL

Was an Old Timer of the North Having Been in the Skeena Valley in 1870.

Charles Barnes, an old timer of the North, was found dead in his bed at the Central Hotel yesterday morning, having passed away in his sleep. No inquest is to be held as Dr. Kergin states that death was due to heart failure.

Mr. Barnes was a man well on in years and was in the Skeena Valley in 1870. For some years he was employed by R. Cunningham at Hazelton and he acquired some land holdings at Fiddler Creek. In the boom days of 1899 he was in Atlin where he was known by Chief Vickers. From there he went down to Dawson and back again to this part of the country. Two years ago he was in the Old Men's Home at Kamloops, but left there and spent the past summer around Alice Arm where he worked for Postmaster H. H. Carney and George Bruggy, the merchant. He also solicited subscriptions to "Resources" Magazine there. He was to have left for Vancouver last night on a mining deal.

Funeral arrangements are in the hands of the B. C. Undertakers.

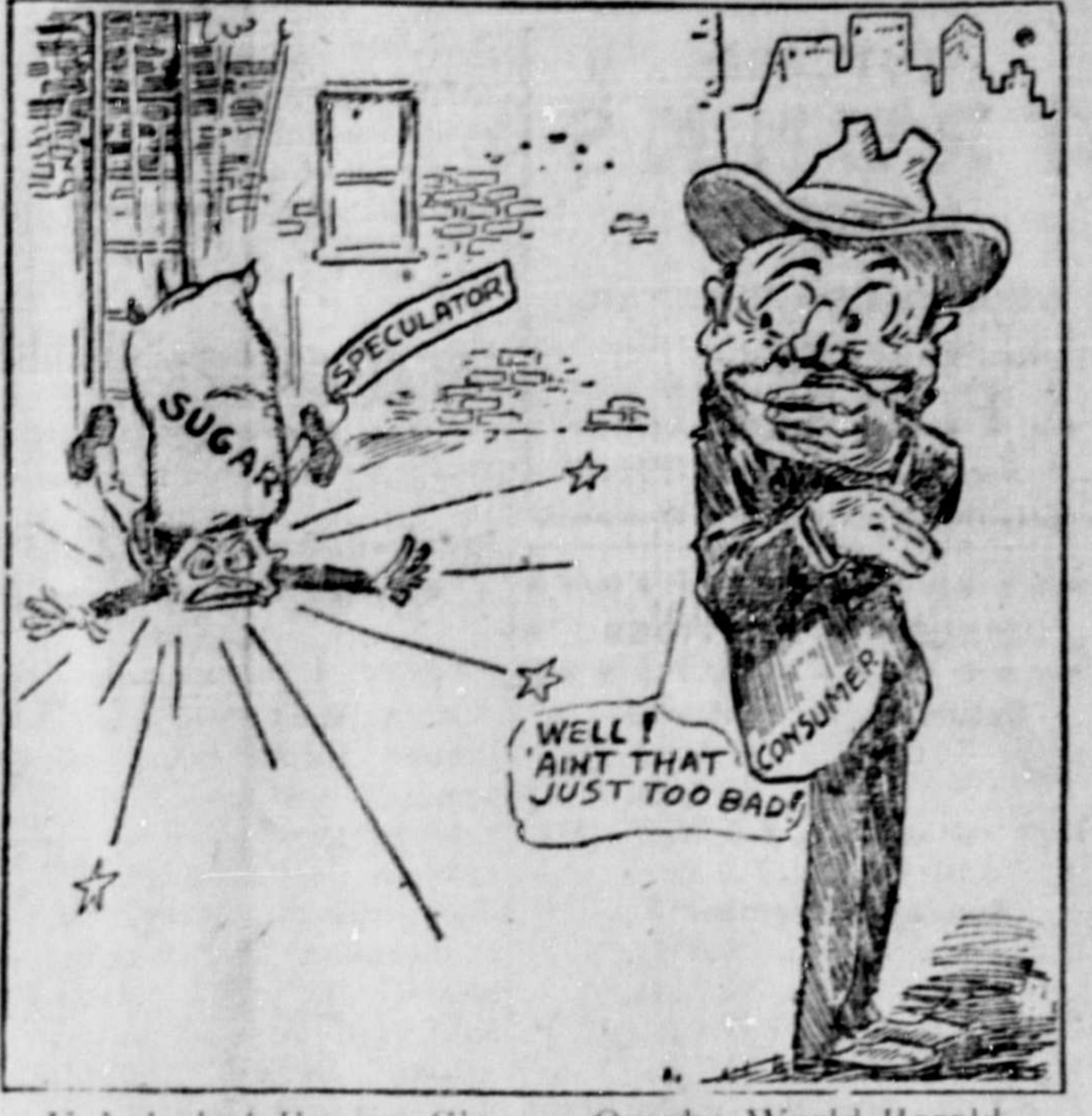
RETURNED MAN WAS DROWNED UP-COUNTRY

Col. Peck and Pillsbury Went East This Morning

Will take up with Government at Ottawa matter of resumption of work at local shipyards before disorganization

Colonel Peck, M. P., and J. H. Pillsbury, superintendent of the drydock and shipbuilding plant, have gone to Ottawa to take up with the Government the question of continuing the construction of the ships here while the organization is on the ground.

A full meeting of the council of the Board of Trade took place this morning in the board rooms, when President S. E. Parker outlined the course of action proposed. Colonel Peck had strongly urged that they should be sent to do the business direct with the ministers in place of telegraphing. It was very important that the work should continue before the shipyard became totally disorganized.

Alderman Dybhavn on behalf of the city said he thought the city would stand the expenses of the trip, but he would take it up with the finance committee this afternoon and tonight it would come before the City Council. It was decided to send the two delegates and they left on the train this morning.

G. W. V. A. WILL CASH CHECKS

Aid for Veterans to the Extent of \$1,250—Port Simpson Native's Pension.

At a meeting last night the local G. W. V. A. decided to cash checks for returned men who have been working at the drydock up to \$1,250 in all. This will relieve some of the difficulties in connection with the non-payment of wages.

The local G. W. V. A. has also taken up with Colonel Peck the matter of pensions with a number of local people. One case is that of Mrs. Forrest, a native woman of Port Simpson, whose two sons were killed overseas. Col. Peck will take this up with the department and it is expected she will receive Government aid. At present the local G. W. V. A. is paying her \$25 a month from their funds.

GEORGE BRODERIUS CHARGED ASSAULT

Charles Lang, Victim of Affray, is in the General Hospital as a Result

George Broderius was up before Magistrate McMordie in the police court this morning charged with making an assault and causing grievous bodily harm on Charles Lang and was remanded for two days. Lang is in the hospital on account of the injuries sustained.

The alleged assault occurred on Saturday night at the shack of the accused near the Commercial Hotel. When Sergeant Adams and Constable Logan, who were called to the scene, arrived, Lang was lying unconscious in a pool of blood outside Broderius door. Both men were battered up pretty badly and it is believed they were drinking.

Broderius is now out on two hundred dollars bail.

GERMAN GUN CAME IN LAST EVENING

Will Be Placed in Front of City Hall for Present.

The German howitzer 332, the war souvenir for Prince Rupert from the War Department at Ottawa, reached town last night on the train. In the meantime it will be placed in front of the City Hall and a permanent location for it will be decided upon later.

Financial Credit Better Than Any

Oliver returning to coast and may be chosen as candidate in Victoria; Capital anxious to have him.

VANCOUVER, November 8.—Premier Oliver will be back from the Kootenay trip tonight in time for the convention.

At Nelson, replying to statements made by W. J. Bowser, Mr. Oliver said that possibly four thousand orders in council had been passed by the former government, not fifty thousand as reported. The financial credit of this province was now the best of any of the provinces of Canada.

It is understood that Mr. Oliver's name will come before the Liberal convention at Victoria and he may possibly be a candidate there as well as in Delta. The Victoria people are very keen to have him stand for that constituency as his presence would be a source of strength on the ticket.

HALIBUT TAKES BIG JUMP AT FISH SALE YESTERDAY MORNING

The fish supply was short yesterday at the Fish Exchange and the demand was great, so lively bidding brought the prices both for first and second class halibut to a mark that was never before reached on the local market. John Dybhavn bought a carload of fish for the Royal Fish Co. and paid 23c and 44.6c. The lucky boats were the Glacier, 8,000 pounds; Viking, 4,000 pounds; Agnes B., 12,000 pounds; and the Kimmount, 2,000 pounds.

SMITH OUT FOR MAJOR MARTYN

Industrial Commissioner to be Candidate — Other Nominations.

VANCOUVER, Nov. 8.—John A. Fraser of Quesnel, a former member of the Legislature under the Bowser Government, has been nominated by the Conservatives at Quesnel.

PORT COQUITLAM, Nov. 8.—Major D. B. Martyn, Liberal, has been nominated here and Maxwell Smith, independent Liberal, has withdrawn in his favor. Martyn is one of the industrial commissioners.

SOUTH VANCOUVER, Nov. 8.—Frank Russell, Liberal, was nominated here after J. W. Weart had refused renomination. Other nominations are: Grand Forks, John McKie, Conservative, E. C. Hininger, Liberal. Delta, R. A. Payne, soldier farmer, as an independent to oppose the Premier, and F. J. McKenzie who is the Conservative.

Therefore the rise in the Prince Rupert harbor is slightly greater than Port Simpson.

VANCOUVER IS SURE OF DOCK BILLS PAYABLE

Creditors there do Not Issue Writs, but Think Government will See Claims Paid

VANCOUVER, Nov. 8.—Manager A. D. Dimming, of the Canadian Credit Men's Association, told the World on Saturday that there were fifty Vancouver creditors of the Prince Rupert Dry Dock and Engineering Co. Their claims against the company would amount to \$123,000. No writs have, however, been issued here as was done at Prince Rupert.

It is hoped that the government will complete the ships and satisfy the creditors out of the profits that were destined for the Prince Rupert company. The government guarantee of \$320,000 would be no benefit to the creditors, who are looking for steps to be taken by the government, believing that, if the work is finished, all obligations will be met.

LOCAL CONSUL IN PACIFIC FISHERMAN

Speaks of Anomalous Condition of Salmon Market Here This Season

E. A. Wakefield, U.S. consul at Prince Rupert, has noted some unusual features that have developed this year in the fresh salmon trade between that port and Alaska, says the Pacific Fisherman.

"Alaskan fishing boats," he says, "are bringing King salmon and cohoes to the nearby British Columbia canneries and a few of them have returned with loads of humpback salmon for Alaskan canneries. King salmon brought here are sold by the pound and cohoes at so much per fish. The prevailing price for the former has been 14 to 15 cents a pound; cohoes sell at 75 cents each, and average 6 to 6 1/2 pounds in weight. Humpback salmon were selling at 5 and 6 cents each, but the Alaskan demand sent the price up to 8 cents.

"British Columbia packers are not inclined this year to can the cheaper grades of fish so extensively as in former years. This explains the shipment of humpbacks to Alaska. Why better grade fish should be so freely shipped from Alaska to British Columbia in a season when the salmon run is said to be not above the average is not so clear. According to the fishermen engaged in this trade the British Columbia packers are willing to pay more for king salmon and cohoes, even after allowing for the prevailing discount in Canadian currency (12 1/2 to 14 per cent).

"This is certainly a new condition of affairs in connection with the Pacific coast salmon-canning industry and one which, on the face of it, is rather difficult to explain. The casual statement which has been made that it is due to a difference in trade demand does not seem sufficient to account for this sudden and unprecedented trade. In 1918 approximately 2,500 pounds of fresh salmon was brought to Prince Rupert from Alaska by American boats and about 12,500 pounds in 1919. So far this year 125,000 pounds, selling for \$51,000, have been landed. According to the vessel owners these fish are nearly all obtained from trolling boats operating off the Alaskan coast."

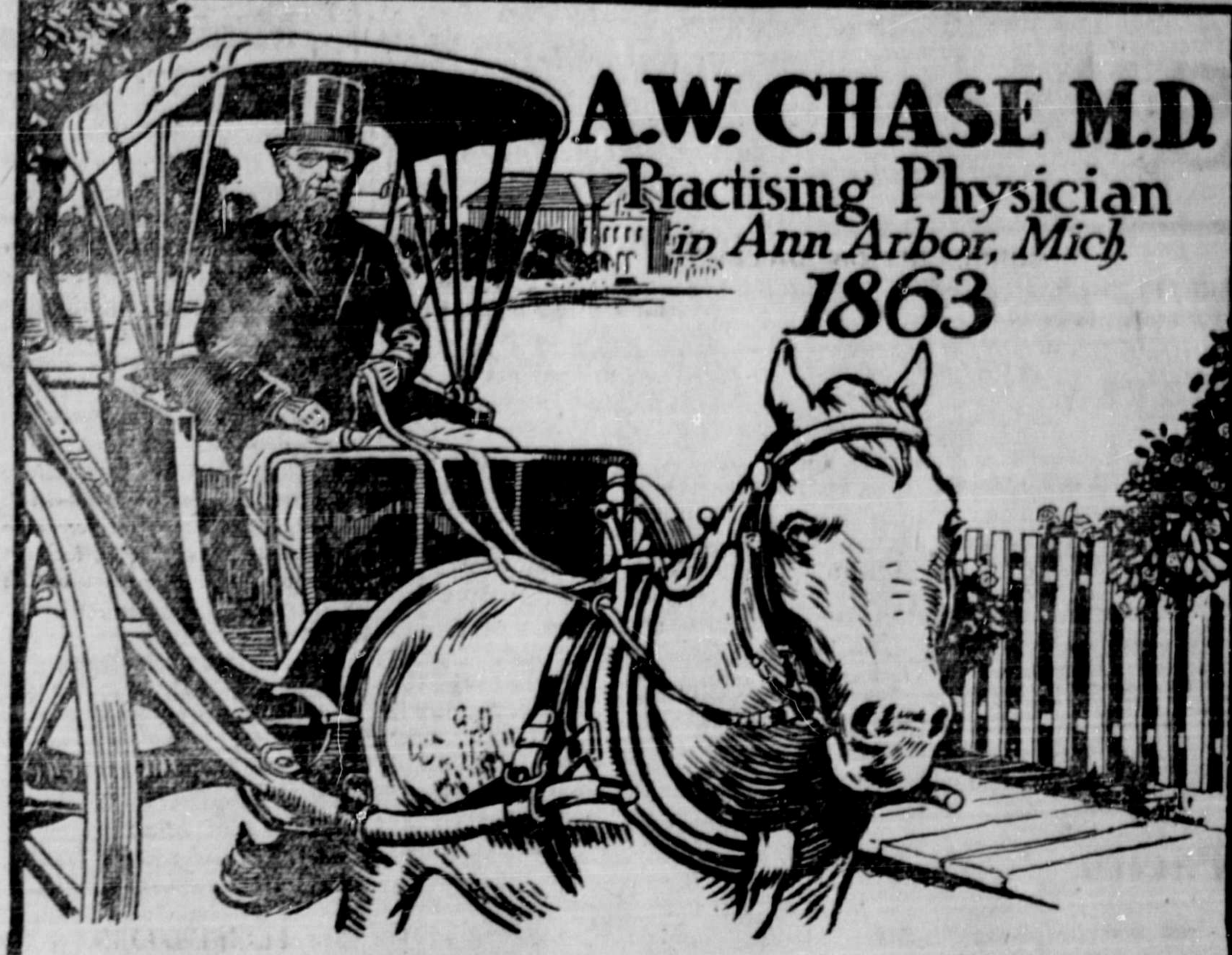

COURT BREAKS WILL TO ASSIST WIDOW

VANCOUVER, Nov. 8.—A case of considerable interest to the women of British Columbia was recently heard by Chief Justice Hunter in this city. Under the statute passed by the provincial government at its last session, known as the Testators' Family Maintenance Act, no one, either man or woman, can cut off his family with the proverbial shillingle. Whenever the court is of opinion that the will does not make adequate provision for the proper support of the testator's wife, husband or children, it may order that adequate, just and equitable payments shall be made for that purpose.

In the case in question, a widow was given nothing, although she was not in any way at fault, in fact had by her own efforts largely contributed to the acquisition of the property which the deceased had left. His lordship remarked to W. F. Gurd, by whom the application was made on behalf of the widow, that the effect of the act enabled the court to make a new will. Mr. Gurd admitted that this was the intent and effect where natural justice had not been done.

An order was made allowing a monthly sum to the widow, which was as generous as the estate half of the widow, that the effect permitted.

Mining News

Samples in Victoria

Specimens of silver ore from Stewart mines are on exhibit in C. H. Bowes' drug store in Victoria. Four samples are from the Premier mine and three other very rich specimens are from the Spider claims. The one of greatest interest to Victoria, however, is from the Silver Tip Group, which is owned by a syndicate of Victoria men. It was recently bonded to a group of Vancouver men, who made a second payment a short time ago of \$7,500, making a total of \$15,000 already paid by them. P. W. Racey is in charge of the Silver Tip which is closed for the winter.

Nome is Done

The steamship Victoria landed 350 persons from Nome on her last trip to Seattle from the North. Former residents of Nome in Seattle predict that this marks the passing of the once famous beach mining town. The most of those who returned to the States on the Victoria will remain there, said passengers who declared that there were less than 200 persons left in Nome. In the summer of 1898, following the gold strike, Nome had a population of 15,000 souls.

Engineer Litigation

A big lawsuit which threatens to eclipse the Dolly Varden one in public interest is now on in Vancouver over the Engineer Mine, at Atlin. W. L. Goodwin, of Nome, and eleven others are fighting the Alexander estate, claiming that they staked the claims first and that Captain Alexander "jumped" the staking. Another case is also pending against the Alexander estate, in which W. Pollard Grant claims a fifth interest in the mine. A sale is proposed of the Engineer Mine in which a price of \$3,000,000 is offered by Cobalt interests.

Usk Mine

A ten foot vein is being developed at the head of Ghimness Creek, near Usk. The body contains many stringers of gray copper ore which is rich in silver, assays having run from 15 to 20 per cent copper and 200 to 300 ounces of silver per ton.

Hedley Closing Down

The plant of the Hedley Gold Mining Co. at Hedley, B. C., near Princeton, has been closed down and it is likely will remain closed for a year. The reduction of gold at the mill there has not been found profitable enough of late to warrant further operation until the gold market changes, so the decision of closing has been reached by the company on the advice of the president, I. L. Mergill. The mine, mill and plant will be in good condition to reopen when decided. The Hedley Mine, commonly known as the Nickel Plate, is a picturesque one, for the ore comes down a long, steep inclined railway from the top of a mountain into the concentrating mill near the town. For the past few years the operation of the Nickel Plate Mine has been the sole source of support of the little town of Hedley.

PORT SIMPSON VOTES THANKS TO VISITORS

Appreciates Manner in Which the Political Issues are Placed Before Them by Mr. Pattullo.

A Liberal meeting was held at Port Simpson on Saturday night in the interests of the candidature of Hon. T. D. Pattullo, minister of lands, which was well attended by voters, ladies predominating. Dr. Spencer presided. The speakers were A. R. Mallory of Port Clements and L. W. Patmore, H. F. Pullen and the candidate from Prince Rupert. At the close a vote of thanks to the visitors was unanimously passed for placing the issues so clearly before them.

Mr. Patmore discussed the matter of finance and explained particularly the value of the work of the minister of lands during the four years he had been in the Legislature. His record was a matter of comment everywhere and this district was not sufficiently appreciative of the splendid work that had been done. He spoke of the candidates, showing that Mr. Pattullo was the only man they could logically support.

Aeroplane Spruce.
Mr. Mallory was very brief but he explained that it was the work of the minister of lands in connection with aeroplane spruce production that had placed the Islands on the map as they had never been before and the people there recognized this and would give Mr. Pattullo a substantial majority.

Mr. Pullen spoke of the candidates. Mr. Burrough was organizer for the Loggers' Union and former general secretary of the O. B. U. and announced himself as a revolutionary Socialist and not caring about reforms. He was a sincere man but, if elected, would use his position at Victoria for socialist propaganda, something that did not get you anywhere. Mr. Newton as usual announced himself and it was by means of his newspaper that he was able to get before the public. This being a candidate was a habit with him. He wrote a series of editorials in which he scathingly attacked his opponent in language which was anything but such as a public man should use. These editorials were a source of great amusement to the community and did not hurt anybody. However a man of that type was hardly the man they wanted in the Legislature. He did not represent anybody and did not stand for anything except himself and his own aggrandizement.

The Conservatives, the speaker said, had been for weeks searching for a candidate, but so far had not been able to find one. Mr. Kirkpatrick had come to Prince Rupert and gone carefully over the district and had decided that it was no job for him. Mr. Orme had been offered it and had refused. Mr. Heattie had been suggested but had not as yet accepted. The Conservatives might choose a man on Monday night, but whether they did so or not the man who would win, and that by a large majority, was T. D. Pattullo.

Women in Politics.
Mr. Pattullo spoke of the fact that women were taking more interest in politics than they had done heretofore and that was due to the legislation passed by the present administration who gave them the vote. They all remembered the time when a man had to join the Conservative Association in order to get a job. That was all changed now. He told of

Wage Act, the Mothers' Pension Act, the Women's Franchise Act, the Equal Guardianship Act, and the measure providing for support for deserted wives. He claimed that in finance, in development of natural resources and in social legislation the Government had done real work which he knew the people appreciated. The administration of John Oliver and his

cabinet had been an honest, courageous and forward administration. Under it the north had not been neglected, as his opponents had charged.

Good Work.
At the close Dr. Spencer said undoubtedly the Government had done good work. He could not, however, understand how it was that men who had been convicted

under the Prohibition Act had been released when they got to Victoria.

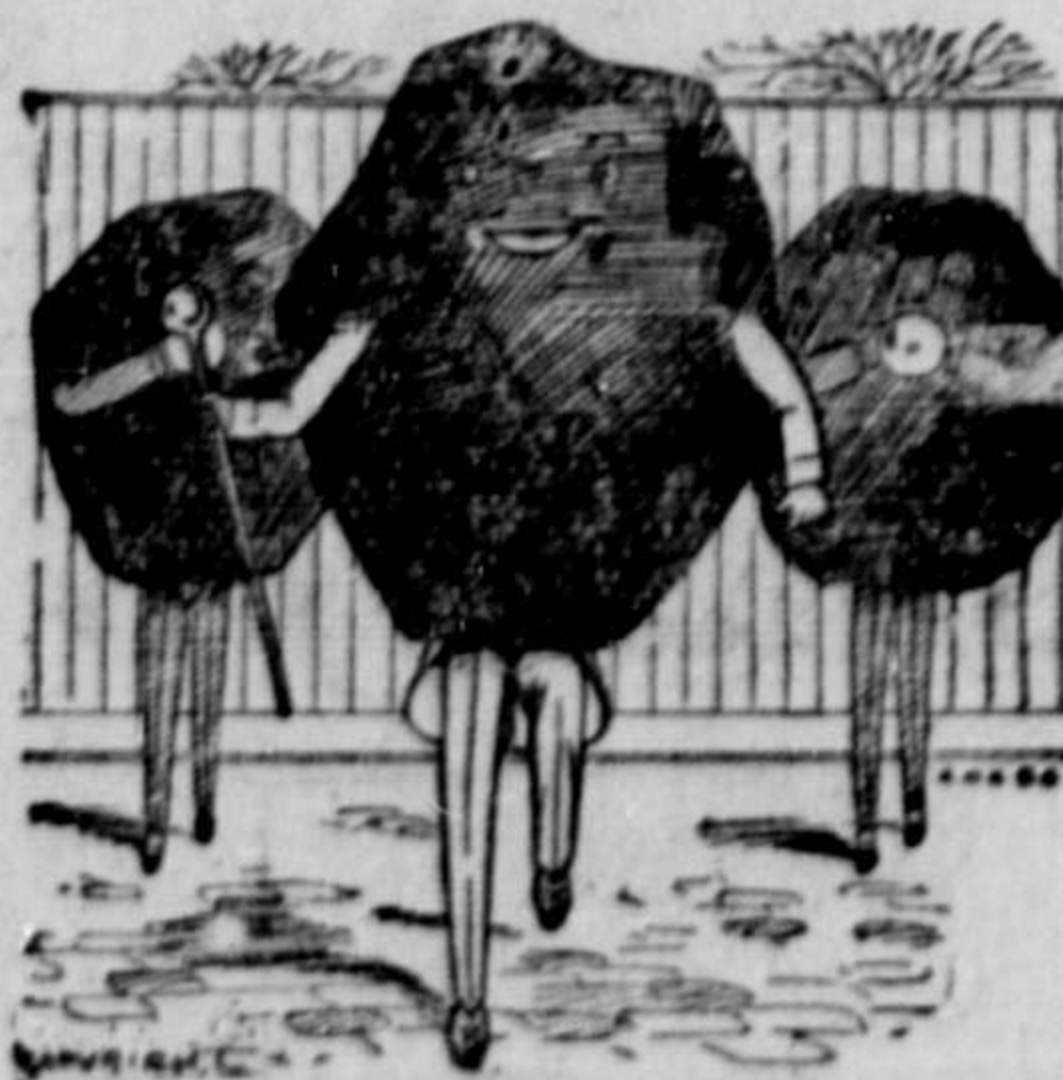

Synopsis of

Land Act Amendments

Minimum price of first-class land reduced to \$5 an acre; second-class to \$3.50 an acre.

Pre-emption now confined to surveyed lands only.

Records will be granted covering only land suitable for agricultural purposes and which is non-timber land.

Partnership pre-emptions abolished, but parties not less than four may arrange for adjacent pre-emptions with joint residence, but each making necessary improvements on respective claims.

Pre-emptors must occupy claims for five years and make improvements to value of \$15 per acre, including clearing and cultivation of at least 5 acres before receiving Crown Grant.

Where pre-emptor in occupation not less than 2 years and has made proportionate improvements, he may, because of ill-health, or other cause, be granted intermediate certificate of improvement and transfer his claim.

Records without permanent residence may be issued provided applicant makes improvements to extent of \$500 per annum and records same each year. Failure to make improvements or record same will operate as forfeiture. Title cannot be obtained in less than 5 years, and improvements of \$150 per acre and residence of at least 2 years are required.

Pre-emptor holding Crown grant may record another pre-emption, if he requires land in conjunction with his farm, without actual occupation, provided that the pre-emption is for agricultural purposes and residence maintained on Crown granted land.

Unsurveyed areas not exceeding 50 acres may be leased as homestead; title to be obtained after fulfilling residential and improvement conditions.

Grazing and industrial purposes areas exceeding 640 acres may be leased by one person or company.

Industrial sites on timber land not exceeding 50 acres may be purchased; conditions include payment of stumpage.

Natural hay meadows inaccessibility by existing roads may be purchased conditional upon construction of a road to them. Estate of one-half of cost of road, not exceeding half of purchase price, is made.

PRE-EMPTORS' FREE GRANTS ACT.

The scope of this Act is enlarged to include all persons who are serving with His Majesty's Forces the time within which the heirs or devisees of a deceased pre-emptor may apply for title under this Act is extended from one year from the death of such person, as formerly, until one year after the conclusion of the present war. This privilege is also made retroactive.

No fees relating to pre-emptions are due or payable by soldiers on pre-emptions recorded after June 26, 1918. Taxes are remitted for five years.

Provision for return of moneys accrued, due and been paid since August 6, 1914, on account of payments, fees or taxes on soldiers' pre-emptions.

Interest on agreements to purchase town or city lots held by members of His Majesty's Forces, or dependents, acquired direct or indirect, remitted from enactment to March 31, 1920.

SUB-PURCHASERS OF CROWN LANDS.

Provision made for issuance of Crown grants to sub-purchasers of Crown Lands, acquiring rights from purchasers who failed to complete purchases, involving forfeiture, on fulfilment of conditions of purchase, interest and taxes. Where sub-purchasers do not claim whole of original purchase price due and taxes may be distributed proportionately over whole area. Applications must be made by May 1, 1920.

GRAZING.

Grazing Act, 1919, for systematic development of livestock industry provides for grazing districts and range administration under Commissioner.

Annual grazing permits issued based on numbers ranked, priority for established owners. Block-owners may form Associations for range management. Free of penalty for permits for settlers, campers or travellers, up to ten head.

LEMON EXTRACT WAS TEMPTATION TO JOHN BROWN AND HE FELL

The barrel of lemon extract that adorned the main entrance of the Prince Rupert Table Supply last week proved too much of a temptation for one John Brown, Alias Duvoy, who this morning appeared before Magistrate Mc-Mordie and was sentenced to thirty days' hard for stealing four bottles therefrom.

It was on Saturday night that Constable Logan was patrolling Sixth Street just in time to see the accused plunge into the barrel and remove two bottles. Before the officer got close he had dived in again and got still another two. When the constable interfered a "battle royal" started and both officer and man were floored and a bottle of "jacky" was broken. Finally three officers got Brown to the station amid much kicking and biting.

In court this morning Brown said he remembered buying some extract but he had imbibed some too with the result that his memory had gone and his subsequent actions were as a blank to him. The magistrate delivered sentence and advised the accused when he got out of jail to leave the strong stuff alone.

MUSICAL SERVICE AT METHODIST CHURCH

Pastor Speaks of Desirability of Doing Justly in All Things.

The musical service at the Methodist Church last night was well attended, the building being packed with an interested congregation. The musical numbers were all well rendered and were much appreciated.

Rev. T. H. Nuttall gave a five minute address in which he spoke on the subject of doing justly. He suggested that those who did not register their votes for the municipal election failed to do justly and also those who allowed a wide open city here were not doing justly by the boys and girls who were growing up.

HALF MILLION WILL BE SHARED IN FIGHT

NEW YORK, Nov. 8.—Jack Dempsey will receive \$300,000 and Georges Carpentier \$200,000 from the super-fight which was signed up on Friday.

PREACHER IN JAIL.

WINDSOR, Nov. 8.—Rev. J. O. L. Spracklin, pastor of the Sandwich Methodist Church and a special liquor license inspector, was detained in the Sandwich Jail following the shooting and death of Beverly Trumble early Saturday morning. Trumble was the proprietor of an inn known as the "Happell House" and the shooting occurred during a raid.
