STEAMER CHESLAKEE FOUNDERS; SIX DROWNED

MORE THAN EIGHTY PER CENT. OF CALIFORNIA ORANGE CROP IS DESTROYED BY FROST

MORE THAN EIGHTY PER CENT OF ORANGE CROP DESTROYED

FROST IN SOUTHERN CALIFORNIA CONTINUES AND CITRUS CROP SUFFERS SEVERE DAMAGE—SMUDGE FIRES BURN

(Special to Daily News.)
Los Angeles, Jan. 7.—As a result of the heavy frosts of the past two days throughout the orange belt of Southern California it is estimated that between 80 and 90 % of the orange, lemon and citrus crops have been destroyed. The damage that has been done means not only a heavy loss to the growers, but to the transportation companies as well.
Frost is again predicted for tonight and smudge fires are general throughout the district.

S. S. CHESLAKEE FOUNDERS; SIX PERSONS WERE DROWNED

HIT BY A HEAVY SEA, HER CARGO SHIFTED AND THE VESSEL TURNED OVER—SANK NEAR WHARF AT VANANDA, TEXADA ISLAND.

(Special to Daily News.)
Vancouver, Jan. 7.—According to a wireless despatch received here this afternoon, the steamer Cheslakee, of the Union Steamship Company, Captain Charles Cogle, in command, sank today alongside the wharf at Vananda, Texada Island. It is reported that four lives were lost. The Cheslakee, a small steel passenger steamer brought out from England about three years ago and engaged on the loggers' run to Alert Bay, left here at 10 o'clock last night, Vananda being the first port of call. The wireless stated that the Camosun, also owned by the Union Steamship Company, was standing by. The names of those drowned were not given. Three were passengers and one a Chinese cook.

Vancouver, Jan. 7.—The steamer Camosun, of the Union Steamship Company, arrived here tonight from Vananda, bringing details of the foundering of the steamer Cheslakee. According to one of the passengers, the ill fated vessel was backing out from the wharf at Vananda when a heavy sea hit her broadside and shifted her cargo. She keeled badly and an attempt was made to dock the vessel, but before it could be accomplished the boat turned completely over and sank. It is believed that six persons were drowned. CAPTAIN AND CREW IN POLICE COURT TODAY

Member of Crew Charges Captain with Assault, but Does Not Appear to Press the Case.

Mutiny on the high seas, chopping off heads literally not metaphorically, assault and battery, and all kinds of terrible things were talked about in the police court this morning. BRITISH DOCTORS FALLING IN LINE

Nearly Ten Thousand Medical Men Accept Terms of the Insurance Act.

London, Jan. 7.—The Liberal newspapers are exultant over the defeat of the doctors in their fight against the government and are congratulating the Chancellor of the Exchequer on his notable victory.
Mr. Lloyd-George was able definitely to inform the insurance act advisory committee that close to 10,000 doctors had joined panels all over the country and that for seven-eighths of the insured population medical benefit on the panel system was certain. OPENING MEETING OF MUNICIPAL CAMPAIGN

Public Meeting Called by T. D. Pattullo Will Be Held Tonight—Mayor Newton to Speak.

The opening meeting of the municipal campaign for the election of the City Council for 1913 and school trustees will be held tonight in the Westholme Theatre at 8 o'clock sharp. This meeting was called by T. D. Pattullo, the only candidate in the field for mayor at the present moment, before the retirement of Mayor Newton from the contest. The latter, however, having announced himself a candidate for alderman for Ward 2, has been invited to address the meeting and has consented to do so. He will be allowed a full hour to speak.

Aldermanic candidates and candidates for the school board will be given an opportunity of addressing the electorate. As there will be a large list of speakers the meeting is to be called promptly at 8 o'clock. Seats will be reserved for ladies up to that hour. There is no doubt but that there will be a crowded house, as the meeting promises to be a most interesting one. Those who wish to secure seats should go early.

This is Mr. Pattullo's first opportunity of addressing the electorate in the present campaign. He will no doubt give the ratepayers a definite understanding as to his attitude on public issues as they affect the city.

THE HERRING FISHING

Numerous Boats Engaged Despite Rough and Stormy Weather.

Despite the rough weather that has prevailed lately, those engaged in herring fishing in the harbor are staying right with it, in some cases night and day. The run is, if anything, greater than ever known before. The difficulty is to get away with the catch. Today several boats can be seen out on the harbor right opposite the G. T. P. wharf, notably the Fredelia of the cold storage plant, the Yankee Boy and the Rosine, belonging to a Vancouver outfit. L. Crippen, of Boneless Herring fame, is putting up a large quantity of fish with great success for curing in the now well known form of boneless herring that has become so popular wherever it has been introduced. The run will extend well into the middle of March.

FIVE KILLED, FORTY INJURED WRECK ON THE BIG FOUR

FAST PASSENGER TRAIN FROM CINCINNATI TO CHICAGO DERAILED ON CURVE AT HIGH SPEED.

Lafayette, Ind., Jan. 7.—Five persons were killed and forty injured when a fast passenger train on the Big Four left the rails today near Stockwell while rounding a sharp curve at a high speed. The train was bound from Cincinnati to Chicago.

OVER THIRTY LIVES LOST WHEN OIL STEAMER SANK

ONLY FOUR OF A CREW OF THIRTY-SIX WERE RESCUED—THREE WERE TAKEN OFF BY LIFE SAVING STEAMER AND ONE WAS WASHED ASHORE.

Astoria, Jan. 7.—Of thirty-five members of the crew of the ill fated steamer Rosecrans, owned by the Associated Oil Company, which ran on a bar in the Columbia River this morning, only four have been rescued. Three were taken off by the American life saving steamer which was standing ashore six miles from the wreck.

BITTER CREEK HOTEL WRECKED BY WIND

An Avalanche on International Mountain Causes Wind Which Demolishes Hotel

A tremendous snow slide coming off from International mountain, opposite the Bitter Creek townsite, ten miles from Stewart, tore across the Bear River, ending its trail of destruction by ruining the Forks hotel, owned by Harry Gibson, shortly after midnight on Christmas morning. At the time Mr. Gibson and Mr. Peter Ronn were both in bed to be suddenly awakened by a terrific roar as the wind caused by the mighty avalanche swept through the premises, completely wrecking the two storey frame building, tearing out heavy doors and all the windows. The kitchen, stables and other outbuildings were levelled to the ground, as also was the vacant store directly opposite the hotel. The main portion of the building was split in two.

That the two solitary occupants escaped with their lives is little short of miraculous. Mr. Roon who was sleeping on the ground floor near the kitchen, went to Mr. Gibson's quarters immediately after the wind struck the building to find the proprietor unhurt in the centre of a mass of wreckage. The force of the wind was so strong that it literally cleared out the contents of the hotel, everything being covered inches deep with a fine snow. After viewing the wreckage and seeing that nothing could be done, the men walked to Stewart.

GUN-A-NOOT, THE INDIAN OUTLAW, DECIDES NOT TO SURRENDER

THINKS HE WOULD NOT GET A FAIR TRIAL BY A WHITE JURY—IS WELL ARMED WITH REVOLVERS

Hazelton, Jan. 7.—Simon Gun-a-Noot, the Indian outlaw, who for years has successfully defied the police in Northern British Columbia, recently considered the question of giving himself up.

Mr. Lee, however, suggested that if Simon voluntarily handed himself over to the police, the facts which led up to the tragedy would, undoubtedly have weight with a jury, and he might be sentenced only to a few years in the penitentiary.

Mr. Lee told a friend later that Simon was armed with three revolvers—one on each hip and one in a holster in the centre of his belt.

AMBASSADOR'S BODY IS LAID AT REST

Diplomats and Political Leaders and Friends Attend the Funeral.

New York, Jan. 6.—The body of Whitelaw Reid, late United States ambassador to Great Britain, was carried to its last resting place in Sleepy Hollow Cemetery, Tarrytown. President Taft, United States cabinet officers, representatives of the army and navy and British embassy, the bereaved family and hundreds of friends and associates of the late ambassador attended the funeral at the Cathedral of St. John the Divine.

Bishop David H. Greer conducted the service, assisted by Bishop Leonard of Cleveland. Great Britain was represented by her American ambassador, Rt. Hon. James Bryce, and members of his suite and the officers of the cruiser Natal, which brought the body across the Atlantic.

Among others present were Sir Ernest H. Shackleton, polar explorer, representing the Pilgrims of Great Britain, and ex-President Theodore Roosevelt from the American Pilgrims.

Honorary pallbearers included Secretary of State Knox, Ambassador Bryce, Senator Root, Senator Lodge, Judge George Gray, Rear Admiral Cowles and Joseph H. Choate.

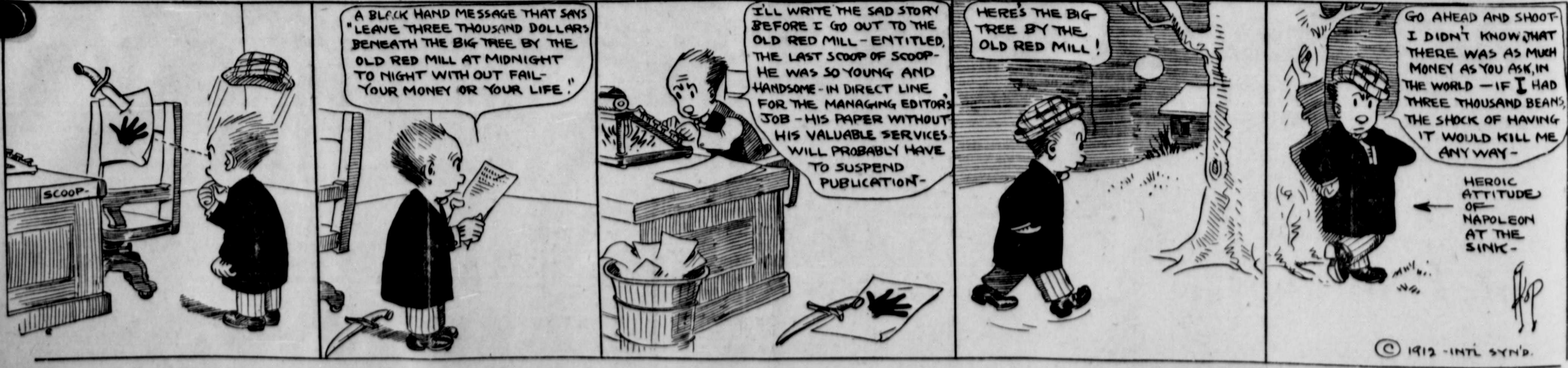

Tom McCarey Offers Englishman First Chance With New Champion

Los Angeles, Jan. 6.—Bombardier Wells may have the first chance at Luther McCarty's newly won ring honors, and at the same time a chance to take the title to England. The proposed Fourth of July international match is squarely up to the Briton today, and promoter McCarey is awaiting a cablegram from Freddie Welsh announcing the result.

If Wells and McCarey are matched, McCarey plans to build a new arena on the site of the present historic fight shed. The new structure would seat 18,000 persons.

WILL CONDUCT RACE TRACKS IN THE WEST

Western Canada Remount Breeding Association Makes Application for Incorporation

Ottawa, Jan. 8.—Application will be made to parliament for an act to incorporate the Western Canada Remount Breeding Association with power to raise, import, export, buy, sell and deal in horses, thoroughbred stock fitted or to be made fitted for use in the army, the R. N. W. M.P., and all other military or semi-military organizations; to establish maintain and conduct, race track grounds, courses, places for the training, racing, and exercising of horses and the establishment of parks and places for athletic contests, games, entertainments and exhibitions in Saskatchewan, Alberta and British Columbia or elsewhere in Canada.

NO MCARTY MATCH FOR GUNBOAT SMITH

San Francisco, Jan. 8.—That Luther McCarty, whose defeat of Al. Palzer in Los Angeles on New Year's Day boosted him in the first rank of heavyweights, may never take on "Gunboat" Smith is the belief among fight followers here today, owing to the bitter differences existing between the managers of the fighters. Billy McCarney, who is handling McCarty, it is said, has turned down Jim Buckley, "Gunboat's" manager, on several occasions because once upon a time McCarty had aspirations to enter the New York field, but was prevented by Buckley.

HUGGINS OFFERS \$4,000 FOR JIMMY SHEEKARD

Chicago, Jan. 8.—Miller Huggins, manager of the St. Louis National League baseball team, has offered the Chicago National League club owners \$4,000 for the veteran outfielder, "Jimmy" Sheekard. President Murphy is considering the offer. He previously had attempted to trade Sheekard to St. Louis for pitchers.

CANNIBALS SLAY AND EAT PLANTERS

Two Brothers Meet Horrible Fate in Wilds of New Guinea—Punitive Expedition to Be Sent.

Sydney, Jan. 8.—Butchered by natives in New Guinea was the fate of two planters named James and Hermann Weber. The men, who were brothers, had their plantation in the heart of the "Nigger Country," and were set upon by a savage tribe of cannibals who came from the unexplored regions inland.

No trace of their bodies has been found and it is thought that they were eaten by the blacks. The news was brought by friendly natives, who state that the same tribe has been carrying on a campaign of butchery throughout the district.

AEROPLANE DESIGNER RESIDING IN RUPERT

Fred Clarke, of the Fishing Smack Rosine, Hopes to Fly Across Vancouver Harbor.

That there is living in Prince Rupert a young man to whom must be ascribed the honor of having built the first aeroplane ever turned out north of San Francisco will be a surprise to most residents of this city. His name is Fred Clarke and he is filling the position of engineer on the gasoline fishing smack Rosine of Vancouver, at present operating seines fishing for herring out in the harbor. Mr. Clarke, who is very well known in Vancouver, in which city he built his aeroplane, had it nearly finished and was awaiting certain parts necessary for its completion when he had the misfortune to have his machine burned up in the fire that recently destroyed the Hoffer boat house at English Bay, where he had it stored. The machine, which was after the English design known as the "Avro," was of the latest model, and a great deal of interest was being taken in its production. Nothing daunted, however, Mr. Clarke, upon completing the season up here with the Rosine, will again undertake the fulfillment of his heart's desire, that of flying his own aeroplane across Vancouver Harbor.

WINNIPEG O'BRIEN WOULD MEET BAYLEY

Prairie Born Boy Has a Good Reputation and Has Never Met Defeat in the Ring.

Calgary, Jan. 8.—Winnipeg O'Brien is asking about the chances for getting matched with either Joe Bayley or Pal Brown in the near future. As Tommy Burns has the "Closed for the Winter" sign tacked up at the Manchester arena, the chances of his appearing here for several months are very remote, but when the lid is again raised he should be considered in the match making. He is a simon pure Canadian product, having been born in Winnipeg. He has a splendid list of victories to his credit, among which are a fifteen round decision over Leo Kossick and a ten round one over Jack Nutt, in which bout the police stopped the men and Referee Tommy Burns awarded the verdict to O'Brien. He also got a draw with Freddie Welsh last year. He has never been defeated and his claim for a bout with Joe Bayley for the lightweight championship should be considered.

LANGFORD COMING HOME VERY SOON

Likely That Tar Baby and Joe Jeanette Will Be Matched by McCarey.

San Francisco, Jan. 8.—Sam Langford, the Boston negro heavyweight who recently knocked out Sam McVey in Australia, is coming to San Francisco about the last of January, according to word received here. Manager Joe Woodman expects to match Langford with Joe Jeanette, the battle to be staged in California. Langford has been away a long time and considerable curiosity is rife among fight fans as to how the Boston black shapes up.

CHAMBER OF MINES SECRETARY RESIGNS

Vancouver, Jan. 8.—Mr. F. J. Crossland, secretary of the Vancouver Chamber of Mines, has handed in his resignation to the executive board. He intends taking a trip to his home in England, from which he has been absent many years. The board is loth to part with Mr. Crossland, who has done good work for the mining industry and the Chamber of Mines. He was asked to reconsider his resignation, but declared that his decision was final.

WAITED HOURS TO REPAIR LIFE BOATS

Passengers of French Steamer St. Augustin Tell of Experiences on Mediterranean.

Bona, Algeria, Jan. 7.—The passengers of the steamer St. Augustin, which foundered recently, deposited a long signed statement concerning the sinking of the vessel at the Commercial Tribunal here. The document says the St. Augustin sailed from Marseilles on December 31st at 1 o'clock in the afternoon. The following day the engineer reported a leak and the water gradually gained, despite the use of the pumps, and at 10 o'clock in the evening extinguished the fires.

The captain then served out life belts and ordered the life boats made ready. This latter operation, the statement says, took four hours, owing to the necessity to execute repairs to the boats before they could be lowered. At 10:30 the following morning the Tyra hove in sight and saw the signals of distress. She took the passengers of the St. Augustin aboard and then began to tow the distressed vessel, but the St. Augustin sank in 2,400 metres of water.

The official statement of the captain of the St. Augustin, which also was deposited at the Commercial Tribunal, says the leak in his vessel probably was due to her striking submerged wreckage.

The steamer Northwestern, belonging to the Alaska Steamship Company of Seattle, went ashore at Valdez at 3 o'clock this morning, but was successfully re-floated at high water. It is not expected that she has suffered much damage.

KLONDIKE PROSPECTOR STAKES HIS LAST CLAIM

Emil Picott, a Well Known Prospector in the North, Found Dead in Bed.

Found dead in his bed at the Knox Hotel yesterday afternoon, Emil Picott, a native of Quebec, who had been a wanderer upon the face of the earth the greater part of his life, cashed in his checks suddenly and dramatically, in keeping with the life he had led for so many years during his sojourn in the north. The deceased, who was 34 years of age, had been ailing for some time. Death was due to heart failure. On Saturday, feeling a pretty sick man, he went to his old Klondike friend, Olie Besner, whom he has known for the last fifteen years, and told him he was afraid he was pretty nearly all in and would like to remain at the hotel for a while. Mr. Besner, realizing the state of the man's health, at once procured the attendance of Dr. Eggert, who had the patient in charge at the time of his demise. He was well enough, however, to attend a picture show with a friend the day before yesterday.

Picott, who hailed from St. Remi, County of Napierville, Quebec, was a tinsmith by trade, but for a number of years had followed the calling of a prospector in the Yukon. A brother of his, also in the Yukon during the palmy days, amassed a fortune, and is at present living in great affluence in the east. The deceased, though at various times acquiring considerable sums of money at the mining business, was one of the great army of prospectors and adventurers who

never hold it very long, new fields always looking green, and who spend in moving to a fresh place what they have made in the old. It was deemed unnecessary to hold an inquest. The remains are in charge of Hayner Bros., awaiting instructions from relatives in the east.

ALLEGED CONSPIRACY TO DEFAUD G. T. P.

Contractor and Tie Inspector Charged with Conspiring to Defraud G. T. P.

There appeared before Stipendiary Magistrate J. H. McMullin yesterday for a preliminary hearing Stanley McNaughton, tie inspector for the G. T. P., and M. G. McLeod, a contractor for supplying ties, upon a charge of fraud upon the railway company. L. W. Patmore represented the company and Alex. Manson the defendants.

The case is somewhat involved and occupied the court the entire day, being proceeded with this morning. The charge is based upon the information of a man named Kelly, who resides in the vicinity of Aldermere. The latter swears that he had heard the contractor say that the only way to make money out of a tie contract was to "fix" the inspector. Other witnesses bore out Kelly's evidence, and it was also stated that the inspector seemed at times particularly flush of money.

One witness, who was supposed to possess very incriminating information in regard to the charge and who had visited the office of the prosecuting counsel in the morning, refused to give evidence when put in the witness box, saying he was under the influence of liquor in the morning when he made the statement in the lawyer's office.

The case is being continued this afternoon.

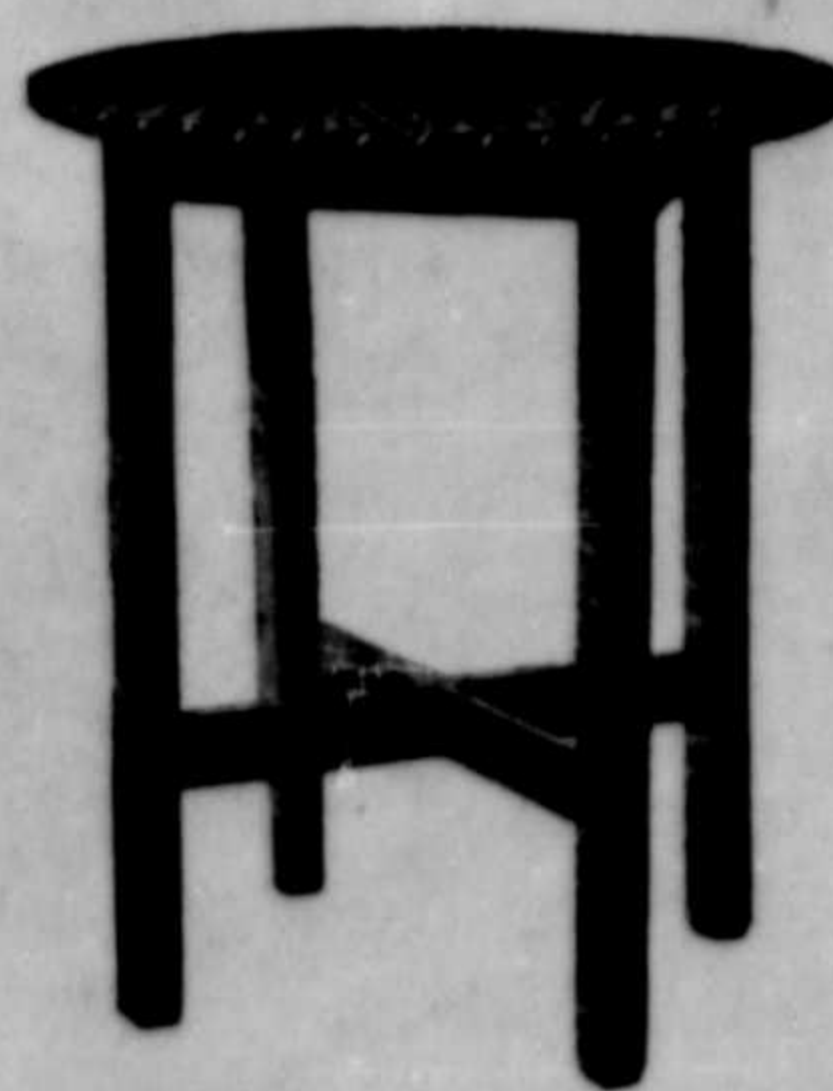

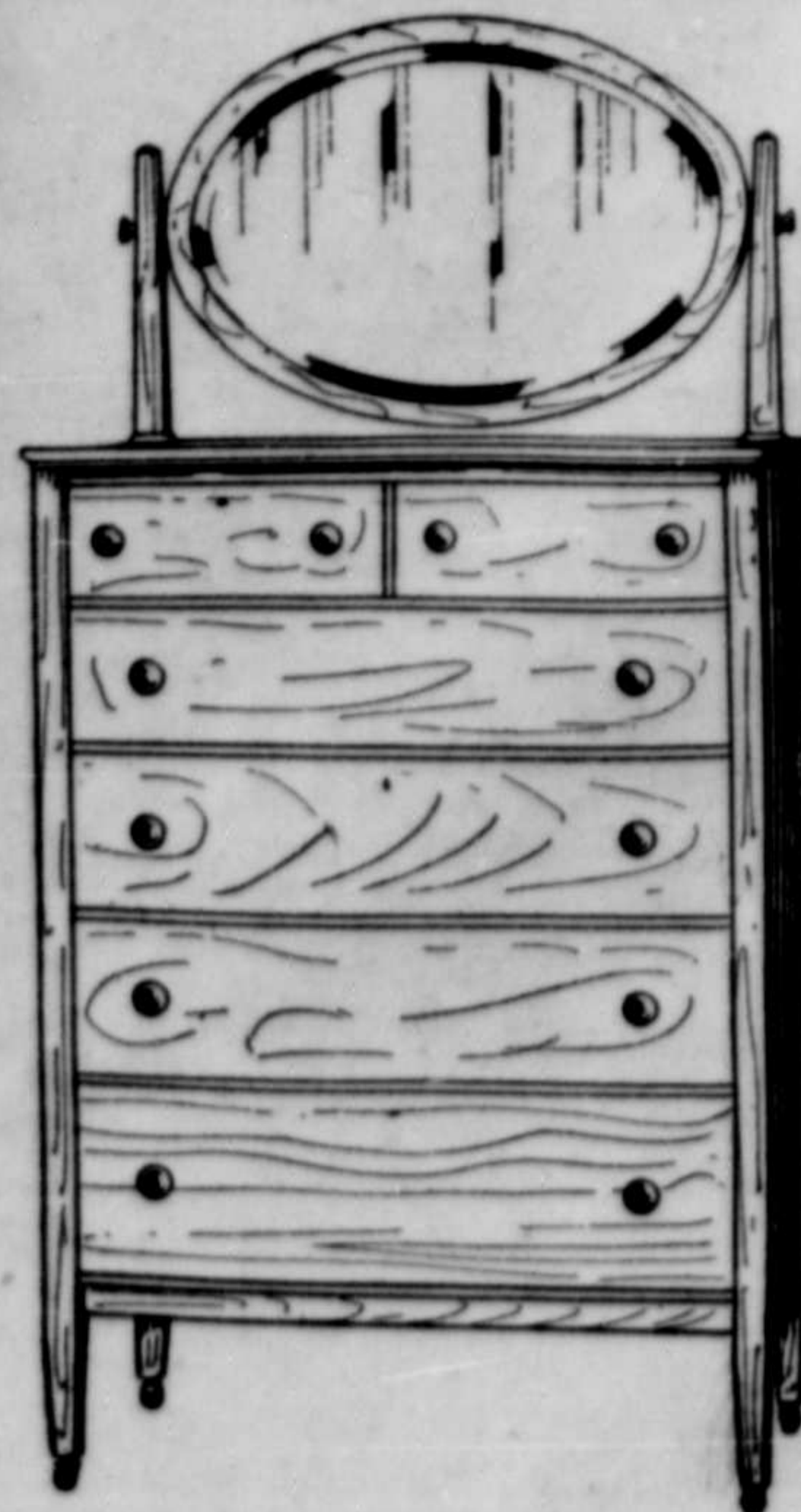

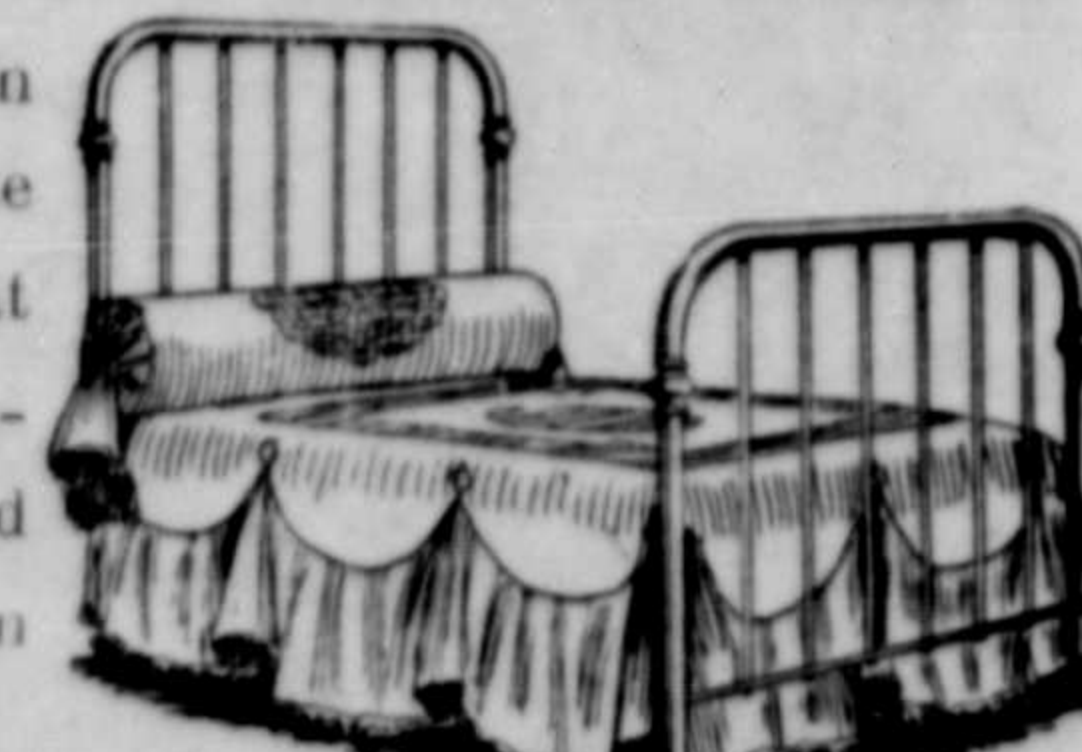
