COAST FISHERIES REGULATIONS ARE CHANGED

Court at Vancouver Decides for Prince Rupert Creditors

Mission Boat Thomas Crosby Wrecked at Queen Charlottes

Craft is a total loss but Capt. Oliver and Mr. and Mrs. Gordon Jolliffe are safe

VANCOUVER, December 7.—A private wireless despatch from Prince Rupert received here Monday afternoon states that the mission steamer Thomas Crosby II was wrecked near Skidegate, Queen Charlotte Islands, in the gale on Saturday. The boat is a total loss, but those on board are safe.

The mission craft was 58 feet long and was gas driven. With her improvements she cost the mission board \$9,000. Captain Oliver, Gordon Jolliffe and Mrs. Jolliffe were the personnel of the boat.

The Thomas Crosby II was the largest of several boats to take the place of the old Thomas Crosby and was designed especially for the Queen Charlotte Islands work. She was here about two weeks ago and was to make her headquarters at Skidegate where Capt. Oliver lives and where a home was to be built for the missionary, Gordon Jolliffe.

The boat was quite new. She was recently purchased in Vancouver for \$7,000, lengthened 10 feet and outfit.

Judge McDonald on Drydock Receiver

Says Vancouver Creditors Took Action after having Asked Others to Stay Hands, but Made No Progress

Will Take Sense of Employees if Prohibition Order Not Withdrawn

OTTAWA, Dec. 7.—A strike ballot is threatened immediately if the order of the Canadian National Railway management is not withdrawn, prohibiting employees from seeking public offices.

FIELD CROPS WERE LARGER

OTTAWA, Dec. 7.—A total value of \$1,636,664,900 for the field crops of Canada during 1920 is reported by the Dominion Bureau of Statistics. This compares favorably with the year 1919 when the figure was \$1,452,437,500. In 1918 the total value was given as \$1,272,935,970.

HODGES IS RECEIVER

Liquidator Appointed by the Court at Vancouver This Morning.

The Supreme Court this morning granted a chambers petition of the Prince Rupert creditors for the appointment of W. E. Hodges as receiver for the Prince Rupert Drydock and Engineering Co., Ltd.

This means that the concern is now in control of the bankruptcy court. A meeting of creditors will be held soon, possibly at Prince Rupert or wherever the court on the recommendation of the liquidator orders.

LEGISLATURE CONVENES ON JANUARY 20

The current number of the B. C. Gazette contains a notice calling the Legislature of B. C. to meet on January 20. Following is the notice in part:

"Now know ye, that for divers causes and considerations, and taking into consideration the ease and convenience of our loving subjects, we have thought fit, by and with the advice of Our executive Council of the Province of British Columbia, to hereby convene you, and each of you, that on Thursday, the twentieth day of January, one thousand nine hundred and twenty-one, you meet Us in Our said Legislature or Parliament of Our said Province, at Our City of Victoria, FOR THE DISPATCH OF BUSINESS, to treat, to act, and conclude upon those things which, in Our Legislature of the Province of British Columbia, by the Common Council of Our said Province may, by the favor of God, be ordained."

COAT DEFENCE TO BE STUDIED

Major-General MacBrien on Way to Prince Rupert in Connection with Problem

VANCOUVER, Dec. 7.—Major-General MacBrien, chief of the Canadian General Staff, accompanied by his aide-de-camp, Major Willis O'Connor, left last night for Prince Rupert on the steamer Prince George. He is making an inspection of all strategic points for coast defences and also taking up the matter of land defences. He will proceed to Ottawa by way of Edmonton and other important centres.

City Council Considers Street Surface Question

Tarvia and Permanent Concrete Discussed and Former Favored; Board of Works to Present Byaw Next Week

The street problem came in for considerable discussion at last night's council meeting and the city engineer, who was called into the meeting, was instructed to draw up estimates for the Tarvia treatment of the downtown streets and submit his figures to the board of works so that a bylaw may be introduced at next Monday's council meeting. This bylaw will cover the surfacing proposition that has been under consideration by the council for some weeks. The original plans have been extended somewhat to provide for the new surfacing on Second and Third Avenues between Eighth and McBride Streets and on Eighth, Sixth, Second and McBride Streets, along First Avenue from McBride to Manson Way, down Manson Way, on Second Street from Third to Pacific Place, and on McBride Street from First Avenue to Fifth Avenue. It is also proposed to surface Sixth street to Fraser Street.

The merits of tarvia and concrete were discussed last night. It was pointed out that permanent concrete streets would require the grading of these streets and the cost would be tremendous. The tarvia surfacing it was considered would be adequate and economical so the idea of permanent concrete as pretty well abandoned. According to the figures submitted by A. E. Foreman the cost of cement would be \$3.60 per yard, not including the foundation, while City Engineer Clements places the cost at \$5 per yard. Tarvia could be used as a foundation for permanent streets when the time came for building them.

MICKEY DISCOVERS THAT HE IS A GIRL

Never Wore Dresses Until a Few Days Ago But is Now Named Mary.

The story of the fourteen-year-old boy who suddenly awoke to the fact that he was a girl, is exciting great interest in Winnipeg. The child has worked on a farm for over a year as a chore boy for Mr. and Mrs. Fred Smith, near the city. She wore boy's clothes and did not seem to know how to wear any other.

She is now named Mary and is in charge of one of the societies that care for destitute children.

Change Fisheries Regulations 1921

Boundaries defined for Naas gill netting; size of mesh for salmon and smelt reduced; Captain's licenses

VANCOUVER, December 7.—The 1921 fisheries regulations have been issued by the Department at Ottawa and they make a number of changes over those of last year. In regard to the Naas River district, a line drawn from Boston to Parkin Islands is to be the outside boundary of the Naas River sockeye gill net fishing.

The regulations also call for a cod fishing close season from January 15 to March 15 in the Gulf of Georgia and adjacent waters between the American boundary on the south and a line east and west from Duval Point in Johnstone Straits to the West-erly entrance to Wells Pass.

According to the amended regulations smelt gill nets and seines are now not to be under one inch instead of an inch and a quarter in the former regulations and an inch and a half in the wings.

Salmon Gill Nets.
 In salmon gill net fishing the mesh is to be not less than six and a half inches instead of seven inches as at present.

The amended regulation reduces the size of the salmon drag seine from 300 fathoms length and a three-inch mesh extension measure, to one hundred fathoms and limits the depth to 180 meshes.

In future all captains of seine boats must obtain a license before operating, but the license fees will be refunded.

Apart from the waters contiguous to the south end of Vancouver Island and Portland Inlet, no salmon trap net licenses will be issued.

EDITOR MOBBED FORCED TO KISS THE UNION JACK

MONCTON, N. B., Dec. 7.—Lindsay Crawford of Toronto, editor of the Statesman, a journal that is very anti-imperialistic in its tone and openly advocates the independence of Canada, was not allowed to speak here at an advertised meeting last night. After the meeting broke up he was mobbed, forced to kiss the Union Jack and then given until the first train to get out of the city.

PARADISE FOR BOOTLEGGERS

Federal Prohibition Commissioner Says Ketchikan is a Bad Town

INFLEX OF WHISKY FROM CANADIAN SIDE

TACOMA, Dec. 7.—"Alaska is a paradise for bootleggers," said Donald A. McDonald, federal prohibition director for Washington and Alaska in an interview here.

"Over fifty bootleggers are openly plying their trade at Ketchikan alone," declared the official. "The underworld is running without restraint and the dry element of Alaska is up in arms. I receive many letters protesting against the influx of whisky into Alaska from Canada."

HARDISTRY MAN AND DAUGHTERS FIRE VICTIMS

Guy Paterson Loses Life Trying to Save His Little Children.

EDMONTON, December 7.—Guy Paterson, a pioneer of Hardistry, and two young daughters, seven and four years of age respectively, were burned to death here when the Paterson home was destroyed by fire.

Mr. Paterson's efforts to save his eldest daughter were successful and it was in a desperate effort to rescue the other two that he died with them.

Mrs. Paterson was badly burned in an effort to save the family.

NEW HAZELTON RESIDENT DIES

W. J. MacKenzie, Merchant and Old Timer here Passes Away

NEW HAZELTON, Dec. 7.—The death occurred here yesterday of W. J. MacKenzie, a merchant of this place and an old timer who was well known and highly respected throughout the country. He formerly was employed in Prince Rupert by Foley, Welch & Stewart and is a considerable property owner in Rupert.

Mr. MacKenzie's son Walter L. was secretary of the Prince Rupert Liberal Association during the recent campaign and another son, Major MacKenzie, is connected with the Whalen Pulp and Paper Co. at Swanson Bay. Both men served overseas.

Mrs. MacKenzie, wife of deceased, died about two years ago. Both were Presbyterians and Mr. MacKenzie was a life long Liberal.

On the other hand it must be admitted that the democratic form of Government is not always a success.

Survival of Fittest Yet.

We have not yet got very far from the old method of the survival of the fittest. The old method exterminated the weakling. Today the weakling is carefully preserved and then exploited.

Seeing all this, there is a section of the community that says it is all bad, rotten to the core, and the only cure is to do away with the present competitive system.

There seems little doubt but the present competitive system must be superseded. It is unthinkable that the system of today is the last word in government and in the general conduct of human affairs.

Constant Adjustments Have to be Made.

Under any system there has to be constant adjustment. We are in a mobile condition. During several years there have been increasing costs of living and many have made fortunes.

As we have said, business has been prosperous for several years. Now we are hearing of failures, and the failure of one often drags down others.

It will take a great deal of mutual forbearance in this trying time to get once more to a solid basis.

CHINAMAN SUES A LONDON POLICEMAN AND WINS HIS CASE

LONDON, Dec. 7.—A London policeman, Sergeant Culling, of the Metropolitan force, was fined £5 for assaulting a Chinaman and ordered to repay £22 taken at the time of the assault.

The plaintiff, Chong Sin, said that he and other Chinamen were smoking opium at Silver Lion Court, Limehouse, when the police entered and pretended to search for opium.

The defendant went to a trunk and took from it £22 in Treasury notes and silver. The police then "set about" the Chinamen and they jumped out of a window. The Chinamen re-entered the house and the plaintiff was hurled downstairs by the police.

The defense was that the police in the execution of their duty had made a raid on the premises and that the injuries which the plaintiff said were due to an assault were caused by his jumping out of the window. A witness named Mok Sin, who had been sentenced to a term of imprisonment to be followed by deportation, said that he was on the premises during the visit of the police.

The police took the money from the box and the defendant pushed the plaintiff downstairs. In cross-examination the witness said that he had lived in England for eight years in the Silver Lion Court premises. He had been convicted of gambling and opium smoking there.

Denied Charge

The defendant said that he had been in the police force for 15 years and no complaint had ever been made against him. He denied that he took the money and that he had pushed the plaintiff downstairs. Mr. Justice Bailhache, in summing up, said that

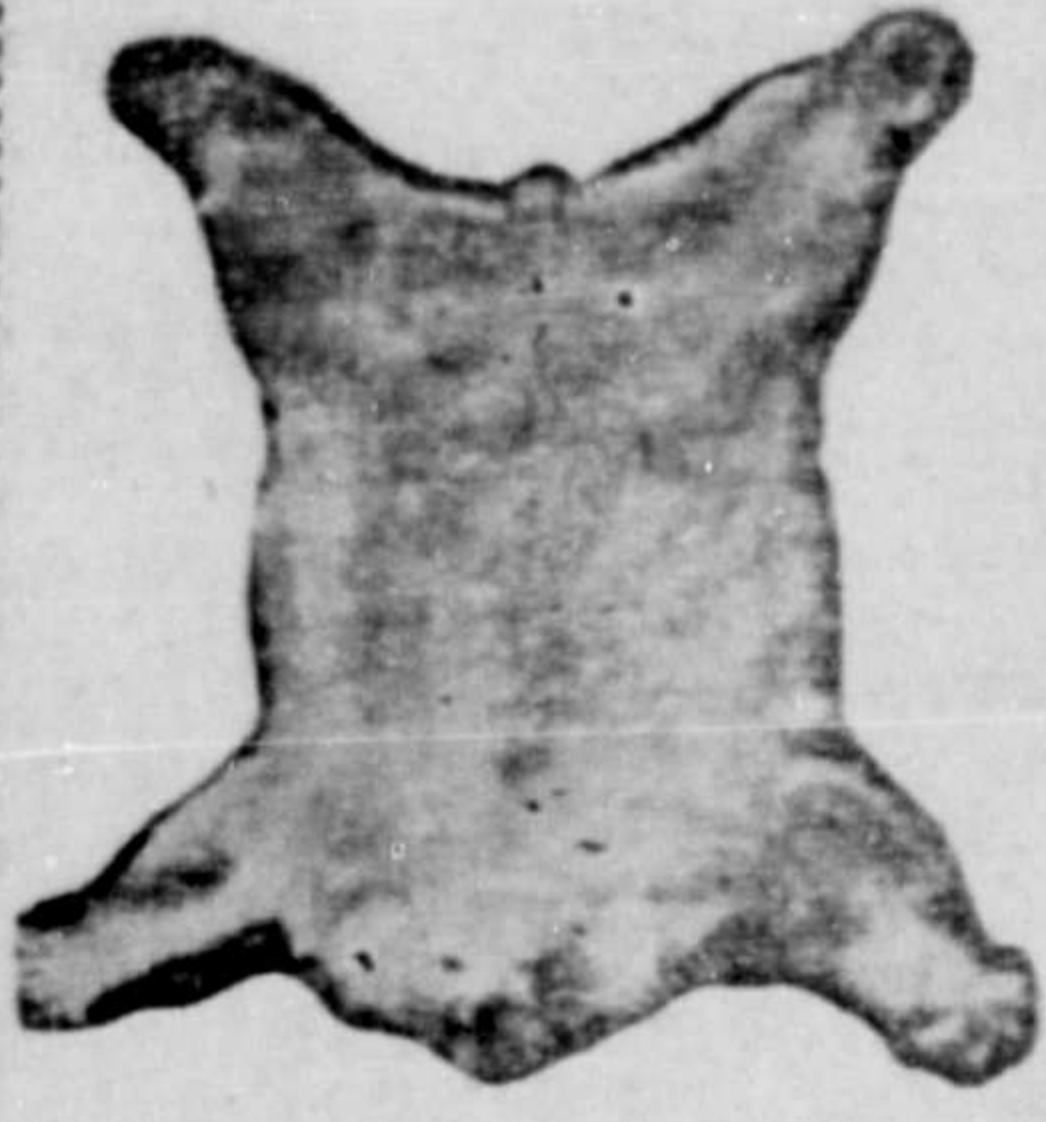

WHEAT CROP MAY BE POOLED

Canadian Council of Agriculture Considering Plans for Marketing 1921 Output.

WINNIPEG, Dec. 7.—Indications are that the meeting of the Canadian Council of Agriculture in Winnipeg today and tomorrow may decide to put into operation a co-operative pooling agency for handling the 1921 wheat crop.

Details of a plan to handle the enormous amount of grain produced will be reported to the council by a committee consisting of H. W. Wood, Alberta; F. W. Riddell, general manager of the Saskatchewan Co-operative Elevator company, and J. R. Murray, assistant general manager of the United Grain Growers, Limited.

According to information supplied, agricultural authorities have proved that an overwhelming opinion among farmers in all parts of the west favors the adoption of the pooling plan.

With regard to the proposed grain pooling agency to handle buying and selling of the wheat crop, officials point out that the meeting of the shareholders of the United Grain Growers, Limited, and the Saskatchewan co-operative elevator companies, held in Calgary and Regina, endorsed the proposal as outlined by members of the committee appointed by the council to investigate.

A meeting of the secretaries of the local Saskatchewan farmers' organizations took similar action.

SHOT SHERIFF AND IS HIMSELF NEARLY DEAD

SANTA ROSA, Cal., Dec. 7.—George Boyd, accused of having shot and killed Sheriff Petray of Sonoma county and two detectives Sunday, when officers attempted to arrest him, was hovering near death in the county jail today.

Boyd was shot by a sergeant of police after the policemen had fallen fatally wounded.

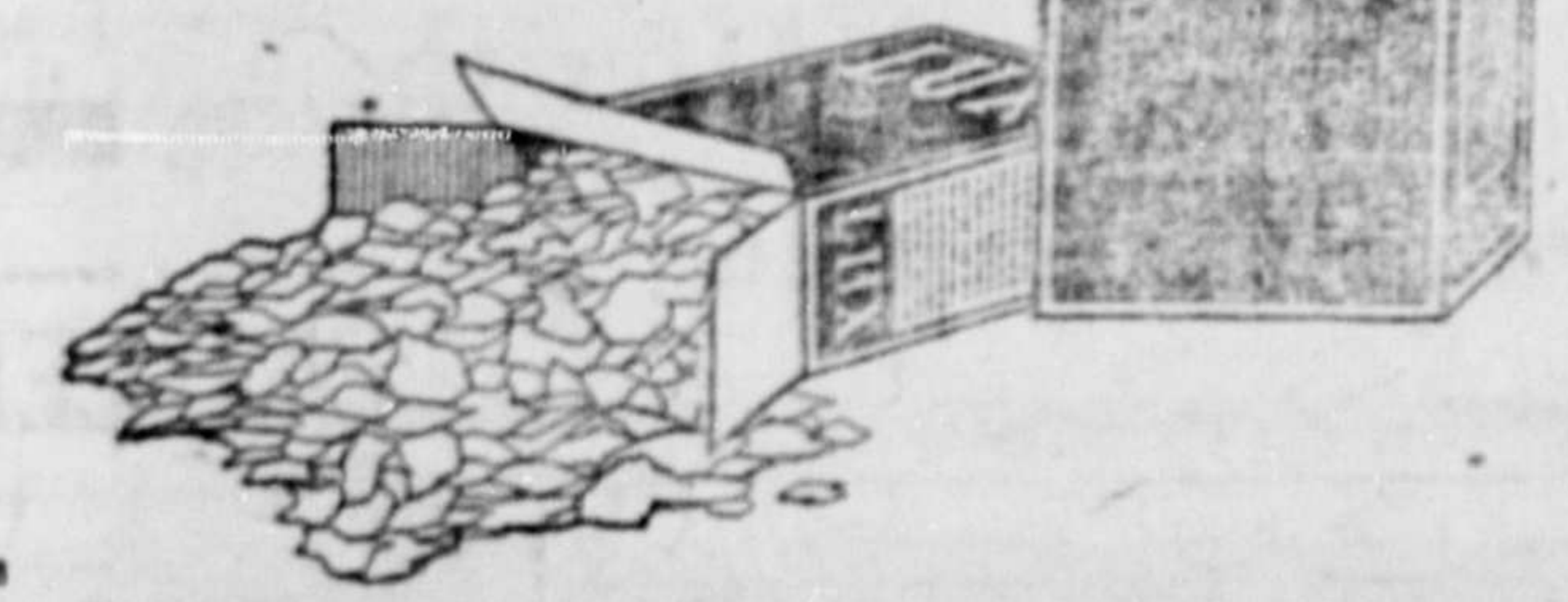
