## ITALIANS DELIVER SMASHING BLOW TO HUN

INFILCT TREMENDOUS LOSSES--RUSSIANS AND GERMANS TREAT FOR ARMISTICE

### HUNS SUFFER APPALLING CASUALTIES

**Italians Resume Offensive, and Smash First and Second German Lines--Awful Casualties.**

(Special to The Daily News.)

Rome, Nov. 29.—Within the last twenty-four hours, the Italian troops have assumed the offensive and have smashed the first and second lines of the Austro-German forces. Tremendous losses have been inflicted upon the invaders. Immediate counter attacks were commenced to beat back the attacks of the Italian troops, but so appalling have been the casualties suffered by the enemy in these fruitless attacks that it was reported today that he had withdrawn seven crippled divisions.

**The British Drive.**

London, Nov. 29.—The meagre reports of the progress of the drive of the British troops upon Cambrai indicates clearly that General Byng's forces are aiming at a great circling movement with a wide wedge driven into the Cambrai front. General Byng is apparently working his way behind the German lines on his west flank.

### SIR WILFRID LAURIER SPEAKS IN OTTAWA

(Special to The Daily News.) Ottawa, Nov. 29.—Sir Wilfrid Laurier spoke here last night to a tremendous crowd which filled the Russell Theatre. Outside there was a long line of people, who vainly sought admittance. The meeting was an enthusiastic one, and greeted the veteran statesman with a great ovation when he stepped upon the platform.

In his speech, Sir Wilfrid replied to Sir Robert Borden's charges that he did not aid recruiting, and he warmly repudiated the suggestion that he was dominated by Henri Bourassa either in his policy or in his actions. It was impossible for Sir Wilfrid to have joined the National Board after Sir Thomas Tait had quit the job. The lukewarmness of Quebec, Sir Wilfrid said, could only be blamed upon the Conservative national propaganda, which was carried out in that province to extreme lengths.

### GRAND JURY SWORN IN AT THE ASSIZE COURT

The first sitting of the Assize Court took place this morning in the Court House. Before Mr. Justice Clement, who will judge the cases brought up, which only number three, the grand jury took the oath. The jury consists of Messrs. C. A. G. Armstrong, Harry Atkins, William Barrie, H. B. Belknap, John Bulger, John C. Gavigan, C. T. Heward, R. O. Jennings, T. H. Johnston, J. W. Potter, H. B. Rochester, and Douglas Sutherland. The name of A. J. Prudhomme was also on the list, but on account of travel difficulties, he was not present. Mr. H. B. Rochester was elected to be foreman.

In addressing the jury, Mr. Justice Clement told them of the two sides of their work, one of which affected the court primarily in connection with the administration of justice. In addition, the jury is supposed to have a knowledge of the needs of the district, and were entitled to make a presentation of the manner in which matters of public importance were being carried on. These presentations, Mr. Justice Clement will see reach the proper destination, whether the Government at Victoria or at Ottawa.

In the matter of bringing in a true bill, the Court pointed out that the rule of giving the benefit of the doubt to the prisoner did not apply. Rather the benefit of the doubt should go to the public. The grand jury did not try the cases. Their duties were to decide whether the cases were of sufficient importance to come before the court. The decisions of the grand jury were final and no one had any power to check them up.

His Lordship mentioned the cases before the court, and gave the jury today to consider them. They will report their decisions tomorrow morning when the court sits again.

### SATAN Abdicates in Favor of the Kaiser

**Scathing and Bitter Satire of the Ruler of Germany by an American Writer.**

Louis Syberkrop of Creston, Iowa, has acquired much fame in recent weeks as author of a satire on Kaiser Wilhelm. Requests have come to him from Tumult, Secretary Daniels and Roosevelt, and people in every state of the Union and in Canada for copies of his article. It follows:

"Ottumwa, Iowa,

"The Internal Region,

"June 2, 1917.

"To Wilhelm von Hohenzollern, King of Prussia, Emperor of all Germany and Envoy Extraordinary of Almighty God:

"My Dear Wilhelm—I can call you that familiar name, for I have always been very close to you; much closer than you could ever know.

"From the time that you were yet an undeveloped being in your mother's womb I have shaped your destiny for my own purpose.

**Makes Her Blush.**

"In the days of Rome I created a rough-neck known in history as Nero. He was a vulgar person and suited my purpose at that particular time. In these modern days a classic demon and efficient super-criminal was needed, and as I know the Hohenzollern blood, I picked you as my special instrument to place on earth an annex to hell.

"I gave you abnormal ambition, likewise an oversupply of egotism that you might not discover your own failings. I twisted your mind to that of a madman, with certain normal tendencies to carry you by—a most dangerous character placed in power. I gave you the power of a hypnotist and a certain magnetic force that you might sway your people.

**Embittered by Deformity.**

"I am responsible for the deformed arm that hangs helpless on your left, for your crippled condition embitters your life and destroys all noble impulses that might otherwise cause me anxiety, but your strong arm is driven by your ambition that squelches all sentiment and pity. I placed in your soul a deep hatred for all things English, for of all nations on earth I hate England most. Wherever England plants her flag she brings order out of chaos, and the hated Cross follows the Union Jack. Under her rule wild tribes become tillers of the soil and in due time practical citizens. She is the great civilizer of the globe and I HATE HER. I planted in your soul a cruel hatred for your mother, because SHE was English, and left my good friend Bismarck to fan the flame I had kindled. Recent history proves how well our work was done. It broke your royal mother's heart, but I gained my purpose.

"The inherited disease of the Hohenzollerns killed your father, just as it will kill you, and you became the ruler of Germany and a tool of mine sooner than I expected.

**Three Evil Spirits.**

"To assist you and further hasten my work I sent you three evil spirits—Nietzsche, Trotschke and later Bernhardi—whose teachings inflamed the youths of Germany, who in good time would be willing and loyal subjects and eager to spill their blood and pull your chestnuts, yours and mine. The spell has been perfect—you cast your ambitious eyes toward the Mediterranean, Egypt, India and the Dardanelles, and you began your great railway to Bagdad, but the ambitious archduke and his more ambitious wife stood in your way. ### RUSSIANS ARE NEGOTIATING WITH GERMANS

**Bolshevik Leaders and German Military Authorities Will Hold Conference on December 2nd.**

(Special to The Daily News.)

London, Nov. 29.—Contact has been established between the Bolshevik leaders in Russia and the German military authorities and negotiations for an armistice are now in full swing behind the German lines.

**December 2nd.**

Petrograd, Nov. 29.—It has been announced officially at the Smolny Institute, the headquarters of the Bolsheviks, that representatives of Ensign Krylinko, the Bolshevik commander in chief, has crossed to the German side and entered into negotiations with the German military authorities. The German Government has named December 2nd as the date when they will be prepared to hold a conference with the Russian representatives with the view of entering into negotiations for an armistice.

**Peace Criminal.**

London, Nov. 29.—"It would be criminal to make peace with the Germans in their present state of mind," says Lord Cecil, the British Minister of Blockade. "The spirit of the Kaiser's Government is the same now as it was three years ago, although the vaunted invincibility of the German army has been proved to be a myth. History has nothing to show which can equal the British blockade."





## POINTS OF INTEREST FOR INTENDING VOTERS

(Continued From Page One.)

There are many points about the Dominion elections act as affected by the war time elections act and the new provisions which will be applicable to the voting in the coming elections.

The following are some points which will be of interest to the voters in the coming federal election:

Where provincial requirements as to residence cannot be applied at the time of making the lists the residential qualifications of voters is one year in the province and thirty days in the electoral district prior to the issuance of the writ of election.

Wives, widows, mothers, sisters and daughters of persons, male or female, alive or dead, who are serving or who have served outside of Canada in any of the military forces of Canada or Great Britain or within or without Canada in any of the naval forces, excepting such female relatives of persons who have ceased service in otherwise than an honorable manner are entitled to vote. No such relatives of persons who have joined the naval forces of Canada since the passing of the war time election act on September 20, 1917, will have the vote.

## Lists to be Posted.

Fifteen days before the polling day (Dec. 17) lists of the voters in each polling subdivision will be posted in said subdivision. The enumerators then sit two hours per day for ten days preceding polling day to revise the list, answer inquiries and execute transfers of votes of election officers and agents whose duties may take them away from the polling subdivision on election day. Up to five days before election the enumerator may upon the representation of any credible person add or strike off the lists any name.

election day electors whose names are not on the lists may appear before the enumerator who sits within or near the polling place. If they are entitled to vote they are given certificates. Any person who is refused a certificate may demand and obtain a written refusal which entitles him to a ballot which is sealed in a envelope and not counted excepting in case of a recount and then only upon proof of his right to vote. Voiles of persons challenged are treated in the same manner.

There is an enumerator in each polling subdivision. Entirely new lists are being made out in Prince Rupert. The lists when completed will be posted outside the polling booths or outside the post office.

## May be Sworn.

Every person, whose name is on the list, can be sworn by candidate, agent, or elector, and if the oath is refused the voter loses the right to cast a vote in the election. The oath is:

"You swear that you are legally qualified to vote at this election, that you are of the (male or female) sex, a British subject, resident of Canada, and of the full age of 21 years. (In case of a female voter the following is added): You do further swear that you are the (wife, widow, mother, sister or daughter as the case may be) of a person who is serving or has served without Canada in the military forces (or within or without Canada in the naval forces) of Canada or of Great Britain in the present war."

The following people are unqualified to vote:

The judges of every court whose appointment rests with the governor-in-council;

Persons disenfranchised for corrupt practices under the act;

Criminals, lunatics, inmates of poor houses and such institutions;

Any person who has applied for exemption from military service on conscientious grounds and who has not been refused;

All Mennonites and Doukhobors excepting those who may have enlisted;

Every naturalized British subject who was born in an enemy country and naturalized subsequent to March, 1902, excepting those who have enlisted and served out of Canada in the Canadian or British armies, or in or without Canada in the navy; or have tried to enlist and been refused because medically unfit; or those who are grandparents, parents, sons, or brothers of such as who have so enlisted or tried to enlist; or those who are or have been during the present war members of the parliament of Canada or any province; or those Syrians and Armenians who are Christians; or those who are females entitled to the vote through relationship to a soldier.

Every person who has been convicted of an offense against the military service act has no vote.
