## SIR WILFRED TAKES VANCOUVER BY STORM

### THIRTY THOUSAND APPLY FOR ADMISSION TO HEAR CANADA'S GREAT MAN

#### THE FATE OF VENICE NOW HANGS IN THE BALANCE

CITY IS NOW AN UNAPPROACHABLE ISLAND TO WITHSTAND SIEGE—ALL ART TREASURES ARE IN SAFETY AND THE POPULATION DEPARTED—BRITISH POSITIONS IMPROVED—FIGHTING IN CHAMPAGNE

(Special to The Daily News.)

Rome, Dec. 15.—The fate of Venice now hangs in the balance. On the outcome of the Italian battles depends the destiny of the Queen of cities. The Romans will expend their last drop of blood in her defence. The city is now being converted into an unapproachable island to withstand the siege. The Venetian plains now constitute a veritable labyrinth of defences. All the art treasures of Venice have been carried away to places of safety or else buried under mountains of sand bags. Most of the population of the city has departed.

#### German Reinforcements.

London, Dec. 15.—Owing to Russia's disintegration and the Italian defeats, the enemy is now able to put larger forces than ever on the French front. There are now a hundred and fifty German divisions, equal to about two million, two hundred and fifty thousand men, on the western front, and seventy-nine divisions on the eastern front. "We must expect half a million fresh German fighters on the western front and many more guns and air craft," declared the Times' military critic, Colonel Repington, in an article today emphatically warning the nation that Germany was preparing for her supreme military effort there.

#### British Front.

The British have improved their positions to the east of Bullecourt as the result of bomb fighting last night. The enemy artillery is active at different points south of the Scarpe and

also to the northeast of Ypres.

#### Russian Prisoners.

Petrograd, Dec. 15.—The Russian authorities have ordered the release of civilian German prisoners in exchange for four thousand Russian officers in German prisons. It is reported that the Russian troops have been ordered to evacuate Finland. The independence of Finland is said to be recognized. A warning has been issued to Kerensky that if he does not surrender voluntarily immediately, he may be lynched if found.

#### French Front.

Paris, Dec. 15.—Artillery fighting occurred last night in the Champagne district. Nothing else is reported.

#### Berlin's Report.

Berlin, Dec. 15.—The British troops endeavoring to recapture their lost trenches at Bulle court on the Cambrai front, were beaten back. The French artillery fire has increased on the east front.

#### VICTORY IS NOW A QUESTION OF SHIPS

In view of the facilities which exist in Prince Rupert for the building of ships, and which have never been utilized by the G.T.P. Development Co., Ltd., nor taken over by the Borden government, the following dispatch received today is of interest. The dispatch reads:

"London, December 15.—Lloyd George in a speech last night at the Lawyers' Club says victory is now a question of tonnage. NOTHING BUT SHORTAGE OF SHIPS CAN OVERPOWER THE ALLIES."

This is nothing new. The Borden government have known what all the people of Canada know, that the allies require ships, ships and still more ships. Prince Rupert has a ship shed, and other splendid locations for slips for laying down ships of any size. How the Borden government have risen to the occasion in Prince Rupert needs no further comment.

Ottawa, Dec. 15.—With the close of the Dominion campaign, practically at hand it looks as though there will be twenty-five seats in which there will be no contest. Ten of these are Unionist, and the Liberals will have fifteen seats by acclamation.

#### LAURIER SPEAKS TO FIVE MEETINGS IN VANCOUVER

THOUSANDS HEAR THE VETERAN CANADIAN STATESMAN AND THOUSANDS MORE FAIL TO OBTAIN ADMISSION—TREMENDOUS ENTHUSIASM AMONGST VANCOUVER PEOPLE FOR GRAND OLD MAN

(Special to The Daily News.)

Vancouver, Dec. 15.—Making his first visit to Vancouver since 1910, Sir Wilfrid Laurier arrived here yesterday morning on board the Imperial Limited. Great crowds, surpassing even those which greeted him at Winnipeg, Regina or Calgary, greeted his arrival in the most enthusiastic manner. His reception in Vancouver was simply great.

In less than nine hours, he spoke to five gatherings of the electors, upon the real issues which are before the Dominion at this present time. One of the meetings was held in the great ballroom of the Hotel Vancouver, and was exclusively for women. They filled the big room to overflowing to which admission was only to be had by ticket. This was the great Liberal leader's first and longest address. From there, he went to four of the largest theatres in the city, which were crammed to the limit of their capacity with supporters and admirers of Sir Wilfrid. In all he spoke to ten thousand persons, and thousands were turned away disappointed, unable to get accommodation in the various buildings. Everywhere Sir Wilfrid was received with hearty cheers and was listened to with close attention.

#### Conscription.

Sir Wilfrid devoted the greater part of the time to the conscription issue. He declared that by persuasion, and not by coercion, he would bring the province of Quebec into line with the other provinces of the Dominion in the matter of enlistment. He held that the Borden government was responsible for the showing made by Quebec, and charged that there had been an alliance between the Conservatives and the Nationalists, which had spent the Conservatives' money teaching Quebec not to fight in the Empire's wars. "I am called a quitter," said Sir Wilfrid. "It is said that if Laurier wins the election, Canada quits the war."

#### To the Finish.

"I answer that if Laurier wins, Canada is still in the war, and then in the war to the finish. From the day on which war broke out, I stood behind the government in all measures to help to win the war. I never intended to give the government a slavish support, whether right or wrong, but I gave it the support of a free British

subject, which I am. Sir Robert Borden stated that the Military Service Bill became necessary because the voluntary enlistment had broken down. I denied that that reason was a good one, and stated that in the ten months that preceded the introduction of conscription into the House of Commons, enlistment under the voluntary system had reached to between six and seven thousand men monthly, which was quite ample to provide reinforcements.

#### The Blame.

"My countrymen know how to fight, when they want to fight. At the same time, I must say that Quebec has not done as well as the other provinces in the matter of enlistment. But the blame rests altogether upon the shoulders and upon the conscience of the Borden government. They created the sentiment that exists in Quebec. The Conservatives in 1911 concluded an alliance with Bourassa and the Quebec Nationalists to carry on a war against Laurier. The creed of the Nationalists was that under no circumstances should Canada participate in the wars of Great Britain. Blondin and Sevigny preached this doctrine and the Conservatives financed it.

#### Tory Money.

"There was an alliance of this kind, but later it fell apart and the truth came out. It was Tory money that taught the people of Quebec never to participate in the Empire's wars. I want Frenchmen to fight. I will make them fight, and I hope, by persuasion. When their passions and prejudices have been aroused, the way to undo the evil is not by compulsion. The way is to appeal to reason and sentiment, to mind and heart.

#### Common Nationality.

"The methods followed by the Laurier government in the past will be the ones followed in the future by the Laurier government. I stand upon the broad principles of Canadian nationality. I am not appealing to any creed, nor any race, but simply to our common nationality and Canadian citizenship."

## COLONEL TELLS WHY MORE SOLDIERS NEEDED

To Make Jobs for Officers—Says Borden Purposely Killed Recruiting.

Windsor, Ont., Dec. 10.—Lieut.-Col. T. B. Welch, who recruited the 99th battalion and took it overseas, took the platform here in the interests of W. C. Kennedy, the Laurier Liberal candidate. Lieut.-Col. Welch declared that he had resigned his command at the Windsor mobilization centre in order to be in a position to protest against the cry of the Union government supporters that Canadians who voted for Liberals would be disloyal.

The appearance of Lieut.-Col. Welch in the political arena was most unexpected, and especially by the followers of Lieut.-Col. Wigle, the Unionist candidate. Lieut.-Col. Welch in his speech, charged that the Borden government had purposely killed voluntary enlistment by withdrawing the machinery with which to obtain recruits.

"We recruited more than 3,000 men here in Windsor," he said, "and could have got that many more if the government had not thrown a monkey wrench into the machinery."

He declared it was impossible for the Dominion to maintain five divisions at the front.

"The militia department is keeping five divisions in France to satisfy the ambitions of officers who sought high commands," he declared. "Thousands of dollars were squandered by the militia department. Canadian soldiers have nothing to thank the Borden government for."

### KRUPPS OPEN BRANCH IN SWITZERLAND

Geneva, Dec. 10.—Germany's great gun-makers, the Krupps, have opened a branch factory at Lucerne with a capital of thirty million marks. The directors registered included Arthur Krupp and Counsellor Ernest Hauer, director of the principal Krupp factories at Essen. In compliance with the Swiss law providing that when new enterprises are established their objects must be set forth, the company declares its purpose to be the fabrication of arms, cannon and munitions of war, the acquisition of factories, mines and metals, and also their sale.

The Krupps already have purchased several houses and a large amount of ground at Lucerne. Sixty-four expert employees have arrived there, and three hundred others are expected shortly.
