OTTAWA PROPOSAL TO TOW DRYDOCK TO VANCOUVER IS OPPOSED BY MR. PATTULLO

MEMBER FOR THIS DISTRICT WIRES AT ONCE ASKING FOR INSURANCE THAT NO SUCH ACTION IS CONTEMPLATED BY AUTHORITIES

(Special to The News via G. T. P. Telegraphs.)

Victoria, June 2.—It is reported from Vancouver that Hon. C. C. Ballantyne has suggested to Harbor Commissioner Fullerton that the drydock at Prince Rupert be towed to Vancouver in order to relieve the situation there.

Immediately Hon. T. D. Pattullo heard of the suggestion, he wired to Mr. Ballantyne at Ottawa as follows:—

"Vancouver paper reports Harbor Commissioner Fullerton as stating that you had suggested the removal of the Prince Rupert drydock to Vancouver as a possible solution of the Vancouver difficulty.

"Northern British Columbia has felt that the north has always been discriminated against and that your giving of the contract for the construction of two ships there was the first recognition of the just right of Northern B. C. Many people went to Prince Rupert upon representations which have never been carried out and the north would deeply resent any action along the lines reported."

"I should appreciate an assurance that no such action will be taken."

GERMANS MUST SIGN TREATY SAYS PREMIER

If Not Done at Versailles it Will Be Signed at Berlin.

Paris, June 2.—In a speech at Amiens dealing with the problems of peace and the prospect of Germany meeting the conditions laid down by the Allies, Premier Lloyd George declared that the Allies were prepared to say to the Germans: "Gentlemen, you must sign. If you do not sign in Versailles, you will sign in Berlin. We are not going to give way."

JAPANESE WILL IRRIGATE RICE LANDS OF KOREA

Capitalists Being Encouraged to Put in Irrigation Works in That Country to Increase Food Supply.

Tokio, Japan, June 2.—The Japanese Government is entering into an arrangement with a number of Japanese financiers to undertake extensive irrigation works in Korea in the province of Chosen. Large stretches of waste land is to be converted into paddy fields for the growing of rice, which is the chief food of this country and Korea. The work is to be conducted on a very large scale, and is encouraged as being one solution of the food problem in this country.

It is roughly computed that there are in Chosen 2,500,000 acres of waste land, which can be made into fertile fields if enough water is supplied to it. Even now Chosen can export to Japan 2,000,000 to 3,000,000 koku (5.12 bushels) of rice a year, in spite of the fact that, owing to unsatisfactory methods of cultivation pursued, the amount of grain obtained from Korean fields is less than two-thirds of that obtained from the same area of land in Japan. When the Korean fields are made as productive as the Japanese and when the extensive waste land now useless is made arable, Chosen will be able annually to supply Japan at least 10,000,000 koku of good rice.

This expectation is by no means visionary. In a normal year Chosen produces at least 12,000,000 koku of rice, and this in spite of the unsatisfactory methods of cultivation pursued by Korean farmers.

In Japan, during the past ten years, the amount of rice crops annually obtained has increased by 10,000,000 koku. This good result has been attained not so much by the opening of new fields as by the improvement introduced in the methods of cultivation. In other words, thanks to the more scientific methods of cultivation pursued, land has been made more productive.

UNIONS VOTE AUTHORITY TO CALL STRIKE

Total of 345 to 105 in Favor of Delegating Right to Call Workers Out.

On Saturday afternoon a vote of the union men of the city was taken on the question of whether they should give authority to a strike committee composed of the delegates to the Trades and Labor Council to go on strike in case occasion should require that they do so. The vote in favor of delegating such authority was 345, with 105 opposed. Only two unions opposed and those were the Electrical Workers and the Retail Clerks. The advertisement of the unions published on Friday said that the power was to be relegated to the strike committee but later it was explained to the voters that the committee referred to was the Trades and Labor Council. VISITOR FROM WINNIPEG TELLS OF CONDITIONS IN REGARD TO THE STRIKE

PUBLIC UTILITIES ARE BEING OPERATED WITH EXCEPTION OF STREET CARS AND THEY WERE TO START ON SATURDAY LAST

That the Winnipeg strike is the basis of a revolutionary movement throughout the west is an absolute fact, according to an arrival from Winnipeg who came in on the train last night and went south on the boat later. He was in Winnipeg four or five days and he made it his business to investigate the conditions everywhere.

The visitor says that since the organization of the committee of one thousand the light and power has been operated, the water supply has been on in full force, the fire department is back on duty, business houses down town are carrying on as usual and a number of delivery wagons are seen on the streets.

Being Drilled.

The citizens committee is being drilled and is doing patrol work and is preparing for any emergency.

The restaurants are open and the hotels are taking care of the guests. Volunteers are running the telephone service, but it is not very efficient as yet.

For three days previous to his leaving on Thursday the three daily papers had been published, not large editions but with a good deal of news, some of which was received by wireless.

People were able to get freight or express parcels by calling for them, and groceries, provisions of all kinds, meat and milk were on sale as usual.

Continue Indefinitely.

"No one thinks of giving way to the strikers," said the visitor. "The fight can be continued indefinitely and there will be no revolution here at any rate for the people are ready and are meeting the situation. Had the strikers acted quickly before the people were prepared, things might have been different. As it is they are beaten, but will not acknowledge it."

The committee promised that street cars would be running on Saturday and Mayor Gray promised protection to volunteers who were ready to man them.

STRIKE BRINGS DOWN PRICE OF HALIBUT

Only Ten Cents Realized at Local Exchange Today.

Eighteen halibut catches were sold at the Fish Exchange this morning at 10.3c. and 5c. per lb. Owing to the present unfortunate conditions most of the fish has to be sent south.

RAILWAYMEN ARE REFUSING RESUME WORK

At Calgary and Winnipeg They Defy Ultimatum of Railway Company.

Strike May Come At Any Time.

The union men of the city, numbering 450 persons, mostly men, have given authority to the Trades and Labor Council to call a strike at any time if they think it necessary. That it will be thought necessary sooner or later, if the strike continues in other cities, goes without saying. Prince Rupert people, in face of Saturday's vote should prepare for a strike, for it is very likely to come. It has been precipitated earlier than most of the labor leaders wished, for the One Big Union which was to have been the great weapon of offense, has not yet been organized. Similar methods are being adopted now, however, to those which would be under the Big Union.

In other cities strong citizens' committees are being formed for the purpose of maintaining law and order. In Winnipeg there is a committee of one thousand and in Vancouver and Victoria similar committees are being formed.

The necessity of the formation of such committees is found in the seditious utterances of some of the strikers and labor leaders. In some cases the men are being incited to lawlessness by suggestion and even in this town around the places where men congregate, threats are openly expressed and suggestions of taking things by violence are muttered. In the face of such a condition a complete organization of the laboring section of the community is necessary.

In Winnipeg there has been good order, but even there the bulletin issued by the strikers has suggested that if the men are hungry there is plenty of food in the houses of the rich at Fort Rouge and men are foolish to go hungry when there is plenty to be obtained.

Revolutionary Movement Is Behind Strike.

Senator Robertson was right when he said that there was a revolutionary movement behind it all. This does not mean that all the union officials are revolutionaries nor perhaps any of them. Men are being used these days by an inner clique who make no effort to conceal their purpose of trying to upset the present form of government and of establishing a soviet. Of this soviet the One Big Union was to be the basis. The union was to be organized in such a way that when the time came it could take to itself the reins of government and rule.

Owing to the strike at Winnipeg the movement was precipitated earlier than was expected. It has gone off at half cock and is not meeting with any great success. If a settlement is made now it will be with the purpose of gathering the forces for another and greater onslaught. It does not, at the time of writing, look as if there would be a settlement possibly for some time to come.

Winnipeg Is Not Making Headway.

In Winnipeg, according to reports, the strike is not making much headway. The unions took control during the first few days and everything was paralyzed because the citizens were wholly unprepared, and did not understand the motive. After a few days they shook off their lethargy and organized and the result is that the public utilities are being operated, food is being distributed, and if there is distress it is among the strikers more than anyone else.

The One Big Union leaders deluded their followers into the idea that a strike could be won in a few days if everything was tied up. That is proved to be incorrect. Winnipeg was tied up, but it broke loose and the outlook for the success of the strike is poorer than it was three weeks ago. The non-strikers say that they can put up with inconvenience just as long as can the strikers and perhaps longer. Also they are determined to preserve law and order. Happily there are no saloons to craze the brains of the people and excite them and the result is that the struggle continues quietly but determinedly, and none are more determined than the citizens who have organized to prevent any upsetting of the constitutional authority.

SOLIDARITY OF CITIZENSHIP

Editor, Daily News:—
The "One Big Union," not of labor ranks only, but of the whole citizenship of Canada, male and female, is the only measure that can save the country from social, industrial and financial disaster due to a further continuance of unbalanced conditions and conflict of interests.

Soldier or civilian or employee, capitalist or laborer, the inequalities, injustice and suffering of the past and present, notwithstanding, our lives and interests, as one big family, are bound up in, and determined by, the measure of unity or division, the solidarity or instability of our citizenship. Absence of the former is wholly responsible for the conditions that have brought Canada to the present impasse.

A Choice.
We are faced with a choice of:
(a) A continuation of instability and increasing unrest, wherein part of the population, without national direction, is producing a portion only of the necessities of life, and doing such other service as carries us along in a slipshod existence, in order that the more fortunate may lead a demoralizing life of idle, wasteful luxury, until such conditions end in early and inevitable revolution.

(b) Solidarity of citizenship and national interests, the adoption, acceptance and enforcement of a safe and sane middle-class democracy, based upon a fifty-fifty of national service and of leisure and pleasure for all; of nationally directed production upon a self-supporting basis, and the stabilizing of remuneration for service with the cost of living and of value of exchange, based upon the time-cost of production and distribution, whereby a permanent balance may be established.

Problems to Solve.
We have great problems to solve, grave injustices to redress, wrongs to right, but we can never raise Canada to the coming "world standard" by hanging on to one another's throats or by roughhouse methods of any description. A united people, a true democracy, does not tolerate an autocracy of labor or of returned soldiers, or of any other form of despotic, factional or party-political control, any more than it or labor is tolerant of any autocracy of capital.

The solution depends upon combined commonsense and determined action, through constitutional methods and by peaceful means.

Time is pregnant with catastrophe, so let us lose no time in burying the dead past under a nation-wide organization of "Solidarity of Citizenship" and in raising the new standard of democracy.

Can we look to the public press of Canada to give a whole-hearted advocacy and voluntary assistance to such a movement? Can we look to existing organizations and societies of democratic tendencies to drop factional efforts and take a leading part in the practical mobilization and direction of forces, to take a leading part in the mobilization of citizenship and the orderly direction of the advance movement?

Ameliorate Conditions.
Above all, can we look, without fear or disappointment, to all who are actively or passively connected with industry, agriculture, trade or commerce, to keep the wheels turning, and to ameliorate, as far as possible, all causes for disaffection, in order to expedite the inauguration of the new system, and avert further unnecessary suffering, waste and national loss meanwhile?

There are many, including the writer, who, without remuneration are ready to devote their services and means to the work of organization and reconstruction, but we must look to the men and women of the younger generation who will constitute the brains and sinew of the "New Canada," to carry the standard.

Solidarity of Citizenship
As a practical start toward general organization I am submitting these suggestions to as many newspapers throughout Canada as possible, inviting each community, town or city to form its own preliminary "Solidarity of Citizenship" and from these evolve a Provincial Committee, representative of all interests, in numbers proportionate to population

These committees to meet at Ottawa as a provisional parliament (without interference meanwhile with existing Government) and draft the general principles which would form the basis of a new constitution, for submission to a general vote of the whole population of voting age, for acceptance or rejection. If rejected to be redrafted until accepted by a two-thirds majority.

Immediately thereafter a Dominion election would be in order and it would devolve upon the elected to put the new constitution in form of practical procedure and enforce it.

It would then be in order for the provincial governments, to be, without delay, brought in harmony with the Dominion.

STATED WORK WILL BE DONE AT RUPERT

Albert Bringing Spare Propellers North—Said Drydock Will Handle G. T. P. Boats in Future.

The Grand Trunk Pacific steamship Prince Albert is now at Esquimalt loading 16,000 cases of empty salmon tins at the Empire Cannery for Inverness Cannery, on the northern British Columbia coast, says the Victoria Colonist of recent date. At noon today she will come around to the Grand Trunk wharf and pick up several spare propellers. These are extra parts for the Prince George and the Prince Rupert. It is understood that as the drydock at Prince Rupert now has sufficient men working there continuously to do all repair work and overhauling of the Grand Trunk boats—this will be done there in future instead of at Victoria, and for this reason the propellers are being taken north.

The Albert loaded steel at Vancouver for the new shipyard at Rupert. She will be filled up when she sails for the north.

LONDON TRUTH GETS AFTER COLONEL PECK

London, May 28.—In a recent number of Truth there was an article strongly criticizing Col. Peck, V. C., for his strictures upon Sir Charles Ferguson, who put Cologne out of bounds for the Canadians. Col. Peck now writes to Truth declaring it is an unwarranted falsehood to state that he "threw mud at the British army."

"What I did," writes Col. Peck, "was to point out that certain sections of the British press seized on every incident of irregularity in connection with the Canadians, and blazoned it to the world, while even more serious things had happened in the British army."

Truth, replying to Col. Peck's letter, today, alleges that he said that in 1917 he was in a town where 14,000 British troops were in open insurrection, and 4,000 Canadians were called in to guard railways and bridges. This, says Truth, is mud-slinging, and it is incorrect to say that the British press has given more prominence to outbreaks of colonialism than among home troops.

THE Soldier Settlement Board has arranged with manufacturers of implements and harness to give soldier settlers a wide choice of first class implements at prices substantially below those quoted to civilians; and in the Prairie Provinces the United Grain Growers, Limited, will give soldier settlers special prices on implements, wagons, and other commodities.

By collective buying in large numbers for cash, it can also offer soldiers the lowest possible prices on horses and other live stock.

It can supply a good harness set for approximately \$31.50 at point of manufacture.

All these concessions are in addition to the Board's offer to secure for the soldiers good

land, conveniently located, and to give financial assistance in the way of loans to establish them on the land.

Land and Loans

With certain exceptions, a soldier who has served with good conduct in the Canadian, Imperial or Allied forces in an actual theatre of war or outside the country in which he enlisted (or widow of any such man) may secure loans to purchase land, live stock and equipment and erect buildings—

- (1) Up to \$4,500 to cover the cost of the land and discharge encumbrances.
- (2) Up to \$1,000 to erect buildings. Both these loans to be paid on the instalment plan. Payments extending over 25 years.

(3) Up to \$2,000 to buy implements, live stock, and equipment. The soldier will begin to pay off this loan in the third year, and will have four years to pay.

Only five per cent. will be charged on these loans.

A cash payment of one-tenth the price of the land will be required, except in special cases.


Qualified settlers on Dominion Lands may secure loans up to a maximum of \$3,000 on a plan similar to the above for farm equipment, live stock, and erection of buildings, provided security offered justifies the loan.

In the Letter Box

RENT PROFITEERS

The Editor Daily News:

I wish to enter a strong protest through the columns of your paper against what I consider the outrageous profiteering carried on by certain landlords in Prince Rupert. I am quite cognizant of the fact, and I wish to state this at the outset, that there has not merely been a diminution in the supply of dwelling houses, but practically an absolute cessation of all building operations.

The necessities of war called our man-power from peaceful pursuits to fulfill the more urgent demands of the conflict. Consequently there was a double flow of men and materials from the needs of peace to the needs of war. The reaction was strongest in the construction of homes, the erection of which was rendered impossible from both patriotic and economic standpoints. Add to this the natural trend of people to our towns and cities, and the cause of the scarcity of dwelling houses becomes apparent. We know that some landlords have "waiting lists" containing many names of those desiring rentals of apartments. The landlords—there are exceptions, I am glad to say here in Rupert—are making the most of an unfortunate economic condition. They are demanding high rents, because they know that in the majority of cases the tenant is powerless to do anything but submit.

Specific Case.

I now wish to state my case, that the public may see how a certain class make use of this situation to enrich themselves at the expense of the public.

Yesterday a received notice that the rent for my flat, far from modern, situated over the office of Westenhaver Bros., was to be increased 100 per cent from July 1st, and Mr. Westenhaver had the cool effrontery to dictate as to how the hundred per cent increase was to be met. He advised taking in boarders. Imagine a mother with three young children in a flat comprising three bedrooms, a sitting room, a dining room and a kitchen, being obliged to take in boarders, so as to be able to put an exorbitant rent each month in the pocket of Mr. Westenhaver, who, true to the tradition of the absentee landlord "draws his rent in Rupert, but spends it elsewhere."

Some days ago I sent a courteous letter to Mr. Westenhaver asking him to make a few small necessary improvements, and he replied in a manner as rude as his English and grammar were poor that "if I was not satisfied to get out."

Is it any wonder, when such profiteering is allowed to go on that so much discontent is rife? The vultures of greed and graft prey on the defenceless and enrich themselves at the expense of those who are the victims of the economic condition resulting from the war.

Should be Curbed.

A tenant has to submit to any and all increases in rent, for he knows that he has no choice in the matter, but pay or vacate. The landlords are certainly making the most of the situation, for they know that if a tenant will not pay the high rent, another will. It is this type of landlord, whose activities should be curbed, this type of unscrupulous owner or lessee who takes advantage of the economic situation to gouge the tenant and make big profit out of

the necessities of the people. And there are many at present using these methods.

New York landlords are proverbial for their profiteering, and lately a cry was raised, when some of them raised their rents 25 and 50 per cent. But Rupert has a landlord who goes one better and increases his one hundred per cent. Is it not high time that some kind of administrator be appointed with authority to review the acts of the landlords pertaining to increase of rentals? At present the tenant is the victim of unscrupulous vampire-sucking profiteers, and, if the tenant seeks to combat this unwarranted action and declines to pay, he receives notice to vacate the premises and if the matter is taken to the courts the tenant is told to pay or move. As a result the tenant is bound down between the upper and nether millstone.

Government Action.

I somehow feel that this is a matter that might well be taken up by the Government. Other matters pertaining to the necessities of life have been taken up by the Government and why not rentals? The nature of the house, the service it renders, the nature of the locality, the investment of the landlord, the taxes he pays are all determining factors, which could easily be considered in coming to a decision as to what rent should be charged.

Is it not time to call a halt to profiteering so flagrant? Here is a question that should concern all who rent dwelling houses in Prince Rupert. Some concerted action is necessary. Let us strike the iron while it is hot and bring this high rental policy to a show-down. Then the honest owner who looks at the tenant's side of things and who demands a fair profit on his investment will get encouragement rather than censure, but let the money-grabbing plethoric profiteer be relegated out of society as an unclean thing.



SYNOPSIS OF LAND ACT AMENDMENT

Pre-emption now confined to surveyed lands only.

Records will be granted covering only land suitable for agricultural purposes and which is non-timber land. Partnership pre-emptions abolished, but parties of not more than four may arrange for adjacent pre-emptions, with joint residence, but each making necessary improvements on respective claims.

Pre-emptors must occupy claims for five years and make improvements to value of \$10 per acre, including clearing and cultivation of at least 5 acres, before receiving Crown Grant.

Where pre-emptor in occupation not less than 3 years, and has made proportionate improvements, he may, because of ill-health or other cause, be granted intermediate certificate of improvement and transfer his claim.

Records without permanent residence may be issued provided applicant makes improvements to extent of \$300 per acre and records same. Further particulars of the Chief Forester, Victoria, B. C., or District Forester, Prince Rupert, B. C.

Unsurveyed areas, not exceeding 20 acres, may be leased as homesteads; title to be obtained after fulfilling residential and improvement conditions.

For grazing and industrial purposes, areas exceeding 840 acres may be leased by one person or company. PRE-EMPTORS' FREE GRANTS ACT. The scope of this Act is enlarged to include all persons joining and serving with His Majesty's Forces. The time within which the heirs or devisees of a deceased pre-emptor may apply for title under this Act is extended from one year from the death of such person, as formerly, until one year after the conclusion of the present war. This privilege is also made retroactive.

TOWNSITE PROPERTY ALLOTMENT ACT.

Provision is made for the grant to persons holding uncompleted Agreements to Purchase from the Crown of such proportion of the land, if divisible, as the payments already made will cover in proportion to the sale price of the whole parcel. Two or more persons holding such Agreements may group their interests and apply for a proportionate allotment jointly. If it is not considered advisable to divide the land covered by an application for a proportionate allotment, an allotment of equal value selected from available Crown lands in the locality may be made. These allotments are conditional upon payment of all taxes due the Crown or to any municipality. The rights of persons to whom the purchase from the Crown has agreed to sell are also protected. The decision of the Minister of Lands in respect to the adjustment of a proportionate allotment is final. The time for making application for these allotments is limited to the 1st day of May, 1919. Any application made after this date will not be considered. These allotments apply to townsite and lands of the Crown sold at public auction. For information apply to any Provincial Government Agent or to G. R. NADEN, Deputy Minister of Lands, Victoria, B. C.
