DOMINION GOVERNMENT IS OUT FOR PROTECTION

BRITISH STATESMAN SCORES THE GOVERNMENT REGARDING IRISH POLICY

Record in Ireland Is Scored by Cecil

Member for Oxford University charges blood stained inefficiency; speaks of "infamous crimes" of Constabulary

LONDON, February 14.—Lord Hugh Cecil, M. P. for Oxford University, in a letter to the Times declares the British Government's record in Ireland to be one of blood-stained inefficiency. He charges the Irish constabulary with infamous crimes and says the Government would be far wiser to have kept the administration in the hands of civilian magistrates.

Fire Outbreaks.

MANCHESTER, England, Feb. 14.—A number of simultaneous outbreaks of fire in several mills and factories in Manchester, worth, Royton and Rochdale were accompanied by suspicious circumstances, such as employment of inflammable liquids, the fleeing of men acting suspiciously, some of whom were on. The police believe they have evidence that the fires were due to Irish irreconcilables.

MAYOR ROCHESTER GETS REPLY TO TELEGRAM

A letter received by Mayor Rochester this morning from the private secretary of the chief railway commissioner outlines the steps which have been taken in regard to delivery of cars here and states that 30 will be delivered between March 15 and March 31.

John Pullen, head of the Canadian Express Co., states in his letter to the commission, "As you are aware, the car equipment for express traffic is provided by the railways and not by the express company, and all we can do is to make our recommendation to the railways as to what equipment is required, and it is for them to determine to what extent new equipment will be provided. You will observe from Mr. Warren's letter of February 1, that he will spare no effort to take care of this business."

TRAIL BEING BUILT TOWARD SHAWATLANS

Work Proceeding on the Grading Work Along Pipe Line from Eleventh Avenue.

Work is proceeding on the grading of a trail along the Prince Rupert Boulevard following close to the pipe line toward Shawatlans road at the city limits. This trail will be made strong enough for the city tractor to pass over and haul a water pipe in case of repairs being needed.

The bridge leading from 11th Ave. will be strengthened in order for the tractor to pass over it. The new trail will be a great improvement over the old plank walk which was falling to pieces. It will make a pleasant walk for those wishing to get off the plank roads.

If the Provincial Government decides to go on with the building of a road to the mouth of the Skeena River, this road will connect with it and will, in all probability, form a part of the highway.

Parliament Opened Today at Ottawa with Usual Ceremony

Tomorrow Mackenzie King is Expected to Move Vote of Want of Confidence in Government with Call for Dissolution and an Election

TEACHERS STRIKE

NEW WESTMINSTER, Feb. 14.—The school teachers here have declared a strike effective this morning because of a dispute with trustees over salaries. Seventy-six teachers are affected.

OTTAWA, February 14.—The fifth session of the thirteenth parliament of Canada was opened this afternoon at three o'clock by the Governor-General, the Duke of Devonshire. It was carried out with all pre-war pomp.

The session promises to be full of fight. Members of the opposition here are determined, they say, to force an election and some of the Government supporters are said to be strongly in favor of an early dissolution followed closely by an appeal to the country.

The first move with this end in view will be made when Mackenzie King gets the floor tomorrow. It is expected that he will move an amendment to the address in reply to the speech from the throne in which he will call for the dissolution of the House and an election, on the ground that the Government is without a mandate to carry on further and that the people should be given an opportunity to say who shall govern them.

The address will be moved tomorrow by James MeLsaar of Kings, P. E. I., and seconded by J. A. McKelvie of Yale-Caribou, when the debate begins following the usual formalities today.

Tariff revision is the chief feature of the Government's legislative program.

MARFISH TENDERS Bids Being Asked by Department of Marine for Repairs to Boat.

Tenders are being called by the Department of Marine for repairs to the Dominion Government fisheries steamer Marfish, the boat which was sent south contrary to the wishes of the local people. The advertisement calling for the tenders will appear in the Daily News tomorrow.

Meighen Out With Protection Policy

Says Not Only Will It Be to Provide Revenue but to Protect and Foster Industries; Worker is Chief Thought

OTTAWA, February 14.—In the speech from the throne delivered by the Governor-General at Ottawa this afternoon the chief feature was a reference to revision of the customs tariff. This was said to be made in regard to the necessity of revenue as well as on the principle of protection of Canadian industries, which must be consistently maintained. It suggests that customs duties with that end should be no higher than was essential to ensure a good standard of living among working people and to obtain and make possible normal expansion of industries in order that workers may find employment.

Other legislation mentioned includes a bill to repeal the Conservation Act, to amend the Dominion Elections Act, and bills relating to copyrights, income war tax, scientific research, and other matters.

KING TO OPEN PARLIAMENT

Will Be Attended by Queen and Duke of York Tomorrow at Westminster.

LLOYD GEORGE IS BEING CRITICIZED

LONDON, February 14.—King George, accompanied by the Queen and the Duke of York, will open at noon Tuesday the session of Parliament which promises to be a test of the continuance in office of Lloyd George's coalition Government. There is much rumor that the Government will try to spike the guns of those criticizing it for waste, by presenting a budget providing for a total expenditure of £950,000,000.

Another Attempt to Abolish the Bar.

Another attempt is to be made to abolish the bar, according to Premier Oliver. This is the second attempt in British Columbia. When the first prohibition measure was carried it was largely in order to banish the bar. Then it was very soon found that the bar was not banished but was very much with us, much more than formerly. It may not have been quite as pernicious as it used to be, but very noisily.

What people are wondering is whether the second attempt will be more successful than the first. Possibly it will, but no one can say with any degree of certainty. It is to be assumed that it will still be legal to sell soft drinks at a bar or table or counter, and if it is, the degree of softness will have to be determined. The bar is a sticker and refuses to be banished with the wave of a hand or the scratch of a pen. It is an attractive institution apparently.

Prince of Wales Was Interested.

Some of the London newspapers are intensely inane. A recent number of the London Times tells of the Prince of Wales visiting the Times newspaper publishing house and says without a twinge or squirm that "the Prince took a keen interest in everything he saw."

What did the Times think the Prince went there for? Surely there could not be as inane a remark made by the simplest boob on the street. Yet the Times is supposed to be one of the great newspapers of the world. It is hard on a prince to have to suffer remarks of that kind, because the inference is that usually the prince had not brains enough to be interested in anything, but on this particular occasion he outshone his ordinary self.

The Prince is really a very bright young lad, but he would seem to be anything but that, judging from the London papers.

Timbermen's Association Should Prove Valuable.

The timbermen of the north are now fully organized and should do some excellent work. They all have much in common and by helping each other may help also themselves. The timber industry is one of the most important industries of the north, one of the basic industries. It should have many other industries dependent on it.

At the present time there is little done north of Swanson Bay to use the timber except to saw it into lumber. There is a box factory at Georgetown and two resaw and planing mills in this city. Only the one at the Prince Rupert lumber mill has been used as yet, however. The other, owned by the Charlotte Islands Spruce Products, Ltd., has not turned a wheel yet, but it is confidently hoped will be reorganized and running full blast in the spring.

The more we can use our lumber at home instead of exporting it in the rough state, the better it will be for the district.

Good News Regarding Local Pay Checks.

Good news was received from Ottawa on Saturday when word was received that the local outstanding pay checks from the drydock would be cashed at once by the government agent. As Capt. Saunders is not at present in the city, there will be a delay of a few days, but it will be a great relief for a good many who have advanced money to get it back. The members of the Board of Trade who went good at the bank for a considerable sum were beginning to fear they would have to pay the note they had given. The bank was willing to renew the note for a short time longer, but not for an indefinite period.

Merchants who had cashed some checks were badly tied up as a result, but the decision of the Government will relieve this. The curious thing is why it should have been necessary to delay so long.

The table given is for Port Simpson but the time for Prince Rupert varies only a few minutes on some days and on others is the same. The range of the tide may be computed as 5 per cent greater at Prince Rupert than at Port Simpson both at springs and neaps. Therefore the rise in the Prince Rupert harbor is slightly greater than Port Simpson.

The height is in feet and tenths of feet above the average level of lower low water.

NOVA SCOTIA LEGISLATURE

Will Open in March with Big Change in Opposition Ranks

HALIFAX, Feb. 14.—The oil paintings of Joseph Howe and W. H. Johnstone which flank the Speaker in the Nova Scotia House of Assembly, will stare down on a legislative gathering inclusive of new elements when Lieutenant Governor McCallum Grant opens the Provincial Legislature, early in March. The time-honored system of Liberal Government and Conservative opposition, which Premier George H. Murray has been accustomed to since he took his seat in the House twenty-four years ago, received a severe jolt at the Provincial elections last July and, although the Murray Government is still as firmly established as ever with a clear majority of seventeen votes over its opponents and in this respect the change, amounting to loss of four seats is practically negligible, the opposition shows a surprising modification in composition. Dr. Benjamin LeBlanc of Richmond and H. W. Corning from Yarmouth are the remnant of a once powerful Conservative group and the rest of the opposing benches will be occupied by six farmers and five labor members, most of whom have never sat in the House before.

Opposition Leader W. R. Corning of Chegozzin, Independent Conservative, is looked upon as the probable leader of the Opposition. Mr. Corning sat in the local House from 1911 to 1916 and acquired a bit of parliamentary experience not unnecessary to the chief of a small and possibly unstable group.

When asked to indicate the probable course of legislation at the coming session of the House of Assembly, for the Canadian Press, Premier Murray said, "Everyone knows the country is here and we are all poor."

While it is generally agreed that little new legislation involving the expenditure of large sums of money is contemplated and for this reason the program is somewhat in doubt, there are straws which point the way to definite legislative action.

Highways Act Perhaps the most important of these is the investigation proceeding at present, under a Royal Commission, of the administration of the Highways Act in Nova Scotia. Whatever may be the outcome of this investigation it is agreed that the circumstances leading up to its institution and its subsequent progress will form the subject for lengthy debate and possible amendment to the existing highways legislation. Indeed many are of the belief that the activities of the members of both sides of the House will centre about the question of highways throughout the approaching session.

Liquor Legislation It is also taken for granted that the referendum held on the question of liquor importation in October, which resulted in an overwhelming defeat for the wet forces, will provoke legislation looking to the further curtailment of the distribution of intoxicants by a re-definition of the privileges of the licensed liquor vendors.

MORE REVENUE THAN EXPENSE

That is Present Condition of Province under Oliver Administration

VICTORIA, Feb. 12.—British Columbia has a surplus revenue over expenditures for the fiscal year ending March 30 last amounting to \$351,388, according to the public accounts presented to the Legislature this afternoon by Hon. John Hart, minister of finance.

The total revenue for the year was \$13,884,602.75 and the expenditures on current account were \$11,588,002.87 and on capital account expenditures charged to income was \$1,942,268, making a total expenditure of \$13,510,271.79.

The total surplus assets over liabilities increased during the year from \$22,181,262.62 to \$23,407,291.45.

UNEMPLOYMENT MEETING HELD

Alderman Kerr Promises Possibility of Work for All on Rock Pile at Acropolis.

J. H. Burroughs took the chair last evening at the Central Labor hall at a meeting of the unemployed men of the city. Ald. Geo. Kerr, chairman of the board of works, was present and addressed the gathering. There were from 150 to 200 men present. He hoped to be able to make a more definite announcement in this regard by next Friday. A deputation representing the unemployed is going to wait on the city council this evening.

USE OF GASOLINE IN CANADA INCREASES

Large Importations of Automobiles; No Less than 2,076 Came in 11 Months

NEW YORK, Feb. 13.—Statistics published by the Wall Street Journal indicate that the consumption of gasoline in Canada has increased greatly since the year. In the first 11 months of 1920, 1,262,000 barrels of gasoline were sent to Canada from the United States, while in the same period of 1918 the exports of gasoline to the Dominion amounted to only 662,000 barrels. At the same time the quantity of crude oil sent to Canada from the United States increased from 4,226,000 barrels in the 1918 period to 6,010,000 barrels in 1920, or nearly fifty per cent.

Canada has been importing a large number of automobiles from the United States, in the first 11 months of 1918 taking 1,499 cars and in the 1920 period 2,075 cars.

OBJECTION TO U.S. FREIGHTS

Arbitrary Against Canadian Goods is Matter of Protest by Convention

VANCOUVER, Feb. 13.—Representatives of 62 boards of trade in annual convention Friday voted to give preference to Canadian railways in routing freight to and from British Columbia from eastern and southern United States until the U.S. railways accede to the demands for the removal of the eight and half per cent arbitrary freight rate now in force against shipments forward out of British Columbia.

Resolutions were also passed urging the preservation of green timber along the public highways, asking for Government assistance to bring tourists into the province, Government aid to ship-building, and also in connection with irrigation.

FRENCH BLUEBEARD CLEVER IN COURT

Uses Up Time of Judges and Studies All Documents

PARIS, Feb. 13.—Henri Desire Landru, under indictment for the murder of eleven women to whom at various times he had promised marriage, and whose trial before the French Assizes had been set for March 1st, has succeeded in obtaining another postponement of his trial. Landru has been in jail for two years and recently was sentenced to five years in jail and subsequent deportation for swindling.

Under French law, a man accused of crime has the right to take cognizance of the dossier in his case before facing the jury. He may make a fight upon the legality of any of the documents submitted to the jury.

7,000 Documents
 The dossier in Landru's case includes 7,000 documents, all of which have to be copied, as the Public Prosecutor does not trust the originals in the hands of the accused. The work of copying the documents will occupy more than a month.

Landru has informed the Court that he will require several weeks in which to study the documents as he intends to challenge all of them as irrelevant.

Landru caused considerable worry and annoyance to Judge Benin while the latter was investigating the case and now that it has been turned over to the Prosecutor of the Republic he has accepted the same tactics.

Would Like to Go
 To one of the assistants of the Prosecutor who reproached him with procrastination, saying that French justice has other things to look after than the Landru case, the alleged Gambais Bluebeard replied:

"Then why don't you let me go. I'm perfectly willing." Then he added: "How I miss Judge Bonin. At least, he was a gentleman."
