Attempt To Break Local Drug Ring

ALBERTA PEOPLE ELECTED MAJORITY OF FARMERS YESTERDAY

Farmers Sweep Alberta in Election for Provincial Legislature; Liberals 15 Members, Conservatives None

CALGARY, July 19.—The Farmers swept Alberta in the provincial election yesterday, securing 38 seats out of a possible 61. The Liberals secured 15 seats, Independents four, Labor four. The Conservatives are not represented.

Three cabinet ministers were elected and three defeated. The defeated were Hon. Duncan Marshall, Hon. George Smith and Hon. A. McLean.

Mrs. Nellie McClung, the authoress and lecturer, was elected in Edmonton. In Calgary Bob Edwards, editor and proprietor of the notorious paper, the Eye Opener, was elected.

The leader of the Farmers has not yet been chosen.

VIEWS ON THE SITUATION.

With the Farmers in the saddle, Alberta is the second province in Canada to send to its legislature a majority group representing organized agricultural industry, Ontario being the first.

The government of Hon. Charles Stewart has been overwhelmingly defeated.

The Farmers fought the battle with the Stewart Government on a broad issue of the alleged iniquities of the old party system of politics rather than on the record or policies of the Stewart administration.

The election brings the virtual disappearance of the Conservative party from the legislature, the twelve candidates on the straight ticket being defeated.

LOOKING FOR NEW PREMIER.

Naturally the question as to who is to be the next Premier is a subject that is much discussed everywhere. H. W. Wood, president of the U. F. A., who was not a candidate in yesterday's elections, declined to make his own position clear. He had not been tendered the premiership, he said. The name of Herbert Greenfield, vice-president of the United Farmers, is spoken of prominently for the premiership, and also the name of George Hoadley, member-elect for Neokos, and recently a Conservative, has been mentioned. The Farmers will likely call a conference to decide the matter.

OTTAWA'S NOT SURPRISED.

OTTAWA, July 19.—The defeat of the Stewart Government in Alberta caused little genuine surprise here, the chief comment being on the size of the U. F. A. representation. The voting will probably have a direct effect on the forthcoming federal cabinet conference in regard to the possibility of dissolution and an election which will probably follow Meighen's return to Canada. Some of the government supporters are for an early appeal to the country, but others are holding on for another year because of the census not having been completed and redistribution provided on the basis of increased population.

NO RUPTURE OF NEGOTIATIONS

Withdrawal of Premier Craig Does not Mean end of Peace Move.

BELFAST, July 19.—The resignation of Sir James Craig, premier of Ulster and the members of his cabinet, who were with him in London in connection with Irish Peace movement, did not bring about a rupture of the negotiations, it was declared today by Colonel Spencer, secretary of the delegation. It is thought likely the delegation will be recalled to London next week.

C. P. R. LEADING CONNAUGHT CUP

Beat Halifax in Two Games with Combined Score of 7 to 3.

MONTREAL, July 19.—A team representing the C. P. R. Soccer Club defeated Halifax by a score of four goals to two in the semi-finals of the inter-provincial Connaught Cup series making a total score of 7 to 3 for the championship in the two games. The C. P. R. will meet Toronto Scottish in the first home and home series next Saturday for the cup.

PRESIDENT HARDING INVITED TO VISIT PRINCE RUPERT CITY

The City Council last night passed a resolution inviting President W. H. Harding of the United States to visit Prince Rupert when he makes his proposed visit to Alaska. The invitation will be forwarded to the President at Washington through E. A. Wakefield, the local United States consul.

KING'S PRIZE BISLEY SHOOT

Canada Sure of Seventeen representatives in Next Stage.

BISLEY, July 19.—Forty scores of 88 in the shootoff for the last seventeen places of those eligible to enter the second stage for the King's prize are facing the target today. Canada is sure of seventeen representatives in the next stage with a chance of Sergeant Steel of Guelph who scored 88 getting in. In the shootoff of the big team match this afternoon teams representing England, Scotland, Ireland, Wales and Canada, with twelve men each get 15 shots a man at 900 and 1,000 yards.

BEER SELLING CASE REMANDED

Will Be Tried at Victoria July 25: Claimed Ultra Vires.

VICTORIA, July 19.—The beer selling charge against the Army and Navy Veterans to obtain a ruling from the supreme court on the contention that the matter is without the jurisdiction of the court and that the whole act is ultra vires of the Provincial Legislature as it is unconstitutional, interfering, he claims, with trade and commerce, the right of action being reserved under the British North American Act to the Dominion government.

ENGINEER KILLED.

REVELSTOCK, July 19.—James Milne, stationary engineer on the C.P.R. for the past fourteen years, died here as the result of scalds caused by the blowing off of a pipe.

Sledge Hammers and Axes Used by Police Forcing Entry Alleged Drug Selling Premises

The city police last night at 1:45 effected a raid which it is believed may result in the breaking up of one of the largest drug selling rings in the city. The coup, which had been planned by Constables Macdonald and Logan, who had watched the premises for many nights, was made when these constables, assisted by Constables Ponstie, Bourne and McMeekin, entered shacks at the rear of 820 Third Avenue West, between Seventh and Eighth streets, and secured prisoners, witnesses and evidence which are said to be of a strong character. Five Chinese, Sing, Chow, Goy, Mah You and Lee Kwong, were arrested. The first three were dismissed in the police court this morning without being charged while the latter two were charged with selling drugs, to wit, cocaine and morphine.

In a secluded location where light seldom enters and in a portion of the city that is fast becoming inhabited by Chinese, the raid was conducted under interesting circumstances. The particular premises have been watched for some time and owing to the nature of the traffic that passed in and out of the shacks, the police were convinced that here they had found an important link of the illicit business. White men had been seen on several occasions to enter the premises under suspicious circumstances and one of these was commandeered and with the use of marked money was used for the purpose of obtaining crown evidence.

Beat Down Doors.

When the time was opportune the squad of police went up to the shacks and with concerted efforts beat in with sledgehammers and axes the entrances to two adjoining cabins. Both were barricaded, one with a pad-lock on the outside and the other from the inside. Through the wall dividing them was found a small slit from one that was ostensibly occupied and the other that bore the appearance of being empty. It is believed that the purchasers of drugs entered the open one and their drug was passed through the slit from the dark one where the stocks were held.

GRAND RAPIDS, July 19.—Benny Leonard, lightweight champion, has agreed to meet an opponent yet to be named at Benton Harbor on Labor Day.

OPENING GOLF CHAMPIONSHIP

Crack Players Enter Qualifying Rounds—Mitchell Makes Round in 75.

WASHINGTON, July 19.—The open golf championship of the United States got under way this morning with half of the 260 entrants scheduled to play in the qualifying rounds at 18 holes. Abe Mitchell of England reached the turn in 38 while Jack Hutchinson of Chicago, who recently won the British open championship, went out in 10. Kirkwood of Australia made the round in 78.

WINNIPEG EX-CHEIF DEAD.

WINNIPEG, July 19.—Ex-Chief of Police McRae died here yesterday.

Premier Craig of Ulster Returns to Ireland; Not Interested in De Valera

LONDON, July 19.—Departing for Belfast with his advisers, Sir James Craig states for publication that Ulster is not interested in any arrangement of Valera and Lloyd George might make regarding the administration of Southern Ireland. Ulster considers the question settled as regards Northern Ireland, the Sinn Féin having recognized Ulster's right of independence by contesting the northern elections on a platform of "no partition" and no "Ag." Ulster was always ready to co-operate, said Sir James, as far as was consistent with their dignity and with the plans for the administration of Ireland, but could go no further.

Premier Craig's statement is considered here as definite indication that the proposed meeting of de Valera, Craig and Lloyd George has now been rendered impossible by the attitude of Ulster.

LIBEL AGAINST SOCKEYE RUN LADY KINDERSLEY IS STILL POOR

Vessel Recently Here Sued for Damages Following Alleged Collision. Skeena and Naas Canneries Getting But Comparatively Few Fish.

JUNEAU, July 19.—Alleged \$3,000 damage caused by injury to the vessel and its consequent withdrawal from the run, the Pacific Coast Gypsum Company has filed a libel suit against the ship Lady Kindersley as the result of a collision between that ship and the barge Palmyra, said to have occurred on July 3. The Palmyra at the time of the collision was being towed by the tug Richard Holtske from the company's property on Chigacoof Island to Tacoma.

The Lady Kindersley is owned by the Hudson Bay Company, it is stated. The collision took place near the junction of Whale Island and Frazer Bight, off Princess Royal Island. The motorship was at that time enroute to Ketchikan.

No Attention to S'nal.

The complaint, which was filed in the office of the clerk of court, by H. L. Faulkner, attorney for the company, alleged that the Lady Kindersley paid no attention to whistle signals which were given repeatedly; that the Lady Kindersley attempted to cross between the tug and the Palmyra, striking the barge, tearing loose the port cap and smashing the cutwaters, split the stem and injuring the forward plating. The barge, it is stated, had to be put on drydock. The cost of repairs and the loss in time to the company is said to have amounted to \$3,000. The tug and barge, it is claimed, were displaying proper signal lights, visible for two miles. The collision, it is charged, resulted from negligence, inattention and want of proper care and skill on the part of the master and crew of the motorship.

Word received this morning from the Skeena river is that the sockeye run continues poor compared with other years, the boats averaging only 30 to 35 fish each. The Naas is equally poor, but from Rivers Inlet come better reports, the catch there being normal.

The humpback salmon are commencing to run and a few of them are being canned but only those taken with the sockeyes.

R. G. Johnston, manager of Inverness Cannery, received a telegram as follows, this morning:

"Pack Saturday night Sockeye, twenty-five hundred and seventy-five, others seventy. Twenty-six boats outside Friday morning averaged one hundred. Weather still dull and changeable but indications tonight are for good run this week."

WAR VETERANS' CLUB RAIDED

Sea Tender at Vancouver Taken in Custody and Out on Bail.

VANCOUVER, July 19.—The Great War Veterans Association club was raided here last night and fifteen bottles of beer seized and the bar tender taken into custody on a charge of selling liquor. Later the man was released under \$3,000 bail.

SAFE CRACKERS GET MUCH LOOT

VANCOUVER, July 19.—Safe crackers secured some big loot here last night. They entered the American Boot Shop on Granville Street and opening the safe with a buttonhook made off with \$1800 currency and checks. They are still at large.

Theatres Hit by Hard Times.

A dispatch from New York states that the city is having its leanest theatrical summer in many years. Only sixteen of Broadway's fifty-seven theatres are in operation. Yet it was recently predicted that the number would never fall below thirty.

Similar news comes from Montreal, where practically all the theatres are closed, and at other cities only a few are running. In Seattle, Levi's Orpheum is not running, and at Victoria Pantages is closed most of the time. When people begin cutting down expenses they usually make their first cut at the luxuries. Theatres are a luxury, especially in summer. Prince Rupert is lucky to have its theatres running as usual.

Good to Watch Game of Ball.

There was a great crowd out last night to watch the ball game and they were not disappointed. They got their money's worth. While there were errors of various kinds, the game was such that anyone might win it even up to the last moment. The score just indicated the level of play of each team and was not a freak one on either side. The fans were interested throughout and all enjoyed it.

Watching a game like that helps to put new life into the older people and puts pep into the youngsters. It takes the mind from the daily grind and tunes up the intellect. While the ball players put up such games as that of last night they are doing us all a favor.

What Should Public Leaders Do?

What should leaders of the people do? Should they listen to the wailings of their followers dodging the bricks of the opposition or should they stand pat and go the way they think best for the country and the community they represent? A case in point is that of Premier Meighen. He is at present in England on important business connected with the future of the country and of the Empire. No one else could do the work which he is doing. Yet, if the Ottawa despatches to some of the coast newspapers are to be believed, his followers are wailing because he does not spend more time at Ottawa looking after the interests of the party and of the country at home.

Surely there must be one among the cabinet ministers who can carry on while he is away! The party interest cannot be so important that it will go to the bow-wows if the Premier is away for a little time. And if the party does suffer, the interest of the state is paramount. As a matter of fact the party does not suffer but gains from honest work done by the leader whether at home or abroad. Mr. Meighen is not our ideal of a Premier, but he has done good service for Canada in England, and we must recognize those services.

Local Member Another Example.

Another instance of ignoring public opinion is found in the representative of Prince Rupert at Victoria. The Minister of Lands is a man who does not keep his ear to the ground all the time listening to the promptings of his party. Sometimes his motto seems to be "Party be damned!" He does what he thinks is best for the district and for the province. We often do not agree with his actions nor do we quite get his point of view, but we are willing to give him credit for honesty of purpose and he is considerably more than fifty per cent. right, which is what cannot be said of a good many politicians.

We might go on and cite instances of men who fly in the face of what seems to be their own interests, influenced by the larger things which they see or think they see. After all, our political representatives are just human, although at times some of their foolish followers would try to deify them for a little while. Then they come back to earth with a hard thud.

Under democratic government there must be a close relationship between the people and their representatives. That goes without saying, but it need not be so close that every action of the representative be dictated by the people who have not the information on which to base their judgment.

MAPLE LEAF VI. WAS LAUNCHED

Will Try to Regain Possession of Motor Boat Trophy; 37 Feet Long.

LONDON, July 19.—Maple Leaf VII. owned by Sir Mackay Edgar, who is as keen to regain possession of the international motorboat trophy, which he held from 1910 until last year as was Sir Thomas Lipton to win the American yacht races, was launched on the Solent last week and will cross the Atlantic shortly to race against America's best as the only representative of the Royal Motor Yacht Club of Great Britain.

The Maple Leaf VII. is thirty-three feet long, being six feet shorter than the two Maple Leafs which were so decisively beaten by Garfield Woods' Miss America last fall. She has four Sunbeam engines, developing 1,800 horse-power, and in her trials moved at a great speed. What she can really do is known only to the owner and builders, who are optimistic of her chances on the other side.

The Royal Yacht Squadron announces it will give a special prize to the first American six meter yacht to finish in the forthcoming British-American cup races at Cowes, and the town of Cowes also will give a cup to the first American yacht in the second cup race. Alterations are being made in the course in order to permit visitors a view of the whole racing expanse.

ORGANIZING FOR EIGHTH OLYMPIAD 1924 IN FRANCE

PARIS, July 19.—Organization of the Eighth Olympiad, in 1924, which has been awarded to Paris, will entirely be in the hands of the French Olympic committee acting under the general direction of a central committee, notwithstanding the fact that the French Government and the City of Paris will furnish the necessary funds, Gaston Vidal, Under Secretary of State for Physical Education, said today: "The intention is to make it a great manifestation of sport, such as never has been seen before," M. Vidal added. The site for the stadium has not yet been chosen definitely, but in all probability it will be on the old wall of Paris, in the neighborhood of the Bois de Boulogne, making that part of Paris the most important sport centre in the world.

The range of the tide may be computed as 5 per cent greater at Prince Rupert than at Port Simpson both at springs and neaps. Therefore the rise in the Prince Rupert harbor is slightly greater than Port Simpson.
The height is in feet and tenths of feet above the average level of lower low water.

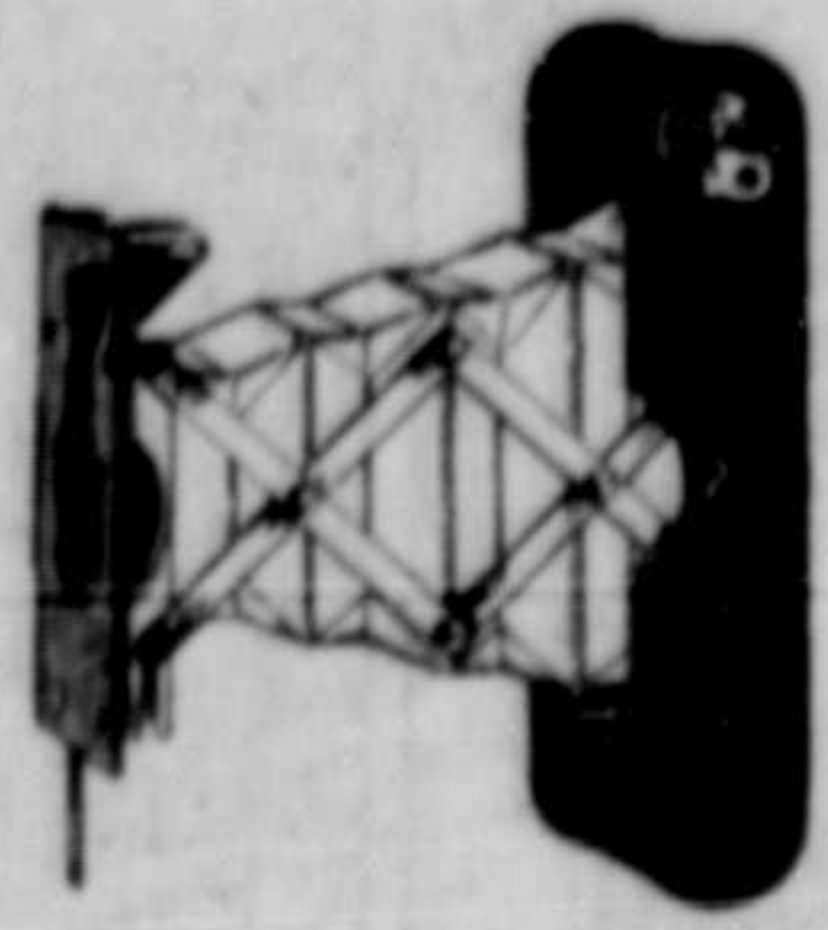

WATER GALA IS DISCUSSED

Suggestion Made That Big Civic Holiday Should Be Held Some Wednesday or Saturday.

There seems to have been some discussion in regard to the holding of a local swimming gala. It has been suggested that in view of the divergence of opinion as to when it should be held, there should be a big civic half holiday on some Wednesday or Saturday and that all should unite in making the gala a big affair, especially as swimming is one of the most popular of local sports and because of its importance in the matter of life saving.

Whether the gala would be possible or not could not be ascertained without getting in touch with the large employers and the building operations would close on a Wednesday, or failing that if the stores could agree to close on a Saturday, there would be possibility of a civic water celebration. Otherwise it would seem to be impossible.

WIDELY KNOWN MAN DROWNED

Ben Stone, Pioneer of North, Met Untimely Fate at Mouth of Skeena River.

The death occurred yesterday by drowning off the mouth of the Skeena River of Ben Stone, a well known citizen of this city and a pioneer of the Yukon country. First word of the sad happening reached the city last night from Mr. Chambers, of Inverness Cannery, out of which the deceased had been employed as a fisherman. The body up to noon today had not been recovered.

The drowning occurred about half a mile west of Green Top Island and report was brought to Inverness by the captain of the gas boat Florence who towed the one man sail boat, from which Mr. Stone was drowned, to the cannery. It is believed that the unfortunate victim of the accident was drowned when he fell from the boat. The occurrence is said to have been witnessed by a Japanese fisherman. This afternoon the witnesses will arrive in the city and an inquest will then be arranged for.

Lived in Yukon.
Mr. Stone was 57 years of age and was born at Greenspond, Newfoundland. He was married and his widow and three surviving children reside in the Thomas Block, Kilton Street. Three sisters, two in Victoria and one in Newfoundland also survive. Deceased was a member of the Anglican Church and belonged to the Orange Lodge. He had lived in the Yukon for twenty years where he was engaged in mining. He came to Prince Rupert about four years ago and was employed for a time by the Canadian Fish and Cold Storage Co. He was widely known here as well as in the Klondyke.

PREPARING FOR ADVANCE

Greek General Thinks Victory Over Turks Assured in Next Engagement.

SMYRNA, July 19.—A complete victory of the Hellenic arms over the Kemalists of Turkey in the next offensive was predicted by Major General Anastasios Pappoulas, the Commander-in-Chief of the Greek forces in Anatolia. His army, he declared, had been enormously strengthened since the repulse at Eskishehr, and only by pure chance could the Turks now be successful. He further stated that his troops outnumbered the Kemalists by almost three to one and that his army was so mobile that it could attack at any point along the 500-kilometer front.

The Greek generalissimo, whose appearance suggests the old civil war type of soldier, received the correspondent in the ancient Turkish barracks overlooking Smyrna harbor. He had just finished admonishing a group of officers telling them that they must put aside factional political feelings, think only of the good of their country and leave politics to Athens. He exhorted them that they must consider themselves as fathers and brothers to their men, and be true to their duty to God and the King.

MAKE CITY PEOPLE PAY MOST TAXES

SOFIA, July 19.—The peasants are now firmly established in power in Bulgaria and legislative bodies, both state and provincial, in which their representatives are in the majority, are engaged in transferring the burden of taxation to the shoulders of the despised city folk.

The district council of Roustchouk has evolved the following taxes which it styles "American":

Garrying a parasol, 50 levas yearly (nominally worth 19 cents each); skirts more than 1 1/2 inches above the ground or wearing silk stockings, 500 levas; wearing gloves between April 15 and September 15 without a doctor's certificate, 200 levas; wearing jewelry, 300 levas; keeping pet dogs, 500 levas; use of walking canes by persons under 50 years of age in good health, 100 levas; wearing shoes with tops exceeding 1 1/2 inches high, 200 levas; fur tippets or mufflers, 500 levas; and using baby carriage in cities, 200 levas.

ALDERMEN FAVOR ALLOWING COURT FOR HAND BALL

Ald. McNeill brought up the matter of establishing a hand ball court on the vacant lot next to the City Hall at the council meeting last night, and all the members went on record as favoring it although no definite resolution was put through. The idea was primarily that the court be used for the firemen and policemen to give them more recreation than they are now getting. The space used will be 30 by 15 feet with 14 foot walls on the 15 foot ends. The city is asked to supply the 1600 feet of lumber that will be required to build the court and the work will be done by the firemen and others.

STATESMAN OF JAPAN IN FAVOR TREATY

Former Foreign Minister Kato Thinks No Reason for Cancellation of Alliance.

NAGOYA, Japan, July 19.—Abrogation of the Anglo-Japanese alliance might necessitate Great Britain's keeping her Pacific fleet to a certain degree of efficiency, and strengthening of her Pacific force by Great Britain might oblige Japan to follow suit and strengthen her navy, former Foreign Minister Kato declared in addressing the Kenseikai, or Opposition party, of which he is the leader, here today.

M. Kato, who as Ambassador of Japan to England, participated in negotiation of the existing treaty, urged a renewal of the alliance with modifications calculated to reassure China and also to harmonize with the League of Nations. He said the alliance originally was intended to be directed against Russia and Germany, but its necessity in these directions had disappeared. It was not surprising, therefore, M. Kato declared, that some should urge there was on longer a necessity for the alliance, but, considering that Great Britain and Japan had been maintaining friendly relations for many years it would be a great pity if the treaty should be abandoned.

M. Kato pointed out that abrogation of the alliance would not affect the friendly relations of the two nations but he asserted its discontinuance might make people think something was wanting to keep the two nations friends, and therefore it was desirable the treaty should be kept in force. M. Kato declared that if the alliance were continued Great Britain would be under no necessity to reinforce her strength in the Pacific. He continued:

"It appears some opposition has been raised in America and in China, but it seems uncalled for. Even as it stands, the treaty stipulates that Great Britain shall not come to Japan's assistance in case of a war between America and Japan, while it contains nothing inimical to the sovereignty of China. If China objects to the use of the word 'China' in the treaty it might be altered to 'the Far East.' In short, the opposition of America and China is not based on reasonable and solid grounds. The discussion he said, centred around that part of the treaty excluding the contracting parties from the necessity of assisting one another against a third party with whom a treaty of arbitration had been concluded.
