## DRAYTON BUDGET IS AFFECTED BY RAILROADS

### ESTIMATED EXPENDITURE FAR EXCEEDS REVENUE FOR THE CURRENT YEAR

#### Seven Dollars a Gallon Tax on Imported Liquor and Nine on Domestic Made; Budget has No General Tariff Changes

OTTAWA, May 10.—The budget proposals as laid out last week by Finance Minister Drayton show no general revision of the budget for this year, the proposed increase having been abandoned in view of the contentious nature of the legislation. A change in the customs arrangement with the West Indies is included to make it conform with the recently signed agreement with the islands. The valuation of goods for customs purposes has been changed to accommodate the exchange situation. The business profits tax to be abolished except on playing cards and liquors. Spirits are taxed ten dollars a gallon straight and five dollars excise duty is placed on local manufactured spirits, and that used for hospitals. Alcohol used in the manufacture of medicine is taxed \$2.00 a gallon and playing cards are to pay eight to fifteen cents a pack. The sales tax is confined to manufacturers, wholesalers, jobbers, importers and is increased to one and a half and three per cent domestic and two and a half per cent on imports with farm products, lumber and fish excepted. The total trade is estimated to be \$2,429,000,000 or a hundred per cent increase over last year. Imports from Britain and United States \$560,000,000, export revenue totals \$432,000,000 an increase of \$128,000,000. Total expenditures amount to \$533,000,000 of which \$97,000,000 is spent on railroads. Sir Henry Drayton urged the necessity of raising additional revenue. The estimates total \$592,000,000 for the coming year and the revenue in sight is only \$435,000,000. Railway expenditures have increased by \$16,000,000 on equipment making a total of \$113,000,000 spent on railways. There has been a surplus this year except for the railroads.

#### CITY WILL SUPPLY POWER TO WIRELESS STATION AT DIGBY

Cable will Carry Current Beneath Harbor to Island. On the recommendation of the Board of Works the City Council last night granted permission to the Dominion Government to tap the city electric light lines for light and power for the Digby Island wireless station. The requirements of the island will be, at the present time, about 31 kilowatts and the revenue will be about \$125 per year. The power will be transmitted to the boundary of Section 2 towards the Fairview point light-house and the total cost of the line to this point will be \$1,500. The city's portion of this will be \$1,300 to extend the line from the present terminal at Morse Creek. The rest of the cost will be borne by the Dominion Government. The department will put in a submarine cable to take the power across to the island. The superintendent of utilities pointed out that the revenue of \$125 per month would provide the repayment of the city's investment inside of a year. The recommendation was adopted with but one dissenting voice, that of Ald. Kelly who felt that the city was not in a position to give any of its power to the Dominion government in that it could not supply industries which would prove more of a direct benefit to the city.

#### Expert at Khtada Looking Into Power Possibilities; Thulme River Discussed

A letter from the Prince Rupert Pulp and Paper Co. was read in committee by the city council last night pointing out that if the city was to supply power and water to industries wishing to establish in the city, a new scheme would have to be developed immediately. Speaking on the letter, Mayor Rochester stated that Mr. Barrows, an expert on water power, had arrived in the city from Dayton, Ohio, in connection with the establishment of the pulp mill here and that when he had looked over the ground he would shortly be going to Union Bay. Ald. Perry, who presented the letter, stated that there had been some criticism of the expedition made to Thulme River by the superintendent of utilities, but in his opinion, it had been fully justified. The Thulme River project was the only one that could be adopted by the city. All others were impracticable.

#### Proposal to Place Duty on Lumber Imported into United States from Canada

VICTORIA, May 10.—The United States may place duty on Canadian lumber entering that country, just as Canada collects a duty of 25 per cent on American lumber coming into this country, according to Eben M. Whitecomb, of Washington, D. C., an economist and tariff expert, who is here making investigations on behalf of the United States tariff commission. The commissioner is investigating the cost of cutting logs, and producing various grades of lumber and on what he finds out here the United States tariff commission will base its recommendations as to whether or not Canadian lumber should pay duty on entering the states.

#### COL. PECK COMMANDS AT BISLEY

Will Take Over Canadian Team to Win Honors in England. OTTAWA, May 10.—Col. C. W. Peck, member for Skeena, has been appointed commander of the Canadian rifle team at Bisley. The team of twenty riflemen was announced complete on Saturday last and this is the group Peck will command. In the team is another member of the 14th, Major Richardson, formerly a member of the old Fifth Regiment of artillery at Victoria, who has been to Bisley often.

#### URGE PROGRESS STREET WORK

Matter of Surfacing Down Town Thoroughfares Discussed by City Council. This week the city council will sit in committee to work out the details of the down town street surfacing work and it will be decided as to whether the work will be done by day labor or by contract. The matter was brought up at last night's council meeting by Ald. Parker who felt that it was time there was some action taken on the work. No tenders had yet been called nor had there been any complete reports yet submitted. Either the city engineer had too much work to do or there was inefficiency in his department. Ald. Kerr defended the engineer's department, stating that at the present time it was not working on the street question but was preparing reports on the road connecting to the provincial government road by the Prince Rupert Boulevard and also on the Sixth Avenue rough grading project. The former had never before been surveyed and was taking a good deal of time. This week, however, the board of works would be ready to submit the plans for the down town work to the council. Ald. Parker stated he was satisfied with Ald. Kerr's report and realized the extent of the work on the Prince Rupert Boulevard.

#### METHODISTS HOLD DISTRICT MEETING HAZELTON CENTRE

Last week the annual Methodist District meeting was held at the home of Mr. and Mrs. H. H. Little, Hazelton. Good progress was reported and especially at Telkwa where the mission had now grown into a self-sustaining church. Delegates to the conference were appointed, those to attend being John Newick of Hazelton, Mrs. Boyer of Smithers, J. A. McDonald of Telkwa and Robert Tomlin of Kispiox. These are the lay delegates in addition to the clergy of the district. Dr. Wrench presided.

#### GERMANY TO ACCEPT PROPOSAL

BERLIN, May 10.—(Noon)—The Reichstag has a safe majority in favor of accepting the demands of the allies. BERLIN, May 10.—(a. m.)—The majority of the Socialists and members of the clerical party voted for acceptance of the Allies ultimatum by Germany. The people's party rejected the proposal to acquiesce in the ultimatum. The democrats are still in session.

#### SOLDIERS MAY WEAR UNIFORMS THURSDAY AT SHIP LAUNCHING

Capt. Johnson this morning received a telegram from Brig. Gen. Ross, commanding Military District 11, granting permission for all ex-members of the 16th Battalion to wear their uniforms at the launching of the "Canadian Scottish" on Thursday afternoon. Also the local militia officers of the Northern B. C. Regiment have been granted similar permission. These under command of Major Gibson in the absence of Colonel McMullin. It is expected that all ex-soldiers will turn out in uniform for the occasion, which is a very important one, and especially so in view of the vessel being named after a battalion which distinguished itself so greatly in the war.

#### LETOURNEAU BUILDS STORE BUILDING ON FULTON STREET LOTS

This morning a building permit was issued to H. Letourneau for the erection of a two storey frame building with concrete basement on Fulton Street between Sixth and Seventh Avenues at a value of \$8,000. The building will be used as a store or shop and upstairs will be apartments.

#### BUILDING INSPECTOR GIVES LARGE PERMIT

Biggest Ever Issued is That for Provincial Government Buildings. The largest building permit ever issued in this city was granted yesterday by Building Inspector Harry L. Landry for the provincial government administration and court buildings to the contractors, Albert, McGaffery, McDougall & McNeill. The cost submitted in the permit is \$440,000.

#### DYNAMITER NOW OUT SAN QUENTIN PRISON

John McNamara Released This Morning, After 11 Years—Brother May be Paroled. SAN QUENTIN, Cal., May 10.—John McNamara, convicted of felony in connection with the dynamiting of the Los Angeles Times in October, 1910, checked out of the San Quentin prison for the last time this morning. Originally sentenced to a fifteen-year term, the prison directors ordered McNamara to be released after serving eleven years. McNamara's brother, James, was sentenced to life imprisonment for his connection with the case. It is possible that he may be paroled.

#### TWO KILLED AND ONE WOUNDED IN SCRAP WITH POLICE

JAMESTOWN, N. D., May 10.—Two men are dead and another unconscious with a bullet through his head following a fight between two Northern Pacific Railroad detectives and three men here yesterday.

#### SHAMROCKS DECLINE LACROSSE IN WEST

MONTREAL, May 9.—The Shamrocks decline to come west to play lacrosse, stating that the series would be only for exhibition purposes and could not decide the Minto Cup holding. Miles McGinnis, formerly manager of the Granby store at Anxoy and now on the road, arrived in the city from the smelter town this morning.

#### CIGARETTE DROPPED IN WRONG POCKET RESULTS IN CHAOS

Lad Blown to Pieces When Dynamite Caps Ignite—Companions Injured. PORTSMOUTH, Eng. May 10.—When Carl Newman, fifteen years of age, yesterday attempted to toss a lighted cigarette away it lodged in his pocket where were a number of dynamite caps. He never knew the result for the caps exploded and the lad was blown to pieces and six companions were more or less seriously injured.

#### ROCK FOR RIPRAP

Beneath New Dock Being Protected by Rock Covering. As soon as this is completed, permanent double track will be laid along the front of the dock and the proposed superstructure and the floor of the dock will be put on. This work will be completed until about middle of June, some delays having occurred in connection with the rock work which have made impossible the completion of the end of this month.

#### NEW PREMIER FOR GERMANY IS DR. WEIRTH

#### FRENCH FIRED ON GERMANS

Burgomaster of Opheln Urged People Not to Give Vent to Feelings. OPHELN, May 10.—French soldiers fired on the Germans threatening the Polish prisoners. The Burgomaster proclaimed faith in the Allied occupation, urging the population to refrain from giving vent to their feelings.

Group System In Politics.

Manitoba has been experimenting with the group system of politics. She has had a Government without a majority in the Legislature. In spite of the fact that only a minority were elected to support the Premier, members of the other groups have hesitated to defeat the Government and precipitate a crisis in provincial politics.

Under the British form of parliamentary government, the executive holds office until it loses the confidence of parliament as expressed in a vote. Directly a majority of the members vote against the Government, that Government resigns or is dismissed and another takes its place.

On Thursday next the first Prince Rupert built ship will glide into the water after being properly baptised by Mrs. G. W. Peck, wife of the member for the district. This will be a great event locally. It places Prince Rupert on the map as a place where ships can be built just as well as at any other place.

The range of the tide may be computed as 5 per cent greater at Prince Rupert than at Port Simpson both at springs and neaps. Therefore the rise in the Prince Rupert harbor is slightly greater than Port Simpson.

The height is in feet and tenths of feet above the average level of lower low water.
